1 AN ACT
 2 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF AGRICULTURE FOR FISCAL
 3 YEAR 2019; APPROPRIATING MONEYS TO THE DEPARTMENT OF AGRICULTURE FOR
 4 FISCAL YEAR 2019; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVA-
 5 LENT POSITIONS; AND PROVIDING LEGISLATIVE INTENT REGARDING THE WATER-
 6 CRAFT INSPECTION PROGRAM.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Department of Agricul-
 9 ture the following amounts to be expended according to the designated pro-
 10 grams and expense classes from the listed funds for the period July 1, 2018,

22 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
23 Idaho Code, the Department of Agriculture is authorized no more than two hun-
24 dred seventeen (217.00) full-time equivalent positions at any point during
25 the period July 1, 2018, through June 30, 2019, unless specifically autho-
26 rized by the Governor. The Joint Finance-Appropriations Committee will be
27 notified promptly of any increased positions so authorized.

28 SECTION 3. WATERCRAFT INSPECTION PROGRAM. It is the intent of the Leg-
29 islature that the Idaho State Department of Agriculture (ISDA) shall max-
30 imize the use of the appropriation provided for the Watercraft Inspection
31 Program to minimize the chances of spreading zebra mussels, quagga mussels,
32 and other aquatic invasive species into Idaho waters. The department is en-
33 couraged to use roving inspection stations when appropriate and for expanded
34 hours of coverage during holidays when boat transport traffic is likely to
35 increase. It is also encouraged to use extra staffing on busy holiday week-
36 ends. The department shall gather data regarding the number of watercraft
37 that are bypassing the stations and nighttime transport of watercraft across
38 Idaho's borders. Furthermore, it is the intent of the Legislature that ISDA
39 shall seek to secure federal funding to further enhance invasive species de-
40 tection and prevention efforts. The ISDA shall report back to the Joint Fi-

1 nance-Appropriations Committee, the Senate Agricultural Affairs Committee,
2 and the House Agricultural Affairs Committee, during the 2019 legislative
3 session, regarding the results of the data gathering, attainment of federal
4 funds, and an operational review of the boat stations.
