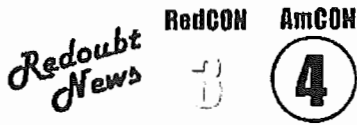

Let's start with the background info for the current allegations:



Rep. Aaron von Ehlinger

Rep. von Ehlinger is serving the people of Nez Perce and Lewis Counties. He is unmarried. A young single adult woman, [REDACTED] initiated a dinner date with Rep. von Ehlinger. The date took place

on March 9, 2021.

Her narrative begins on a false note, as she reported the crime took place on March 10th. Reading from the statement of Kim Blackburn, she is clear that it was the 11th when [REDACTED] approached her and stated clearly that it was "last night" meaning March 10th. However, Rep. von Ehlinger has receipts that show the dinner took place two nights prior, on March 9th. How did this woman lose an entire day of her life?
