

## STATEMENT OF PURPOSE

RS29896 / H0824

This is the FY 2023 original appropriation bill for the Commission for Libraries. It appropriates a total of \$11,206,700 and caps the number of authorized full-time equivalent positions at 37.50. For benefit costs, the bill increases the appropriated amount for health insurance by \$850 to \$12,500 per eligible full time FTP, includes a one-year holiday of unemployment insurance, and adjusts workers compensation amounts. The bill also provides funding for permanent employees for the equivalent of a 3% salary structure shift and provides \$1.25 per hour per eligible employee to be distributed based on merit for change in employee compensation. The bill funds six line items, which provide additional funds for Broadband Reimbursements, Project Coordinator, Local Library Grants, Digital Training and Programming, Technology Projects, and Digital Access.
