STATUTORY AUTHORITY

Idaho Constitution Article IX, Section 2: The general supervision of the state educational institutions . . . of the state of Idaho, shall be vested in a state board of education . . .

Idaho Code 33-3001: There is hereby established . . . an institution of higher education to be designated and known as the Idaho State University, consisting of such colleges, schools or departments as may from time to time be authorized by the state board of education.

Idaho Code 33-3002: Idaho State University shall be a comprehensive institution of higher education giving instruction in undergraduate, professional and graduate education, as approved by the board . . .

Idaho Code 33-3003: Idaho State University is hereby declared to be a body politic and corporate . . . the general supervision, government and control of the Idaho State University is vested in the state board of education

Idaho Code 33-3006: Idaho State University shall have the following powers: To adopt rules and regulations for its own government . . . To prescribe the courses and programs of study . . . To have at all times, general supervision and control of all property, real and personal, appertaining to the university . . .

PHYSICIAN ASSISTANT PROGRAM EXPANSION | \$7 MILLION

Idaho State University is the only Idaho institution with the degree programs needed to meet Idaho's healthcare demand. To continue training healthcare professionals, facilities at ISU that support the PA program need to be updated and expanded. Idaho State is considering remodeling current space or pursuing new construction in coordination with the Family Medical Residency expansion that was funded by the legislature last year. This investment would strategically grow enrollment in a high-demand program that prepares physician assistants for the health of Idaho's future.



MERIDIAN HEALTH SCIENCE CENTER PROPERTY DEVELOPMENT | \$6 MILLION

Idaho State University is Idaho's leader in health science education and the primary supplier of a ready workforce for the most critical healthcare disciplines, including: registered nurses, physician assistants, nurse practitioners, and physical, occupational, and speech therapists. To prepare graduates to meet the demands of Idaho's current healthcare environment, ISU needs to expand infrastructure for the health science programs at the ISU Meridian Health Sciences Center. Improvements will create an immersive living-learning environment that provides research and academic space, addresses regional housing shortages, and enhances campus-life facilities and amenities.



NUCLEAR FACILITY RESEARCH LAB | \$3 MILLION

Substantial growth is anticipated across the state and throughout the nation in the engineering and science fields. The US Department of Labor Statistics predict the vast majority of engineering and technology-based disciplines are experiencing positive growth over the next 10 years. This translates to an average percentage growth of 5.1% or 117,000 positions each year. Additionally, INL has a projected growth of approximately 2,900 positions over the next five years. The Idaho Colleges and Universities are well positioned to provide credentialed students to help meet these statewide and national workforce needs, as well as provide the faculty expertise to build on INL research and development objectives.
