SENATE BILL NO. 1383

BY JUDICIARY AND RULES COMMITTEE

AN ACT

1 RELATING TO THE CIVIL RIGHTS OF PERSONS CONVICTED OF CRIME; AMENDING SECTION  
2 18-310, IDAHO CODE, TO PROVIDE THAT THE RIGHT TO SHIP, TRANSPORT, POS-  
3 SESS OR RECEIVE A FIREARM SHALL NOT BE RESTORED FOLLOWING FELONY CONVIC-  
4 TIONS FOR CERTAIN CRIMES.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section 18-310, Idaho Code, be, and the same is hereby  
8 amended to read as follows:

9 18-310. IMPRISONMENT -- EFFECT ON CIVIL RIGHTS AND OFFICES. (1) A  
10 sentence of custody to the Idaho state board of correction suspends all the  
11 civil rights of the person so sentenced including the right to refuse treat-  
12 ment authorized by the sentencing court, and forfeits all public offices and  
13 all private trusts, authority or power during such imprisonment: provided  
14 that any such person may bring an action for damages or other relief in the  
15 courts of this state or have an action brought against such person; and pro-  
16 vided further that any such person may lawfully exercise all civil rights  
17 that are not political during any period of parole or probation, except the  
18 right to ship, transport, possess or receive a firearm, and the right to  
19 refuse treatment authorized by the sentencing court.

20 (2) Upon final discharge, a person convicted of any Idaho felony shall  
21 be restored the full rights of citizenship, except that for persons con-  
22 victed of treason or those offenses enumerated in paragraphs (a) through  
23 (jjnn) of this subsection the right to ship, transport, possess or receive a  
24 firearm shall not be restored. As used in this subsection, "final discharge"  
25 means satisfactory completion of imprisonment, probation and parole as the  
26 case may be.

30 (jj) terrorism (18-8103, 18-8106, Idaho Code);  
31 (kk) human trafficking (18-8602, Idaho Code);  
32 (ll) hijacking (18-7501, Idaho Code);  
33 (mm) supplying firearms to a criminal gang (18-8505, Idaho Code);  
34 (nn) attempt (18-306, Idaho Code), conspiracy (18-1701, Idaho Code),  
35 or solicitation (18-2001, Idaho Code), to commit any of the crimes de-  
36 scribed in paragraphs (a) through (~~jj~~mm) of this subsection.  
37 (~~kkoo~~) The provisions of this subsection shall apply only to those per-  
38 sons convicted of the enumerated felonies in paragraphs (a) through  
39 (~~jjnn~~) of this subsection on or after July 1, 1991, except that per-  
40 sons convicted of the felonies enumerated in paragraphs (s) and (t) of  
41 this subsection, for any degree of murder or voluntary manslaughter,  
42 shall not be restored the right to ship, transport, possess or receive a  
43 firearm regardless of the date of their conviction if the conviction was  
44 the result of an offense committed by use of a firearm.  
45 (3) A person not restored to the civil right to ship, transport, pos-  
46 sess or receive a firearm may make application to the commission of pardons  
47 and parole to restore the civil right to ship, transport, possess or receive  
48 a firearm. The commission shall not accept any such application until five  
49 (5) years after the date of final discharge. The commission shall conduct  
50 the proceeding upon such application pursuant to rules adopted in accordance

1 with the law. The commission shall not restore the right to ship, transport,  
2 possess or receive a firearm to any person convicted of murder in the first  
3 degree (18-4003, Idaho Code), murder in the second degree (18-4003, Idaho  
4 Code), or any felony enumerated in paragraphs (a) through (~~jjnn~~) of subsec-  
5 tion (2) of this section, upon which the sentence was enhanced for the use of  
6 a firearm during the commission of said felony.

7 (4) Persons convicted of felonies in other states or jurisdictions  
8 shall be allowed to register and vote in Idaho upon final discharge which  
9 means satisfactory completion of imprisonment, probation and parole as the  
10 case may be. These individuals shall not have the right restored to ship,  
11 transport, possess or receive a firearm, in the same manner as an Idaho felon  
12 as provided in subsection (2) of this section.
