1 AN ACT
 2 RELATING TO THE APPROPRIATION TO THE INDUSTRIAL COMMISSION FOR FISCAL YEAR
 3 2019; APPROPRIATING MONEYS TO THE INDUSTRIAL COMMISSION FOR FISCAL
 4 YEAR 2019; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT
 5 POSITIONS; AND AMENDING SECTION 72-503, IDAHO CODE, TO INCREASE THE
 6 SALARIES OF THE INDUSTRIAL COMMISSIONERS.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Industrial Commission
 9 the following amounts to be expended according to the designated programs
 10 and expense classes from the listed funds for the period July 1, 2018,
 11 through June 30, 2019:

13 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
14 Idaho Code, the Industrial Commission is authorized no more than one hundred
15 thirty-eight and twenty-five hundredths (138.25) full-time equivalent po-
16 sitions at any point during the period July 1, 2018, through June 30, 2019,
17 unless specifically authorized by the Governor. The Joint Finance-Appro-
18 priations Committee will be notified promptly of any increased positions so
19 authorized.

20 SECTION 3. That Section 72-503, Idaho Code, be, and the same is hereby
21 amended to read as follows:

22 72-503. SALARY. Commencing July 1, 2017~~8~~, the annual salary of each
23 member of the industrial commission shall be one hundred four thousand ~~nine~~
24 ~~hundred ninety twenty~~ dollars (\$~~100,990~~104,020). Industrial commissioner
25 salaries shall be paid from sources set by the legislature. Each member of
26 the industrial commission shall devote full time to the performance of his
27 duties.
