SENATE BILL NO. 1366

AN ACT

RELATING TO THE APPROPRIATION TO THE STATE BOARD OF EDUCATION AND THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO FOR HEALTH EDUCATION PROGRAMS FOR FISCAL YEAR 2019; APPROPRIATING MONEYS TO THE STATE BOARD OF EDUCATION AND THE BOARD OF REGENTS OF THE UNIVERSITY OF IDAHO FOR HEALTH EDUCATION PROGRAMS FOR FISCAL YEAR 2019; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; EXEMPTING THE APPROPRIATION FROM OBJECT TRANSFER LIMITATIONS; AND PROVIDING NON-GENERAL FUND REAPPROPRIATION.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the State Board of Education and the Board of Regents of the University of Idaho for Health Education Programs the following amounts to be expended according to the designated programs and expense classes from the listed funds for the period July 1, 2018, through June 30, 2019:

1 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
 2 Idaho Code, each of the programs in the State Board of Education and the
 3 Board of Regents of the University of Idaho for Health Education Programs
 4 specified in this section is authorized no more than the number of full-time
 5 equivalent positions shown at any point during the period July 1, 2018,
 6 through June 30, 2019, unless specifically authorized by the Governor. The
 7 Joint Finance-Appropriations Committee will be notified promptly of any
 8 increased positions so authorized.

18 SECTION 3. EXEMPTIONS FROM OBJECT TRANSFER LIMITATIONS. For fiscal
 19 year 2019, the State Board of Education and the Board of Regents of the Uni-
 20 versity of Idaho for Health Education Programs are hereby exempted from the
 21 provisions of Section 67-3511(1) and (3), Idaho Code, allowing unlimited
 22 transfers between object codes for dedicated fund moneys appropriated for
 23 the period July 1, 2018, through June 30, 2019. Legislative appropriations
 24 shall not be transferred from one fund to another fund unless expressly ap-
 25 proved by the Legislature.

26 SECTION 4. NON-GENERAL FUND REAPPROPRIATION AUTHORITY. There is hereby
 27 reappropriated to the State Board of Education and the Board of Regents of
 28 the University of Idaho for Health Education Programs any unexpended and un-
 29 encumbered balances of moneys categorized as dedicated funds as appropri-
 30 ated or reappropriated for fiscal year 2018 to be used for nonrecurring ex-
 31 penditures for the period July 1, 2018, through June 30, 2019.
