HOUSE BILL NO. 23

BY TRANSPORTATION AND DEFENSE COMMITTEE

AN ACT

RELATING TO THE MILITARY; AMENDING SECTION 46-1102, IDAHO CODE, TO REVISE PROVISIONS REGARDING THE MODEL STATE CODE OF MILITARY JUSTICE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 46-1102, Idaho Code, be, and the same is hereby amended to read as follows:

46-1102. MODEL STATE CODE OF MILITARY JUSTICE. The "Model State Code of Military Justice" is hereby enacted into law and entered into by this state with any other states legally joining therein in the form substantially as follows:

MODEL STATE CODE OF MILITARY JUSTICE

PART I. GENERAL PROVISIONS

ARTICLE 1. DEFINITIONS -- GENDER NEUTRALITY

(a) In this act, unless the context otherwise requires:

~~(1) The term "accuser" means a person who signs and swears to charges, any person who directs that charges nominally be signed and sworn to by another, and any other person who has an interest other than an official interest in the prosecution of the accused;~~

~~(2) The term "cadet," "candidate," or "midshipman" means a person who is enrolled in or attending the United States military academy, the United States air force academy, the United States coast guard academy, officer candidate school, a state military academy, a regional training institute, or any other formal education program for the purpose of becoming a commissioned officer in the state military forces;~~

~~(3) The term "classified information" means:~~

~~(A) Any information or material that has been determined by an official of the United States or any state pursuant to law, an executive order, or regulation to require protection against unauthorized disclosure for reasons of national or state security; and~~

~~(B) Any restricted data, as defined in section 11(y) of the atomic energy act of 1954, 42 U.S.C. section 2014(y);~~

~~(4) The term "code" means this act;~~

~~(5) The term "commanding officer" includes only commissioned officers of the state military forces and shall include officers in charge only when administering nonjudicial punishment under article 15 of this code. The term "commander" has the same meaning as "commanding officer" unless the context otherwise requires;~~

1 ~~(6) The term "convening authority" includes, in addition to the person~~
 2 ~~who convened the court, a commissioned officer commanding for the time~~
 3 ~~being or a successor in command to the convening authority;~~

4 ~~(7) The term "day" means calendar day and is not synonymous with the~~
 5 ~~term "unit training assembly." Any punishment authorized by this arti-~~
 6 ~~cle which is measured in terms of days shall, when served in a status~~

 10 ~~type of duty not in federal service and not full-time duty in the active~~

13 ~~(9) The term "enlisted member" means a person in an enlisted grade;~~

14 ~~(10) The term "judge advocate" means a commissioned officer of the or-~~
 15 ~~ganized state military forces who is a member in good standing of the bar~~
 16 ~~of the highest court of a state and is:~~

17 (A) Certified or designated as a judge advocate in the judge ad-
 18 vocate general's corps of the army, air force, navy, or the marine
 19 corps or designated as a law specialist as an officer of the coast
 20 guard, or a reserve component of one ~~(1)~~ of these; or

21 (B) Certified as ~~an~~ a nonfederally recognized judge advocate, un-
 22 der regulations promulgated pursuant to this provision, by the se-
 23 nior judge advocate of the commander of the force in the state mil-
 24 itary forces of which the accused is a member, as competent to per-
 25 form such military justice duties required by this code. If there
 26 is no such judge advocate available, then such certification may
 27 be made by such senior judge advocate of the commander of another
 28 force in the state military forces, as the convening authority di-

 31 ~~may..." means that no person is required, authorized or permitted to do~~

35 ~~(13) The term "military judge" means an official of a general or special~~
 36 ~~court-martial detailed in accordance with article 26 of this code;~~

17 (16) "Classified information" means:

18 (A) Any information or material that has been determined by an of-
 19 ficial of the United States pursuant to law, an executive order, or
 20 regulation to require protection against unauthorized disclosure
 21 for reasons of national security; and

22 (B) Any restricted data, as defined in section 11(y) of the atomic
 23 energy act of 1954, 42 U.S.C. 2014(y);

24 (17) "National security" means the national defense and foreign rela-
 25 tions of the United States;

26 (18) "Military offenses" means those offenses prescribed under arti-
 27 cles 77 through 117, 123, 124a, 124b, and 131b through 134.

28 (b) The use of the masculine gender throughout this code shall also in-
 29 clude the feminine gender.

30 ARTICLE 2. PERSONS SUBJECT TO THIS CODE -- JURISDICTION

31 (a) This code applies to all members of the state military forces when
 32 serving in a title 32 status or state active duty status as defined in arti-
 33 cle 1(a) (235) of this code. This code does not apply to members serving in a
 34 title 10 status or members of the unorganized militia as defined in section
 35 46-102, Idaho Code.

36 (b) Subject matter jurisdiction is established if a nexus exists be-
 37 tween an offense, either military or nonmilitary, and the state military
 38 force, regardless of duty status. Courts-martial convened by the governor
 39 or his designated representative have primary jurisdiction of military of-
 40 fenses as defined in article 1(a) (148) of this code. A proper civilian court
 41 has primary jurisdiction of a nonmilitary offense when an act or omission
 42 violates both this code and local criminal law, foreign or domestic. In such
 43 a case, a court-martial may be initiated only after the civilian authority
 44 has declined to prosecute or dismissed the charge, provided jeopardy has not
 45 attached. Jurisdiction over attempted crimes, conspiracy crimes, sollicita-
 46 tion, and accessory crimes must be determined by the underlying offense.

ARTICLE 3. JURISDICTION TO TRY CERTAIN PERSONNEL

(a) ~~Each person discharged from the state military forces who is later charged with having fraudulently obtained a discharge is, subject to article 43 of this code, subject to trial by court-martial on that charge and is, after apprehension, subject to this code while in custody under the direction of the state military forces for that trial. Upon conviction of that charge that person is subject to trial by court-martial for all offenses under this code committed before the fraudulent discharge~~ Subject to article 43, a person who is in a status in which the person is subject to this chapter and who committed an offense against this chapter while formerly in a status in which the person was subject to this chapter is not relieved from amenability to the jurisdiction of this chapter for that offense by reason of a termination of that person's former status.

(b) ~~No person who has deserted from the state military forces may be relieved from amenability to the jurisdiction of this code by virtue of a separation from any later period of service~~ Each person discharged from the state military forces who is later charged with having fraudulently obtained his discharge is, subject to article 43, subject to trial by court-martial on that charge and is, after apprehension, subject to this chapter while in the custody of the state military forces for that trial. Upon conviction of that charge, he is subject to trial by court-martial for all offenses under this chapter committed before the fraudulent discharge.

(c) No person who has deserted from the state military forces may be relieved from amenability to the jurisdiction of this chapter by virtue of a separation from any later period of service.

(d) A member of the state military forces who is subject to this chapter is not, by virtue of the termination of a period of active duty for training or inactive-duty training, relieved from amenability to the jurisdiction of this chapter for an offense against this chapter committed during such period of active duty or inactive-duty training.

ARTICLE 4. ~~RESERVED~~ DISMISSED OFFICER'S RIGHT TO TRIAL BY COURT-MARTIAL

(a) If any commissioned officer, dismissed by order of the governor or his designated representative, makes a written application for trial by court-martial, setting forth, under oath, that he has been wrongfully dismissed, the governor or his designated representative, as soon as practicable, shall convene a general court-martial to try that officer on the charges on which he was dismissed. A court-martial so convened has jurisdiction to try the dismissed officer on those charges, and he shall be considered to have waived the right to plead any statute of limitations applicable to any offense with which he is charged. The court-martial may, as part of its sentence, adjudge the affirmance of the dismissal, but if the court-martial acquits the accused or if the sentence adjudged, as finally approved or affirmed, the adjutant general shall substitute for the dismissal ordered by the governor or his designated representative a form of discharge authorized for administrative issue.

(b) If the governor or his designated representative fails to convene a general court-martial within six (6) months from the presentation of an ap-

1 plication for trial under this article, the adjutant general shall substi-
 2 tute for the dismissal ordered by the governor or his designated representa-
 3 tive a form of discharge authorized for administrative issue.

4 (c) If a discharge is substituted for a dismissal under this article,
 5 the governor or his designated representative alone may reappoint the offi-
 6 cer to such commissioned grade and with such rank as, in the opinion of the
 7 governor or his designated representative, that former officer would have
 8 attained had he not been dismissed. The reappointment of such a former offi-
 9 cer shall be without regard to the existence of a vacancy and shall affect the
 10 promotion status of other officers only insofar as the governor or his des-
 11 ignated representative may direct. All time between the dismissal and the
 12 reappointment shall be considered as actual service for all purposes, in-
 13 cluding the right to pay and allowances.

14 (d) If an officer is discharged from any armed force by administrative
 15 action or is dropped from the rolls by order of the governor or his designated
 16 representative, he has no right to trial under this article.

17 ARTICLE 5. TERRITORIAL APPLICABILITY OF THE CODE

18 (a) This code has applicability at all times and in all places subject
 19 to the personal jurisdiction as provided in article 2 of this code, or, if
 20 not in a duty status, that there is a nexus between the act or omission con-
 21 stituting the offense and the efficient functioning of the state military
 22 forces; however, this grant of military jurisdiction shall neither preclude
 23 nor limit civilian jurisdiction over an offense, which is limited only by the
 24 prohibition of double jeopardy.

25 (b) Courts-martial and courts of inquiry may be convened and held in
 26 units of the state military forces while those units are serving outside the
 27 state with the same jurisdiction and powers as to persons subject to this
 28 code as if the proceedings were held inside the state, and offenses commit-
 29 ted outside the state may be tried and punished either inside or outside the
 30 state.

31 ARTICLE 6. JUDGE ADVOCATES AND LEGAL OFFICERS

32 (a) The senior force judge advocates in each of the state's military
 33 forces or that judge advocate's delegates shall make frequent inspections in
 34 the field in supervision of the administration of military justice in that
 35 force.

36 (b) Convening authorities shall at all times communicate directly with
 37 their staff judge advocates or legal officers in matters relating to the ad-
 38 ministration of military justice. The staff judge advocate or legal officer
 39 of any command is entitled to communicate directly with the staff judge advo-
 40 cate or legal officer of a superior or subordinate command, or with the state
 41 judge advocate.

42 ~~(c) No person who has acted as member, military judge, trial counsel,~~
 43 ~~defense counsel, or investigating officer, or who has been a witness, in any~~
 44 ~~case may later act as a judge advocate to any reviewing authority upon the~~
 45 ~~same case.~~

1 (c) (1) No person who, with respect to a case, serves in a capacity spec-
 2 ified in paragraph (2) of this subsection, may later serve as a staff
 3 judge advocate or legal officer to any reviewing or convening authority
 4 upon the same case.

5 (2) The capacities referred to in paragraph (1) of this subsection are,
 6 with respect to the case involved, any of the following:

7 (A) Preliminary hearing officer, court member, military judge,
 8 military magistrate, or appellate judge; or

9 (B) Counsel who have acted in the same case or appeared in any pro-
 10 ceeding before a military judge, military magistrate, preliminary
 11 hearing officer, or appellate court.

12 ARTICLE 6a. RESERVED INVESTIGATION AND DISPOSITION OF
 13 MATTERS PERTAINING TO THE FITNESS OF MILITARY JUDGES

14 (a) The governor or his designee shall prescribe procedures for the
 15 investigation and disposition of charges, allegations, or information per-
 16 taining to the fitness of a military appellate judge, military judge, or
 17 military magistrate to perform the duties of the position involved.

18 (b) The governor or his designee shall transmit a copy of the proce-
 19 dures prescribed pursuant to this article to the appropriate committees of
 20 the Idaho senate and Idaho house of representatives.

21 ARTICLE 6b. RIGHTS OF THE VICTIM OF AN OFFENSE UNDER THIS CODE

22 (a) A victim of an offense under this code has the following rights:

23 (1) The right to be reasonably protected from the accused.

24 (2) The right to reasonable, accurate, and timely notice of any of the
 25 following:

26 (A) A public hearing concerning the continuation of confinement
 27 prior to trial of the accused;

28 (B) A preliminary hearing under article 32 relating to the of-
 29 fense;

30 (C) A court-martial relating to the offense;

31 (D) A public proceeding of the service clemency and parole board
 32 relating to the offense; and

33 (E) The release or escape of the accused, unless such notice may
 34 endanger the safety of any person.

35 (3) The right not to be excluded from any public hearing or proceed-
 36 ing described in paragraph (2) of this subsection unless the military
 37 judge or preliminary hearing officer, as applicable, after receiving
 38 clear and convincing evidence, determines that testimony by the victim
 39 of an offense under this chapter would be materially altered if the vic-
 40 tim heard other testimony at that hearing or proceeding.

41 (4) The right to be reasonably heard at any of the following:

42 (A) A public hearing concerning the continuation of confinement
 43 prior to trial of the accused;

44 (B) A sentencing hearing relating to the offense; and

45 (C) A public proceeding of the service clemency and parole board
 46 relating to the offense.

1 (5) The reasonable right to confer with the counsel representing the
2 government at any proceeding described in paragraph (2) of this subsec-
3 tion.

4 (6) The right to receive restitution as provided in law.

5 (7) The right to proceedings free from unreasonable delay.

6 (8) The right to be treated with fairness and with respect for the dig-
7 nity and privacy of the victim of an offense under this code.

8 (b) In this article, "victim of an offense under this code" means an in-
9 dividual who has suffered direct physical, emotional, or pecuniary harm as a
10 result of the commission of an offense under this code.

11 (c) In the case of a victim of an offense under this code who is under
12 eighteen (18) years of age but who is not a member of the state military
13 forces, incompetent, incapacitated, or deceased, the legal guardians of the
14 victim or the representatives of the victim's estate, family members, or any
15 other person designated as suitable by the military judge, may assume the
16 rights of the victim under this article.

17 (d) Enforcement by the Idaho supreme court:

18 (1) If the victim of an offense under this chapter believes that an ar-
19 ticle 32 preliminary hearing ruling or a court-martial ruling violates
20 the rights of the victim afforded by the provisions of this article, in-
21 cluding provisions specified in subsection (a) (4) of this article, the
22 victim may petition the Idaho supreme court for a writ of mandamus to
23 require the preliminary hearing officer or the court-martial to comply
24 with the provisions of this article.

25 (2) A petition for a writ of mandamus described in this subsection shall
26 be forwarded directly to the Idaho supreme court by such means as may
27 be prescribed by the governor or his designee. To the extent practi-
28 cable, a petition for a writ of mandamus described in this subsection
29 shall have priority over all other proceedings before the Idaho supreme
30 court.

31 (3) Paragraph (1) of this subsection applies with respect to the pro-
32 tections afforded by the following:

33 (A) The provisions of this article;

34 (B) Military rule of evidence 513, relating to the psychothera-
35 pist-patient privilege;

36 (C) Military rule of evidence 514, relating to the victim advo-
37 cate-victim privilege; and

38 (D) Military rule of evidence 615, relating to the exclusion of
39 witnesses.

40 (e) Upon notice by counsel for the government to counsel for the accused
41 of the name of an alleged victim of an offense under this article who counsel
42 for the government intends to call as a witness at a proceeding under this ar-
43 ticle, counsel for the accused shall make any request to interview the victim
44 through the special victims' counsel or other counsel for the victim, if ap-
45 plicable.

46 (f) If requested by an alleged victim who is subject to a request for in-
47 terview under subsection (e) of this article, any interview of the victim by
48 counsel for the accused shall take place only in the presence of the counsel
49 for the government, a counsel for the victim, or, if applicable, a victim ad-
50 vocate.

1 PART II. APPREHENSION AND RESTRAINT

2 ARTICLE 7. APPREHENSION

3 (a) Apprehension is the taking of a person into custody.

4 (b) Any person authorized by this code or by 10 U.S.C. chapter 47, or by
5 regulations issued under either, to apprehend persons subject to this code,
6 any marshal of a court-martial appointed pursuant to the provisions of this
7 code, and any peace officer or civil officer having authority to apprehend
8 offenders under the laws of the United States or of a state, including, but
9 not limited to, section 46-1103, Idaho Code, may do so upon probable cause
10 that an offense has been committed and that the person apprehended committed
11 it.

12 (c) Commissioned officers, warrant officers, petty officers, and non-
13 commissioned officers have authority to quell quarrels, frays, and disor-
14 ders among persons subject to this code and to apprehend persons subject to
15 this code who take part therein.

16 (d) If an offender is apprehended outside the state, the offender's re-
17 turn to the area must be in accordance with normal extradition procedures or
18 by reciprocal agreement.

19 (e) No person authorized by this article to apprehend persons subject
20 to this code or the place where such offender is confined, restrained, held,
21 or otherwise housed may require payment of any fee or charge for so receiv-
22 ing, apprehending, confining, restraining, holding, or otherwise housing a
23 person except as otherwise provided by law.

24 ARTICLE 8. ~~RESERVED~~ APPREHENSION OF DESERTERS

25 Any civil officer having authority to apprehend offenders under the laws of
26 the United States or of a state, commonwealth, possession, or the District of
27 Columbia may summarily apprehend a deserter from the state military forces
28 and deliver him into the custody of those forces.

29 ARTICLE 9. IMPOSITION OF RESTRAINT

30 (a) Arrest is the restraint of a person by an order, not imposed as a
31 punishment for an offense, directing him to remain within certain specified
32 limits. Confinement is the physical restraint of a person.

33 (b) An enlisted member may be ordered into arrest or confinement by any
34 commissioned officer by an order, oral or written, delivered in person or
35 through other persons subject to this code. A commanding officer may autho-
36 rize warrant officers, petty officers, or noncommissioned officers to order
37 enlisted members of the commanding officer's command or subject to the com-
38 manding officer's authority into arrest or confinement.

39 (c) A commissioned officer, a warrant officer, or a civilian subject to
40 this code or to trial thereunder may be ordered into arrest or confinement
41 only by a commanding officer to whose authority the person is subject, by an
42 order, oral or written, delivered in person or by another commissioned offi-
43 cer. The authority to order such persons into arrest or confinement may not
44 be delegated.

1 (d) No person may be ordered into arrest or confinement except for prob-
2 able cause.

3 (e) This article does not limit the authority of persons authorized
4 to apprehend offenders to secure the custody of an alleged offender until
5 proper authority may be notified.

6 ARTICLE 10. RESTRAINT OF PERSONS CHARGED WITH OFFENSES

7 ~~Any person subject to this code charged with an offense under this code may~~
8 ~~be ordered into arrest or confinement, as circumstances may require. When~~
9 ~~any person subject to this code is placed in arrest or confinement prior to~~
10 ~~trial, immediate steps shall be taken to inform the person of the specific~~
11 ~~wrong of which the person is accused and diligent steps shall be taken to try~~
12 ~~the person or to dismiss the charges and release the person~~

13 (a) In general.

14 (1) Subject to paragraph (2) of this subsection, any person subject to
15 this chapter who is charged with an offense under this chapter may be or-
16 dered into arrest or confinement as the circumstances require.

17 (2) When a person subject to this chapter is charged only with an of-
18 fense that is normally tried by summary court-martial, the person ordi-
19 narily shall not be ordered into confinement.

20 (b) Notification to accused and related procedures.

21 (1) When a person subject to this chapter is ordered into arrest or con-
22 finement before trial, immediate steps shall be taken:

23 (A) To inform the person of the specific offense of which the per-
24 son is accused; and

25 (B) To try the person or to dismiss the charges and release the
26 person.

27 (2) To facilitate compliance with paragraph (1) of this subsection, the
28 governor or his designee shall prescribe regulations setting forth pro-
29 cedures relating to referral for trial, including procedures for prompt
30 forwarding of the charges and specifications and, if applicable, the
31 preliminary hearing report submitted under article 32.

32 ARTICLE 11. PLACE OF CONFINEMENT -- REPORTS AND RECEIVING OF PRISONERS

33 (a) If a person subject to this code is confined before, during, or af-
34 ter trial, confinement shall be in a civilian or military confinement facil-
35 ity.

36 (b) No person authorized to receive prisoners pursuant to subsection
37 (a) of this article may refuse to receive or keep any prisoner committed to
38 the person's charge by a commissioned officer of the state military forces,
39 when the committing officer furnishes a statement, signed by such officer,
40 of the offense charged against the prisoner, unless otherwise authorized by
41 law.

42 (c) Every person authorized to receive prisoners pursuant to subsec-
43 tion (a) of this article to whose charge a prisoner is committed shall,
44 within twenty-four (24) hours after that commitment or as soon as the person
45 is relieved from guard, report to the commanding officer of the prisoner the

1 name of the prisoner, the offense charged against the prisoner, and the name
2 of the person who ordered or authorized the commitment.

3 ARTICLE 12. CONFINEMENT WITH ENEMY PRISONERS PROHIBITED

4 No member of the state military forces may be placed in military confinement
5 in immediate association with enemy prisoners or other foreign nationals not
6 members of the armed forces. This article shall not apply to confinement of
7 state military forces in civilian confinement facilities.

8 ARTICLE 13. PUNISHMENT PROHIBITED BEFORE TRIAL

9 No person, while being held for trial or awaiting a verdict, may be subjected
10 to punishment or penalty other than arrest or confinement upon the charges
11 pending against the person, nor shall the arrest or confinement imposed upon
12 such person be any more rigorous than the circumstances required to ensure
13 the person's presence.

14 ARTICLE 14. DELIVERY OF OFFENDERS TO CIVIL AUTHORITIES

15 (a) A person subject to this code accused of an offense against civil
16 authority may be delivered, upon request, to the civil authority for trial or
17 confinement.

18 (b) When delivery under this article is made to any civil authority of
19 a person undergoing sentence of a court-martial, the delivery, if followed
20 by conviction in a civil tribunal, interrupts the execution of the sentence
21 of the court-martial, and the offender after having answered to the civil au-
22 thorities for the offense shall, upon the request of competent military au-
23 thority, be returned to the place of original custody for the completion of
24 the person's sentence.

25 PART III. NONJUDICIAL PUNISHMENT

26 ARTICLE 15. COMMANDING OFFICER'S NONJUDICIAL PUNISHMENT

27 (a) Under such regulations as prescribed, any commanding officer (and
28 for purposes of this article, officers-in-charge) may impose disciplinary
29 punishments for minor offenses without the intervention of a court-martial
30 pursuant to this article. The governor, the adjutant general, or an officer
31 of a general or flag rank in command may delegate the powers under this arti-
32 cle to a principal assistant who is a member of the state military forces.

33 (b) Any commanding officer may impose upon enlisted members of the of-
34 ficer's command:

- 35 (1) An admonition;
36 (2) A reprimand;
37 (3) The withholding of privileges for not more than six (6) months;
38 (4) The forfeiture of pay of not more than seven (7) days' pay;
39 (5) A fine of not more than seven (7) days' pay;
40 (6) A reduction to the next inferior pay grade, if the grade from which
41 demoted is within the promotion authority of the officer imposing the

1 reduction or any officer subordinate to the one who imposes the reduc-
2 tion;

3 (7) Extra duties, including fatigue or other duties, for not more than
4 fourteen (14) days, which need not be consecutive; and

5 (8) Restriction to certain specified limits, with or without suspen-
6 sion from duty, for not more than fourteen (14) days, which need not be
7 consecutive.

8 (c) Any commanding officer of the grade of major or lieutenant comman-
9 der, or above, may impose upon enlisted members of the officer's command:

10 (1) Any punishment authorized in subsection (b) (1), (2) and (3) of this
11 article;

12 (2) The forfeiture of not more than one-half (1/2) of one (1) month's
13 pay per month for two (2) months;

14 (3) A fine of not more than one (1) month's pay;

15 (4) A reduction to the lowest or any intermediate pay grade, if the
16 grade from which demoted is within the promotion authority of the of-
17 ficer imposing the reduction or any officer subordinate to the one who
18 imposes the reduction, but an enlisted member in a pay grade above E-4
19 may not be reduced more than two (2) pay grades;

20 (5) Extra duties, including fatigue or other duties, for not more than
21 forty-five (45) days, which need not be consecutive; and

22 (6) Restriction to certain specified limits, with or without suspen-
23 sion from duty, for not more than sixty (60) days, which need not be con-
24 secutive.

25 (d) The governor, the adjutant general, an officer exercising general
26 court-martial convening authority, or an officer of a general or flag rank in
27 command may impose:

28 (1) Upon officers of the officer's command:

29 (A) Any punishment authorized in subsection (c) (1), (2), (3) and
30 (6) of this article; and

31 (B) Arrest in quarters for not more than thirty (30) days, which
32 need not be consecutive.

33 (2) Upon enlisted members of the officer's command:

34 (A) Any punishment authorized in subsection (c) of this article.

35 (e) Whenever any of those punishments are combined to run consec-
36 utively, the total length of the combined punishment cannot exceed the
37 authorized duration of the longest punishment in the combination, and there
38 must be an apportionment of punishments so that no single punishment in the
39 combination exceeds its authorized length under this article.

40 (f) Except in the case of a member attached to or embarked in a vessel,
41 punishment under this article may not be imposed on any member under this ar-
42 ticle if the member has, before the imposition of such punishment, demanded
43 trial by court-martial in lieu of such punishment.

44 (g) The officer who imposes the punishment, or the successor in com-
45 mand, may, at any time, suspend, set aside, mitigate, or remit any part or
46 amount of the punishment and restore all rights, privileges, and property
47 affected. The officer also may:

48 (1) Mitigate reduction in grade to forfeiture of pay;

49 (2) Mitigate arrest in quarters to restriction; or

50 (3) Mitigate extra duties to restriction.

1 The mitigated punishment shall not be for a greater period than the punish-
 2 ment mitigated. When mitigating reduction in grade to forfeiture of pay, the
 3 amount of the forfeiture shall not be greater than the amount that could have
 4 been imposed initially under this article by the officer who imposed the pun-
 5 ishment mitigated.

6 (h) A person punished under this article who considers the punishment
 7 unjust or disproportionate to the offense may, through the proper channel,
 8 appeal to the next superior authority within fifteen (15) days after the pun-
 9 ishment is either announced or sent to the accused, as the commander may de-
 10 termine. The appeal shall be promptly forwarded and decided, but the person
 11 punished may in the meantime be required to undergo the punishment adjudged.
 12 The superior authority may exercise the same powers with respect to the pun-
 13 ishment imposed as may be exercised under subsection (g) of this article by
 14 the officer who imposed the punishment. Before acting on an appeal from a
 15 punishment, the authority that is to act on the appeal may refer the case to a
 16 judge advocate for consideration and advice.

17 (i) The imposition and enforcement of disciplinary punishment under
 18 this article for any act or omission is not a bar to trial by court-martial
 19 or a civilian court of competent jurisdiction for a serious crime or offense
 20 growing out of the same act or omission and not properly punishable under
 21 this article; but the fact that a disciplinary punishment has been enforced
 22 may be shown by the accused upon trial and, when so shown, it shall be consid-
 23 ered in determining the measure of punishment to be adjudged in the event of
 24 a finding of guilty.

25 (j) Whenever a punishment of forfeiture of pay is imposed under this ar-
 26 ticle, the forfeiture may apply to pay accruing before, on, or after the date
 27 that punishment is imposed.

28 (k) Regulations may prescribe the form of records to be kept of proceed-
 29 ings under this article and may prescribe that certain categories of those
 30 proceedings shall be in writing.

31 PART IV. COURT-MARTIAL JURISDICTION

32 ARTICLE 16. COURTS-MARTIAL CLASSIFIED

33 The three (3) kinds of courts-martial in the state military forces are:

34 (1) General courts-martial, consisting of:

35 (A) A military judge and not less than five (5) members; or

36 (B) Only a military judge, if before the court is assembled the accused,
 37 knowing the identity of the military judge and after consultation with
 38 defense counsel, requests orally on the record or in writing a court
 39 composed only of a military judge and the military judge approves;

40 (2) Special courts-martial, consisting of:

41 (A) A military judge and not less than three (3) members; or

42 (B) Only a military judge, if one ~~(1)~~ has been detailed to the court, and
 43 the accused under the same conditions as those prescribed in subsection

44 (1) (B) of this article so requests; and

45 (3) Summary courts-martial, consisting of one (1) commissioned offi-
 46 cer.

1 ARTICLE 17. JURISDICTION OF COURTS-MARTIAL IN GENERAL

2 Each component of the state military forces has court-martial jurisdiction
3 over all members of the particular component who are subject to this code.
4 Additionally, the army and air national guard state military forces have
5 court-martial jurisdiction over all members subject to this code.

6 ARTICLE 18. JURISDICTION OF GENERAL COURTS-MARTIAL

7 Subject to article 17 of this code, general courts-martial have jurisdiction
8 to try persons subject to this code for any offense made punishable by this
9 code, and may, under such limitations as the governor may prescribe, adjudge
10 any punishment not forbidden by this code.

11 ARTICLE 19. JURISDICTION OF SPECIAL COURTS-MARTIAL

12 Subject to article 17 of this code, special courts-martial have jurisdic-
13 tion to try persons subject to this code for any offense made punishable by
14 this code, and may, under such limitations as the governor may prescribe,
15 adjudge any punishment not forbidden by this code except dishonorable dis-
16 charge, dismissal, confinement for more than one (1) year, forfeiture of pay
17 exceeding two-thirds (2/3) pay per month, or forfeiture of pay for more than
18 one (1) year.

19 ARTICLE 20. JURISDICTION OF SUMMARY COURTS-MARTIAL

20 (a) Subject to article 17 of this code, summary courts-martial have
21 jurisdiction to try persons subject to this code, except officers, cadets,
22 candidates, and midshipmen, for any offense made punishable by this code
23 under such limitations as the governor may prescribe.

24 (b) No person in the rank of E-7 or above may be brought to trial before
25 a summary court-martial if that person objects thereto. If objection to
26 trial by summary court-martial is made by an accused in the rank of E-7 or
27 above, trial by special or general court-martial may be ordered, as may be
28 appropriate. Members in the rank of E-6 and below do not have the right to
29 reject trial before a summary court-martial. Summary courts-martial may,
30 under such limitations as the governor may prescribe, adjudge any punishment
31 not forbidden by this code except dismissal, dishonorable or bad-conduct
32 discharge, confinement for more than one (1) month, restriction to specified
33 limits for more than two (2) months, or forfeiture of more than two-thirds
34 (2/3) of one (1) month's pay.

35 (c) A summary court-martial is a noncriminal forum. A finding of guilty
36 at a summary court-martial does not constitute a criminal conviction.

37 ARTICLE 21. RESERVED

38 PART V. APPOINTMENT AND COMPOSITION OF COURTS-MARTIAL

39 ARTICLE 22. WHO MAY CONVENE GENERAL COURTS-MARTIAL

- 1 (a) General courts-martial may be convened by:
2 (1) The governor;
3 (2) The adjutant general;
4 (3) The commanding officer of a force of the state military forces;
5 (4) The commanding officer of a division or a separate brigade; or
6 (5) The commanding officer of a separate wing.
7 (b) If any such commanding officer is an accuser, the court shall be
8 convened by superior competent authority and may in any case be convened by
9 such superior authority if considered desirable by such authority.

10 ARTICLE 23. WHO MAY CONVENE SPECIAL COURTS-MARTIAL

- 11 (a) Special courts-martial may be convened by:
12 (1) Any person who may convene a general court-martial;
13 (2) The commanding officer of a garrison, fort, post, camp, station,
14 air national guard base, or naval base or station;
15 (3) The commanding officer of a brigade, regiment, detached battalion,
16 or corresponding unit of the army;
17 (4) The commanding officer of a wing, group, separate squadron, or cor-
18 responding unit of the air force; or
19 (5) The commanding officer or officer in charge of any other command
20 when empowered by the adjutant general.
21 (b) If any such officer is an accuser, the court shall be convened by
22 superior competent authority and may in any case be convened by such superior
23 authority if considered desirable by such authority.

24 ARTICLE 24. WHO MAY CONVENE SUMMARY COURTS-MARTIAL

- 25 (a) Summary courts-martial may be convened by:
26 (1) Any person who may convene a general or special court-martial;
27 (2) The commanding officer of a detached company or other detachment,
28 or corresponding unit of the army;
29 (3) The commanding officer of a detached squadron or other detachment,
30 or corresponding unit of the air force; or
31 (4) The commanding officer or officer in charge of any other command
32 when empowered by the adjutant general.
33 (b) When only one (1) commissioned officer is present with a command
34 or detachment, that officer shall be the summary court-martial of that com-
35 mand or detachment and shall hear and determine all summary court-martial
36 cases. Summary courts-martial may, however, be convened in any case by supe-
37 rior competent authority if considered desirable by such authority.

38 ARTICLE 25. WHO MAY SERVE ON COURTS-MARTIAL

- 39 (a) Any commissioned officer of the state military forces is eligible
40 to serve on all courts-martial for the trial of any person subject to this
41 code.
42 (b) Any warrant officer of the state military forces is eligible to
43 serve on general and special courts-martial for the trial of any person sub-
44 ject to this code, other than a commissioned officer.

1 ~~(c) Any enlisted member of the state military forces who is not a member~~
2 ~~of the same unit as the accused is eligible to serve on general and special~~
3 ~~courts-martial for the trial of any enlisted member subject to this code, but~~
4 ~~that member shall serve as a member of a court only if, before the conclu-~~
5 ~~sion of a session called by the military judge under article 39(a) of this~~
6 ~~code prior to trial or, in the absence of such a session, before the court~~
7 ~~is assembled for the trial of the accused, the accused personally has re-~~
8 ~~quested orally on the record or in writing that enlisted members serve on~~
9 ~~it. After such a request, the accused may not be tried by a general or spe-~~
10 ~~cial court-martial the membership of which does not include enlisted members~~
11 ~~in a number comprising at least one-third (1/3) of the total membership of~~
12 ~~the court, unless eligible enlisted members cannot be obtained on account~~
13 ~~of physical conditions or military exigencies. If such members cannot be~~
14 ~~obtained, the court may be assembled and the trial held without them, but~~
15 ~~the convening authority shall make a detailed written statement, to be ap-~~
16 ~~pended to the record, stating why they could not be obtained. In this arti-~~
17 ~~cle, "unit" means any regularly organized body of the state military forces~~
18 ~~not larger than a company, a squadron, a division of the naval militia, or a~~
19 ~~body corresponding to one (1) of them~~

20 (c) (1) Any enlisted member of the state military forces is eligible to
21 serve on a general or special court-martial for the trial of any other
22 enlisted member.

23 (2) Before a court-martial with a military judge and members is assem-
24 bled for trial, an enlisted member who is an accused may personally re-
25 quest, orally on the record or in writing, that:

26 (A) The membership of the court-martial be comprised entirely of
27 officers; or

28 (B) Enlisted members comprise at least one-third (1/3) of the mem-
29 bership of the court-martial, regardless of whether enlisted mem-
30 bers have been detailed to the court-martial.

31 (3) Except as provided in paragraph (4) of this subsection, after such
32 a request, the accused may not be tried by a general or special court-
33 martial if the membership of the court-martial is inconsistent with the
34 request.

35 (4) If, because of physical conditions or military exigencies, a suf-
36 ficient number of eligible officers or enlisted members, as the case may
37 be, is not available to carry out the provisions of paragraph (2) of this
38 subsection, the trial may nevertheless be held. In that event, the con-
39 vening authority shall make a detailed written statement of the reasons
40 for nonavailability. The statement shall be appended to the record.

41 ~~(d) When it can be avoided, no person subject to this code may be tried~~
42 ~~by a court-martial any member of which is junior to the accused in rank or~~
43 ~~grade.~~

44 (d) (1) The accused in a court-martial with a military judge and members
45 may, after the findings are announced and before any matter is presented
46 in the sentencing phase, request, orally on the record or in writing,
47 sentencing by members.

48 (2) The convening authority shall detail not less than the number of
49 members necessary to impanel the court-martial under article 29.

1 (e) When convening a court-martial, the convening authority shall de-
2 tail as members thereof such members of the state military forces as, in the
3 convening authority's opinion, are best qualified for the duty by reason of
4 age, education, training, experience, length of service, and judicial tem-
5 perament. No member of the state military forces is eligible to serve as a
6 member of a general or special court-martial when that member is the accuser,
7 a witness, or has acted as investigating officer or as counsel in the same
8 case.

9 (f) Before a court-martial is assembled for the trial of a case, the
10 convening authority may excuse a member of the court from participating in
11 the case. The convening authority may delegate the authority under this sub-
12 section to a judge advocate or to any other principal assistant.

13 ARTICLE 25a. RESERVED

14 ARTICLE 26. MILITARY JUDGE OF A GENERAL OR SPECIAL COURT-MARTIAL

15 (a) A military judge shall be detailed to each general and special
16 court-martial. ~~The military judge shall preside over each open session of~~
17 ~~the court-martial to which the military judge has been detailed.~~

18 (b) A military judge shall be:

19 (1) An active or retired commissioned officer of an organized state
20 military force and qualified, by reason of education, training, experi-
21 ence, and judicial temperament, for duty;

22 (2) A member in good standing of the bar of the highest court of a state
23 or a member of the bar of a federal court for at least five (5) years; and

24 (3) Certified as ~~qualified for duty as~~ a military judge by the senior
25 force judge advocate which is the same force as the accused; and

26 (4) Certified as qualified, by reason of education, training, experi-
27 ence, and judicial temperament, for duty.

28 (c) In the instance when a military judge is not a member of the bar of
29 the highest court of the state, the military judge shall be deemed admitted
30 pro hac vice, subject to filing a certificate with the senior force judge ad-
31 vocate which is the same force as the accused setting forth such qualifica-
32 tions provided in subsection (b) of this article.

33 (d) The military judge of a general or special court-martial shall be
34 designated by the senior force judge advocate which is the same force as the
35 accused, or a designee, for detail by the convening authority. Neither the
36 convening authority nor any staff member of the convening authority shall
37 prepare or review any report concerning the effectiveness, fitness, or ef-
38 ficiency of the military judge so detailed, which relates to performance of
39 duty as a military judge.

40 (e) No person is eligible to act as military judge in a case if that per-
41 son is the accuser or a witness, or has acted as ~~investigating~~ preliminary
42 hearing officer or a counsel in the same case.

43 (f) The military judge of a court-martial may not consult with the mem-
44 bers of the court except in the presence of the accused, trial counsel, and
45 defense counsel, nor vote with the members of the court.

46 (g) A military judge may be detailed under subsection (a) of this arti-
47 cle to a court-martial or a proceeding under article 30 that is convened in a

1 different armed force, when so permitted by the senior force judge advocate
 2 of the armed force of which the military judge is a member.

3 ARTICLE 26a. MILITARY MAGISTRATES

4 (a) A military magistrate will be a commissioned officer of the state
 5 military forces who:

6 (1) Is a member of the bar of a federal court or a member of the bar of the
 7 highest court of a state; and

8 (2) Is certified to be qualified, by reason of education, training, ex-
 9 perience, and judicial temperament, for duty as a military magistrate
 10 by the state judge advocate.

11 (b) In accordance with regulations promulgated by the governor or his
 12 designee, in addition to duties when designated under this code, a military
 13 magistrate may be assigned to perform other duties of a nonjudicial nature.

14 ARTICLE 27. DETAIL OF TRIAL COUNSEL AND DEFENSE COUNSEL

15 (a) General provision:

16 (1) For each general and special court-martial, the authority conven-
 17 ing the court shall detail trial counsel, defense counsel, and such as-
 18 sistants as are appropriate.

19 (2) ~~No person who has acted as investigating officer, military judge,~~
 20 ~~witness or court member in any case may act later as trial counsel, with~~
 21 ~~respect to a case, has served as a preliminary hearing officer, court~~
 22 ~~member, military judge, military magistrate, or appellate judge may~~
 23 ~~later serve as trial counsel, assistant trial counsel, or, unless ex-~~
 24 ~~pressly requested by the accused, as defense counsel or assistant or~~
 25 ~~associate defense counsel in the same case. No person who has acted for~~
 26 ~~the prosecution may act later in the same case for the defense nor may~~
 27 ~~any person who has acted for the defense act later in the same case for~~
 28 ~~the prosecution.~~

29 (b) Except as provided in subsection (c) of this article, trial coun-
 30 sel, ~~or~~ defense counsel, ~~or~~ assistant defense counsel detailed for a general
 31 or special court-martial must be:

32 (1) A judge advocate as defined in article 1(a) (103) of this code; and

33 (2) ~~In the case of trial counsel, a~~ member in good standing of the bar
 34 of the highest court of the state where the court-martial is held.

35 (c) ~~In the instance when a defense counsel is not a member of the bar of~~
 36 ~~the highest court of the state, the defense counsel shall be deemed admitted~~
 37 ~~pro hac vice, subject to filing a certificate with the military judge setting~~
 38 ~~forth the qualifications that counsel is:~~

39 ~~(1) A commissioned officer of the armed forces of the United States or a~~
 40 ~~component thereof; and~~

41 ~~(2) A member in good standing of the bar of the highest court of a state;~~
 42 ~~and~~

43 ~~(3) Certified as a judge advocate in the judge advocate general's corps~~
 44 ~~of the army, air force, navy, or the marine corps; or~~

45 ~~(4) A judge advocate as defined in article 1(a) (10) of this code~~

1 Defense counsel and assistant defense counsel detailed for a special or
 2 general court-martial shall have the qualifications set forth in subsection
 3 (b) of this article.

4 (d) Trial counsel, assistant trial counsel, defense counsel, and as-
 5 stant defense counsel detailed for a special court-martial must be deter-
 6 mined to be competent to perform such duties by the senior force judge advo-
 7 cate, under such rules as the governor or his designee may prescribe.

8 ARTICLE 28. DETAIL OR EMPLOYMENT OF REPORTERS AND INTERPRETERS

9 Under such regulations as may be prescribed, the convening authority of a
 10 general or special court-martial or court of inquiry shall detail or employ
 11 qualified court reporters, who shall record the proceedings of and testimony
 12 taken before that court and may detail or employ interpreters who shall in-
 13 terpret for the court.

14 ARTICLE 29. ~~ABSENT AND ADDITIONAL ASSEMBLY AND IMPANEL-~~
 15 ING OF MEMBERS -- DETAIL OF NEW MEMBERS AND MILITARY JUDGES

16 (a) No member of a general or special court-martial may be absent or ex-
 17 cluded after the court has been assembled for the trial of the accused unless
 18 excused as a result of a challenge, excused by the military judge for physi-
 19 cal disability or other good cause, or excused by order of the convening au-
 20 thority for good cause. The military judge shall announce the assembly of a
 21 general or special court-martial with members. After such a court-martial
 22 is assembled, no member may be absent, unless the member is excused:

23 (1) As a result of a challenge;

24 (2) Under subsection (b) (1) (B) of this article; or

25 (3) By order of the military judge or the convening authority for dis-
 26 ability or other good cause.

27 (b) Whenever a general court-martial, other than a general court-mar-
 28 tial composed of a military judge only, is reduced below five (5) members,
 29 the trial may not proceed unless the convening authority details new members
 30 sufficient in number to provide not less than the applicable minimum number
 31 of five (5) members. The trial may proceed with the new members present after
 32 the recorded evidence previously introduced before the members of the court
 33 has been read to the court in the presence of the military judge, the accused,
 34 and counsel for both sides. Impaneling.

35 (1) Under rules prescribed by the governor or his designated represen-
 36 tative, the military judge of a general or special court-martial with
 37 members shall:

38 (A) After determination of challenges, impanel the court-mar-
 39 tial; and

40 (B) Excuse the members who, having been assembled, are not impan-
 41 eled.

42 (2) In a general court-martial, the military judge shall impanel eight
 43 (8) members.

44 (3) In a special court-martial, the military judge shall impanel four
 45 (4) members.

38 (1) A preliminary hearing under this article shall be conducted by an

43 of exceptional circumstances, is not a judge advocate so certi-
44 fied.

45 (2) In the case of a hearing officer under paragraph (1) (B) of this sub-

47 available to provide legal advice to the hearing officer.

 2 ~~jurisdiction. If that is not practicable, the commanding officer shall~~
 3 ~~report in writing to that person the reasons for delay~~ The governor or his
 4 designated representative shall issue nonbinding guidance regarding fac-
 5 tors that commanders, convening authorities, staff judge advocates, and
 6 judge advocates should take into account when exercising their duties with

35 (b) Commencement of trial.

36 (1) Subject to paragraphs (2) and (3) of this subsection, no trial or
 37 other proceeding of a general court-martial or a special court-martial,
 38 including any session under article 39(a), may be held over the objec-

5 ARTICLE 36. GOVERNOR OR THE ADJUTANT GENERAL MAY PRESCRIBE RULES

6 Pretrial, trial, and ~~post-trial~~ posttrial procedures, including modes of
7 proof, for courts-martial cases arising under this code, and for courts of
8 inquiry, may be prescribed by the governor or the adjutant general by regu-
9 lations, or as otherwise provided by law, which shall apply the principles
10 of law and the rules of evidence generally recognized in military criminal
11 cases in the courts of the armed forces but which may not be contrary to or in-
12 consistent with this code.

13 ARTICLE 37. UNLAWFULLY INFLUENCING ACTION OF COURT

14 (a) No authority convening a general, special, or summary court-mar-
15 tial, nor any other commanding officer, or officer serving on the staff
16 thereof, may censure, reprimand, or admonish the court or any member, the
17 military judge, or counsel thereof, with respect to the findings or sentence
18 adjudged by the court or with respect to any other exercise of its or their
19 functions in the conduct of the proceedings. No person subject to this code
20 may attempt to coerce or, by any unauthorized means, influence the action of
21 a court-martial or court of inquiry or any member thereof, in reaching the
22 findings or sentence in any case, or the action of any convening, approving,
23 or reviewing authority with respect to their judicial acts. The foregoing
24 provisions of this subsection shall not apply with respect to: (1) general
25 instructional or informational courses in military justice if such courses
26 are designed solely for the purpose of instructing members of a command in
27 the substantive and procedural aspects of courts-martial; or (2) to state-
28 ments and instructions given in open court by the military judge, summary
29 court-martial officer, or counsel.

30 (b) In the preparation of an effectiveness, fitness, or efficiency re-
31 port, or any other report or document used in whole or in part for the purpose
32 of determining whether a member of the state military forces is qualified to
33 be advanced in grade, or in determining the assignment or transfer of a mem-
34 ber of the state military forces, or in determining whether a member of the
35 state military forces should be retained on active status, no person subject
36 to this code may, in preparing any such report: (1) consider or evaluate the
37 performance of duty of any such member as a member of a court-martial or wit-
38 ness therein; or (2) give a less favorable rating or evaluation of any coun-
39 sel of the accused because of zealous representation before a court-martial.

40 ARTICLE 38. DUTIES OF TRIAL COUNSEL AND DEFENSE COUNSEL

41 (a) The trial counsel of a general or special court-martial shall be a
42 member in good standing of the state bar and shall prosecute in the name of

1 the state and shall, under the direction of the court, prepare the record of
2 the proceedings.

3 (b) Defense counsel:

4 (1) The accused has the right to be represented in defense before a gen-
5 eral or special court-martial or at an investigation under article 32 of
6 this code as provided in this subsection.

7 (2) The accused may be represented by civilian counsel at the provision
8 and expense of the accused.

9 (3) The accused may be represented:

10 (A) By military counsel detailed under article 27 of this code; or

11 (B) By military counsel of the accused's own selection if that
12 counsel is reasonably available as determined under paragraph (7)
13 of this subsection.

14 (4) If the accused is represented by civilian counsel, military counsel
15 detailed or selected under paragraph (3) of this subsection shall act as
16 associate counsel unless excused at the request of the accused.

17 (5) Except as provided under paragraph (6) of this subsection, if the
18 accused is represented by military counsel of his own selection under
19 paragraph (3) (B) of this subsection, any military counsel detailed un-
20 der paragraph (3) (A) of this subsection shall be excused.

21 (6) The accused is not entitled to be represented by more than one mil-
22 itary counsel. However, the person authorized under regulations pre-
23 scribed under article 27 of this code to detail counsel, in that per-
24 son's sole discretion:

25 (A) May detail additional military counsel as assistant defense
26 counsel; and

27 (B) If the accused is represented by military counsel of the ac-
28 cused's own selection under paragraph (3) (B) of this subsection,
29 may approve a request from the accused that military counsel de-
30 tailed under paragraph (3) (A) of this subsection act as associate
31 defense counsel.

32 (7) The senior force judge advocate of the same force of which the ac-
33 cused is a member shall determine whether the military counsel selected
34 by an accused is reasonably available.

35 (c) In any court-martial proceeding resulting in a conviction, the de-
36 fense counsel:

37 (1) May forward for attachment to the record of proceedings a brief of
38 such matters as counsel determines should be considered in behalf of the
39 accused on review, including any objection to the contents of the record
40 which counsel considers appropriate; and

41 (2) ~~May assist the accused in the submission of any matter under article~~
42 ~~60 of this code; and~~

43 ~~(3) May take other action authorized by this code.~~

44 ARTICLE 39. SESSIONS

45 (a) At any time after the service of charges which have been referred
46 for trial to a court-martial composed of a military judge and members, the
47 military judge may, subject to article 35 of this code, call the court into
48 session without the presence of the members for the purpose of:

1 (1) Hearing and determining motions raising defenses or objections
2 which are capable of determination without trial of the issues raised by
3 a plea of not guilty;

4 (2) Hearing and ruling upon any matter which may be ruled upon by the
5 military judge under this code, whether or not the matter is appropriate
6 for later consideration or decision by the members of the court;

7 (3) Holding the arraignment and receiving the pleas of the accused; and

8 (4) Conducting a sentencing proceeding and sentencing the accused in
9 noncapital cases unless the accused requests sentencing by members un-
10 der article 25; and

11 (5) Performing any other procedural function which does not require the
12 presence of the members of the court under this code. These proceedings
13 shall be conducted in the presence of the accused, the defense counsel,
14 and the trial counsel and shall be made a part of the record. These pro-
15 ceedings may be conducted notwithstanding the number of court members
16 and without regard to article 29.

17 (b) When the members of a court-martial deliberate or vote, only the
18 members may be present. All other proceedings, including any other consul-
19 tation of the members of the court with counsel or the military judge, shall
20 be made a part of the record and shall be in the presence of the accused, the
21 defense counsel, the trial counsel, and the military judge.

22 ARTICLE 40. CONTINUANCES

23 The military judge of a court-martial or a summary court-martial may, for
24 reasonable cause grant a continuance to any party for such time and as often
25 as may appear to be just.

26 ARTICLE 41. CHALLENGES

27 (a) Challenges generally.

28 (1) The military judge and members of a general or special court-mar-
29 tial may be challenged by the accused or the trial counsel for cause
30 stated to the court. The military judge or the court shall determine
31 the relevancy and validity of challenges for cause and may not receive a
32 challenge to more than one (1) person at a time. Challenges by the trial
33 counsel shall ordinarily be presented and decided before those by the
34 accused are offered.

35 (2) If exercise of a challenge for cause reduces the court below the
36 ~~minimum~~ number of members required by article 16 of this code, all par-
37 ties shall, notwithstanding article 29 of this code, either exercise or
38 waive any challenge for cause then apparent against the remaining mem-
39 bers of the court before additional members are detailed to the court.
40 However, peremptory challenges shall not be exercised at that time.

41 (b) Preemptory challenges.

42 (1) Each accused and the trial counsel are entitled initially to one (1)
43 preemptory challenge of members of the court. The military judge may
44 not be challenged except for cause.

45 (2) If exercise of a preemptory challenge reduces the court below the
46 minimum number of members required by article 16 of this code, the par-

1 ties shall, notwithstanding article 29 of this code, either exercise
2 or waive any remaining peremptory challenge, not previously waived,
3 against the remaining members of the court before additional members
4 are detailed to the court.

5 (3) Whenever additional members are detailed to the court, and after
6 any challenges for cause against such additional members are presented
7 and decided, each accused and the trial counsel are entitled to one (1)
8 peremptory challenge against members not previously subject to peremp-
9 tory challenge.

10 ARTICLE 42. OATHS OR AFFIRMATIONS

11 (a) Before performing their respective duties, military judges, gen-
12 eral and special courts-martial members, trial counsel, defense counsel,
13 reporters, and interpreters shall take an oath or affirmation in the pres-
14 ence of the accused to perform their duties faithfully. The form of the
15 oath or affirmation, the time and place of the taking thereof, the manner
16 of recording the same, and whether the oath or affirmation shall be taken
17 for all cases in which these duties are to be performed or for a particular
18 case, shall be as prescribed in regulation or as provided by law. These reg-
19 ulations may provide that an oath or affirmation to perform faithfully the
20 duties as a military judge, trial counsel, or defense counsel may be taken
21 at any time by any judge advocate or other person certified or designated to
22 be qualified or competent for the duty, and if such an oath or affirmation
23 is taken, it need not again be taken at the time the judge advocate or other
24 person is detailed to that duty.

25 (b) Each witness before a court-martial shall be examined under oath or
26 affirmation.

27 ARTICLE 43. STATUTE OF LIMITATIONS

28 (a) Except as otherwise provided in this article, a person charged with
29 any offense is not liable to be tried by court-martial or punished under ar-
30 ticle 15 of this code if the offense was committed more than three (3) years
31 before the receipt of sworn charges and specifications by an officer exer-
32 cising court-martial jurisdiction over the command or before the imposition
33 of punishment under article 15 of this code.

34 (b) Periods in which the accused is absent without authority or flee-
35 ing from justice shall be excluded in computing the period of limitation pre-
36 scribed in this article.

37 (c) Periods in which the accused was absent from territory in which the
38 state has the authority to apprehend him, or in the custody of civil authori-
39 ties, or in the hands of the enemy, shall be excluded in computing the period
40 of limitation prescribed in this article.

41 (d) When the United States is at war, the running of any statute of limi-
42 tations applicable to any offense under this code:

43 (1) Involving fraud or attempted fraud against the United States, any
44 state, or any agency of either in any manner, whether by conspiracy or
45 not;

1 (2) Committed in connection with the acquisition, care, handling, cus-
 2 tody, control, or disposition of any real or personal property of the
 3 United States or any state; or

4 (3) Committed in connection with the negotiation, procurement, award,
 5 performance, payment, interim financing, cancellation, or other termi-
 6 nation or settlement, of any contract, subcontract, or purchase order
 7 which is connected with or related to the prosecution of the war, or with
 8 any disposition of termination inventory by any war contractor or gov-
 9 ernment agency;

10 is suspended until two (2) years after the termination of hostilities as pro-
 11 claimed by the president or by a joint resolution of congress.

12 (e) Exception.

13 (1) If charges or specifications are dismissed as defective or insuffi-
 14 cient for any cause and the period prescribed by the applicable statute
 15 of limitations:

16 (A) Has expired; or will be met.

17 (B) Will expire within one hundred eighty (180) days after the
 18 date of dismissal of the charges and specifications, trial and
 19 punishment under new charges and specifications are not barred by
 20 the statute of limitations if the conditions specified in para-
 21 graph (2) of this subsection are met.

22 (2) The conditions referred to in paragraph (1) of this subsection are
 23 that the new charges and specifications must:

24 (A) Be received by an officer exercising summary court-martial
 25 jurisdiction over the command within one hundred eighty (180) days
 26 after the dismissal of the charges or specifications; and

27 (B) Allege the same acts or omissions that were alleged in the dis-
 28 missed charges or specifications (or allege acts or omissions that
 29 were included in the dismissed charges or specifications).

30 (f) Fraudulent enlistment or appointment. A person charged with fraud-
 31 ulent enlistment or fraudulent appointment under article 104a(1) may be
 32 tried by court-martial if the sworn charges and specifications are received
 33 by an officer exercising summary court-martial jurisdiction with respect to
 34 that person, as follows:

35 (1) In the case of an enlisted member, during the period of the enlist-
 36 ment or five (5) years, whichever provides a longer period.

37 (2) In the case of an officer, during the period of the appointment or
 38 five (5) years, whichever provides a longer period.

39 (g) DNA evidence. If DNA testing implicates an identified person in
 40 the commission of an offense punishable by confinement for more than one (1)
 41 year, no statute of limitations that would otherwise preclude prosecution of
 42 the offense shall preclude such prosecution until a period of time following
 43 the implication of the person by DNA testing has elapsed that is equal to the
 44 otherwise applicable limitation period.

45 ARTICLE 44. FORMER JEOPARDY

46 (a) No person may, without his consent, be tried a second time for the
 47 same offense.

1 (b) No proceeding in which an accused has been found guilty by a court-
 2 martial upon any charge or specification is a trial in the sense of this arti-
 3 cle until the finding of guilty has become final after review of the case has
 4 been fully completed.

5 ~~(c) A proceeding which, after the introduction of evidence but before a~~
 6 ~~finding, is dismissed or terminated by the convening authority or on motion~~
 7 ~~of the prosecution for failure of available evidence or witnesses without~~
 8 ~~any fault of the accused is a trial in the sense of this article.~~

9 (c) (1) A court-martial with a military judge alone is a trial in the
 10 sense of this article if, without fault of the accused after introduc-
 11 tion of evidence and before announcement of findings under article 53,
 12 the case is dismissed or terminated by the convening authority or on mo-
 13 tion of the prosecution for failure of available evidence or witnesses.

14 (2) A court-martial with a military judge and members is a trial in the
 15 sense of this article if, without fault of the accused after the mem-
 16 bers, having taken an oath as members under article 42 and after com-
 17 pletion of challenges under article 41, are impaneled, and before an-
 18 ouncement of findings under article 53, the case is dismissed or ter-
 19 minated by the convening authority or on motion of the prosecution for
 20 failure of available evidence or witnesses.

36 (c) Harmless error. A variance from the requirements of this article is
 37 harmless error if the variance does not materially prejudice the substantial
 38 rights of the accused.

39 ARTICLE 46. OPPORTUNITY TO OBTAIN WIT-
 40 NESSES AND OTHER EVIDENCE IN TRIALS BY COURT

41 (a) In a case referred for trial by court-martial, ¶the trial counsel,
 42 and the defense counsel, and the court-martial shall have equal opportunity
 43 to obtain witnesses and other evidence as prescribed by regulations and pro-
 44 vided by law. Process issued in court-martial cases to compel witnesses to
 45 appear and testify and to compel the production of other evidence shall ap-
 46 ply the principles of law and the rules of courts-martial generally recog-

1 nized in military criminal cases in the courts of the armed forces of the
 2 United States, but which may not be contrary to or inconsistent with this
 3 code. Process shall run to any part of the United States, or the territo-
 4 ries, commonwealths, and possessions, and may be executed by civil officers
 5 as prescribed by the laws of the place where the witness or evidence is lo-

7 (b) Subpoena and other process generally. Any subpoena or other
 8 process issued under this article:

1 ARTICLE 50a. DEFENSE OF LACK OF MENTAL RESPONSIBILITY

2 (a) It is an affirmative defense in a trial by court-martial that, at
3 the time of the commission of the acts constituting the offense, the accused,
4 as a result of a severe mental disease or defect, was unable to appreciate the
5 nature and quality or the wrongfulness of the acts. Mental disease or defect
6 does not otherwise constitute a defense.

7 (b) The accused has the burden of proving the defense of lack of mental
8 responsibility by clear and convincing evidence.

9 (c) Whenever lack of mental responsibility of the accused with respect
10 to an offense is properly at issue, the military judge shall instruct the

15 (3) Not guilty only by reason of lack of mental responsibility.

16 (d) Subsection (c) of this article does not apply to a court-martial
17 composed of a military judge only. In the case of a court-martial composed
18 of a military judge only or a summary court-martial officer, whenever lack of
19 mental responsibility of the accused with respect to an offense is properly
20 at issue, the military judge or summary court-martial officer shall find the
21 accused:

 2 sideration of a sentence, with a view toward decreasing the sentence,

30 (1) At any time before the announcement of findings under article 53,
 31 the convening authority and the accused may enter into a plea agree-
 32 ment with respect to such matters as the manner in which the convening
 33 authority will dispose of one (1) or more charges and specifications
 34 and limitations on the sentence that may be adjudged for one (1) or more

 44 provision for a sentence that is less than the mandatory minimum sen-

46 (4) Is prohibited by law; or

1 mony shall be prepared in any case of a sentence of death, dismissal,
 2 discharge, confinement for more than six (6) months, or forfeiture of
 3 pay for more than six (6) months.

4 (f) A copy of the record of the proceedings of each general and special
 5 court-martial shall be given to the accused as soon as it is certified.

6 (g) In the case of a general or special court-martial, upon request, a
 7 copy of all prepared records of the proceedings of the court-martial shall
 8 be given to the victim of the offense if the victim testified during the pro-
 9 ceedings. The records of the proceedings shall be provided without charge
 10 and as soon as the records are certified. The victim shall be notified of the
 11 opportunity to receive the records of the proceedings.

12 PART VIII. SENTENCES

13 ARTICLE 55. CRUEL AND UNUSUAL PUNISHMENTS PROHIBITED

14 Punishment by flogging, or by branding, marking, or tattooing on the body, or
 15 any other cruel or unusual punishment may not be adjudged by a court-martial
 16 or inflicted upon any person subject to this code. The use of irons, single
 17 or double, except for the purpose of safe custody, is prohibited.

18 ARTICLE 56. ~~MAXIMUM LIMITS~~ SENTENCING

19 (a) The punishment which a court-martial may direct for an offense may
 20 not exceed such limits as prescribed by this code, but in no instance may a
 21 sentence exceed more than ten (10) years for a military offense, nor shall a
 22 sentence of death be adjudged. A conviction by general court-martial of any
 23 military offense for which an accused may receive a sentence of confinement
 24 for more than one (1) year is a felony offense. Except for convictions by a
 25 summary court-martial, all other military offenses are misdemeanors. Any
 26 conviction by a summary court-martial is not a criminal conviction.

27 (b) The limits of punishment for violations of the punitive articles
 28 prescribed herein shall be the lesser of the sentences prescribed by the man-
 29 ual for courts-martial of the United States currently in effect ~~on January 1,~~
 30 ~~2004,~~ and the state manual for courts-martial, but in no instance shall any
 31 punishment exceed that authorized by this code.

32 (c) Imposition of sentence.

33 (1) In general. In sentencing an accused, a court-martial shall impose
 34 punishment that is sufficient, but not greater than necessary, to pro-
 35 motivate justice and to maintain good order and discipline in the state mil-
 36 itary forces, taking into consideration:

37 (A) The nature and circumstances of the offense and the history
 38 and characteristics of the accused;

39 (B) The impact of the offense on:

40 (i) The financial, social, psychological, or medical well-
 41 being of any victim of the offense; and

42 (ii) The mission, discipline, or efficiency of the command
 43 of the accused and any victim of the offense;

44 (C) The need for the sentence:

45 (i) To reflect the seriousness of the offense;

- 1 (ii) To promote respect for the law;
 2 (iii) To provide just punishment for the offense;
 3 (iv) To promote adequate deterrence of misconduct;
 4 (v) To protect others from further crimes by the accused;
 5 (vi) To rehabilitate the accused; and
 6 (vii) To provide, in appropriate cases, the opportunity for
 7 retraining and return to duty to meet the needs of the ser-
 8 vice; and

9 (D) The sentences available under this chapter.

10 (2) Sentencing by military judge. In announcing the sentence in a gen-
 11 eral or special court-martial in which the accused is sentenced by a
 12 military judge alone under article 53, the military judge shall, with
 13 respect to each offense of which the accused is found guilty, specify
 14 the term of confinement, if any, and the amount of the fine, if any. If
 15 the accused is sentenced to confinement for more than one (1) offense,
 16 the military judge shall specify whether the terms of confinement are to
 17 run consecutively or concurrently.

18 (3) Sentencing by members. In a general or special court-martial in
 19 which the accused has elected sentencing by members, the court-martial
 20 shall announce a single sentence for all of the offenses of which the ac-
 21 cused was found guilty.

22 (d) Appeal of sentence to the district court of the county where the
 23 court-martial is held.

24 (1) With the approval of the senior force judge advocate concerned, the
 25 government may appeal a sentence, on the grounds that the sentence vio-
 26 lates the law or the sentence is unreasonable.

27 (2) An appeal under this subsection must be filed within sixty (60) days
 28 after the date on which the judgment of a court-martial is entered into

(A) An order or ruling of the military judge which terminates the proceedings with respect to a charge or specification.

(B) An order or ruling which excludes evidence that is substantial proof of a fact material in the proceeding.

(C) An order or ruling which directs the disclosure of classified information.

(D) An order or ruling which imposes sanctions for nondisclosure of classified information.

(E) A refusal of the military judge to issue a protective order sought by the state to prevent the disclosure of classified information.

(F) A refusal by the military judge to enforce an order described in subparagraph (E) of this paragraph that has previously been issued by appropriate authority.

(G) An order or ruling of the military judge entering a finding of not guilty with respect to a charge or specification following the return of a finding of guilty by the members.

(2) (A) An appeal of an order or ruling may not be taken unless the trial counsel provides the military judge with written notice of appeal from the order or ruling within seventy-two (72) hours of the order or ruling. Such notice shall include a certification by the trial counsel that the appeal is not taken for the purpose of delay and, if the order or ruling appealed is one which excludes evidence, that the evidence excluded is substantial proof of a fact material in the proceeding.

 38 in article 64. For courts-martial held outside of the state of Idaho, venue

 41 be those provided by law and rule for the appeal of criminal cases thereto.

2 ARTICLE 70. APPELLATE COUNSEL

3 (a) The senior force judge advocate shall detail a judge advocate as ap-
4 pellate government counsel to represent the state in the review or appeal of
5 cases specified in article 67a of this code and before any federal court when
6 requested to do so by the state attorney general. Appellate government coun-
7 sel must be a member in good standing of the bar of the highest court of the
8 state to which the appeal is taken.

9 (b) Upon an appeal by the state, an accused has the right to be repre-
10 sented by detailed military counsel before any reviewing authority and be-
11 fore any appellate court.

12 (c) Upon the appeal by an accused, the accused has the right to be repre-
13 sented by military counsel before any reviewing authority.

14 (d) Upon the request of an accused entitled to be so represented, the
15 senior force judge advocate shall appoint a judge advocate to represent the
16 accused in the review or appeal of cases specified in subsections (b) and (c)
17 of this article.

18 (e) An accused may be represented by civilian appellate counsel at no
19 expense to the state.

20 ARTICLE 71. EXECUTION OF SENTENCE -- SUSPENSION OF SENTENCE

21 (a) If the sentence of the court-martial extends to dismissal or a dis-
22 honorable or bad-conduct discharge and if the right of the accused to appel-
23 late review is not waived, and an appeal is not withdrawn under article 61 of
24 this code, that part of the sentence extending to dismissal or a dishonorable
25 or bad-conduct discharge may not be executed until there is a final judgment
26 as to the legality of the proceedings. A judgment as to the legality of the
27 proceedings is final in such cases when review is completed by an appellate
28 court prescribed in article 67a- of this code and is deemed final by the law
29 of state where the judgment was had.

30 (b) If the sentence of the court-martial extends to dismissal or a dis-
31 honorable or bad conduct discharge and if the right of the accused to appel-
32 late review is waived, or an appeal is withdrawn under article 61 of this
33 code, that part of the sentence extending to dismissal or a dishonorable or
34 bad-conduct discharge may not be executed until review of the case by the se-
35 nior force judge advocate and any action on that review under article 64 of
36 this code is completed. Any other part of a court-martial sentence may be or-
37 dered executed by the convening authority or other person acting on the case
38 under article 60 of this code when so approved under that article.

39 ARTICLE 72. VACATION OF SUSPENSION

40 (a) Before the vacation of the suspension of a special court-martial
41 sentence, which as approved includes a bad-conduct discharge, or of any gen-
42 eral court-martial sentence, the officer having special court-martial ju-
43 risdiction over the probationer shall hold a hearing on an alleged violation
44 of probation. The probationer shall be represented at the hearing by mili-

1 ~~tary counsel if the probationer so desires~~ special court-martial convening
2 authority may detail a judge advocate who is certified under article 27(b)
3 of this code to conduct the hearing. The probationer shall be represented at
4 the hearing by military counsel if the probationer so desires.

5 (b) The record of the hearing and the recommendation of the officer hav-
6 ing special court-martial jurisdiction shall be sent for action to the offi-
7 cer exercising general court-martial jurisdiction over the probationer. If
8 the officer exercising general court-martial jurisdiction vacates the sus-
9 pension, any unexecuted part of the sentence, except a dismissal, shall be
10 executed, subject to applicable restrictions under article 57 in this code.

11 (c) The suspension of any other sentence may be vacated by any authority
12 competent to convene, for the command in which the accused is serving or as-
13 signed, a court of the kind that imposed the sentence.

14 ARTICLE 73. PETITION FOR A NEW TRIAL

15 At any time within ~~two~~ three (23) years after approval by the convening au-
16 thority of a court-martial sentence, the accused may petition the adjutant
17 general for a new trial on the grounds of newly discovered evidence or fraud
18 on the court-martial.

19 ARTICLE 74. REMISSION AND SUSPENSION

20 (a) Any authority competent to convene, for the command in which the ac-
21 cused is serving or assigned, a court of the kind that imposed the sentence
22 may remit or suspend any part or amount of the unexecuted part of any sen-
23 tence, including all uncollected forfeitures other than a sentence approved
24 by the governor.

25 (b) The governor may, for good cause, substitute an administrative form
26 of discharge for a discharge or dismissal executed in accordance with the
27 sentence of a court-martial.

28 ARTICLE 75. RESTORATION

29 (a) Under such regulations as may be prescribed, all rights, privi-
30 leges, and property affected by an executed part of a court-martial sentence
31 which has been set aside or disapproved, except an executed dismissal or
32 discharge, shall be restored unless a new trial or rehearing is ordered and
33 such executed part is included in a sentence imposed upon the new trial or
34 rehearing.

35 (b) If a previously executed sentence of dishonorable or bad-conduct
36 discharge is not imposed on a new trial, the governor or his designated rep-
37 resentative may substitute therefore a form of discharge authorized for ad-
38 ministrative issuance unless the accused is to serve out the remainder of the
39 accused's enlistment.

40 (c) If a previously executed sentence of dismissal is not imposed on
41 a new trial, the governor or his designated representative may substitute
42 therefore a form of discharge authorized for administrative issue, and the
43 commissioned officer dismissed by that sentence may be reappointed by the
44 governor alone to such commissioned grade and with such rank as in the opin-

1 ion of the governor that former officer would have attained had he not been
 2 dismissed. The reappointment of such a former officer shall be without re-
 3 gard to the existence of a vacancy and shall affect the promotion status of
 4 other officers only insofar as the governor may direct. All time between the
 5 dismissal and the reappointment shall be considered as actual service for
 6 all purposes, including the right to pay and allowances.

7 (d) The adjutant general may prescribe regulations, with such limita-
 8 tions as the adjutant general considers appropriate, governing eligibility
 9 for pay and allowances for the period after the date on which an executed part
 10 of a court-martial sentence is set aside.

11 ARTICLE 76. FINALITY OF PROCEEDINGS, FINDINGS, AND SENTENCES

12 The appellate review of records of trial provided by this code, the proceed-
 13 ings, findings, and sentences of courts-martial as approved, reviewed, or
 14 affirmed as required by this code, and all dismissals and discharges car-
 15 ried into execution under sentences by courts-martial following approval,
 16 review, or affirmation as required by this code are final and conclusive.
 17 Orders publishing the proceedings of courts-martial and all action taken
 18 pursuant to those proceedings are binding upon all departments, courts,
 19 agencies, and officers of the United States and the several states, subject
 20 only to action upon a petition for a new trial as provided in article 73 of
 21 this code and to action under article 74 of this code.

22 ARTICLE 76a. LEAVE REQUIRED TO BE TAKEN PEND-
 23 ING REVIEW OF CERTAIN COURT-MARTIAL CONVICTIONS

24 Under regulations prescribed, an accused who has been sentenced by a court-
 25 martial may be required to take leave pending completion of action under this
 26 article if the sentence, as approved under article 60 of this code, includes

 28 charge. The accused may be required to begin such leave on the date on which
 29 the sentence is approved under article 60 of this code or at any time after
 30 such date, and such leave may be continued until the date on which action un-

17 (b) Definition. In this article, the term "lesser included offense"

27 (3) Through disobedience, neglect, or intentional misconduct endan-

30 (5) Is guilty of cowardly conduct;

31 (6) Quits his place of duty to plunder or pillage;

32 (7) Causes false alarms in any command, unit, or place under control of
33 the armed forces of the United States or the state military forces;

34 (8) Willfully fails to do his utmost to encounter, engage, capture, or
35 destroy any enemy troops, combatants, vessels, aircraft, or any other thing,
36 which it is his duty so to encounter, engage, capture, or destroy; or

37 (9) Does not afford all practicable relief and assistance to any
38 troops, combatants, vessels, or aircraft of the armed forces belonging to
39 the United States or its allies, to the state, or to any other state, when
40 engaged in battle;

42 ARTICLE 100. SUBORDINATE COMPELLING SURRENDER

1 Any person subject to this code who compels or attempts to compel the comman-

10 (a) Any person subject to this code who, with the intent to retaliate
 11 against any person for reporting or planning to report a criminal offense,
 12 or making or planning to make a protected communication, or with the intent
 13 to discourage any person from reporting a criminal offense or making or plan-
 14 ning to make a protected communication:

15 (1) Wrongfully takes or threatens to take an adverse personnel action
 16 against any person; or

17 (2) Wrongfully withholds or threatens to withhold a favorable person-
 18 nel action with respect to any person;

19 shall be punished as a court-martial may direct.

20 (b) Definitions. In this article:

21 (1) "Protected communication" means the following:

22 (i) A lawful communication to a member of congress or an inspector
 23 general; or

24 (ii) A communication to a covered individual or organization
 25 in which a member of the armed forces complains of, or discloses
 26 information that the member reasonably believes constitutes evi-
 27 dence of, any of the following:

28 (A) A violation of law or regulation, including a law or reg-
 29 ulation prohibiting sexual harassment or unlawful discrimi-
 30 nation; or

31 (B) Gross mismanagement, a gross waste of funds, an abuse
 32 of authority, or a substantial and specific danger to public
 33 health or safety.

34 (2) "Inspector general" has the meaning given that term in 10 U.S.C.
 35 1034.

36 (3) "Covered individual or organization" means any recipient of a
 37 communication specified in clauses (i) through (vi) of 10 U.S.C.
 38 1034(b) (1) (B).

39 ARTICLE 133. CONDUCT UNBECOMING AN OFFICER AND A GENTLEMAN

40 Any commissioned officer, cadet, candidate, or midshipman who is convicted
 41 of conduct unbecoming an officer and a gentleman shall be punished as a
 42 court-martial may direct.

43 ARTICLE 134. GENERAL ARTICLE

44 Though not specifically mentioned in this code, all disorders and neglects
 45 to the prejudice of good order and discipline in the state military forces
 46 and all conduct of a nature to bring discredit upon the state military forces

1 shall be taken cognizance of by a court-martial and punished at the discre-
 2 tion of a military court. Offenses which may be punished under this ~~section~~
 3 article include, but are not limited to, those offenses set out in the man-
 4 ual for courts-martial as punishable under this article of the uniform code
 5 of military justice, those offenses that violate the criminal laws of the
 6 state where the offense occurred, and those offenses that violate the crimi-
 7 nal laws of the United States. However, where a crime constitutes an offense
 8 that violates both this code and the criminal laws of the state where the of-
 9 fense occurs or criminal laws of the United States, jurisdiction of the mili-
 10 tary court must be determined in accordance with article 2 (b) of this code.

11 PART XI. MISCELLANEOUS PROVISIONS

12 ARTICLE 135. COURTS OF INQUIRY

13 (a) Courts of inquiry to investigate any matter of concern to the state
 14 military forces may be convened by any person authorized to convene a gen-
 15 eral court-martial, whether or not the persons involved have requested such
 16 an inquiry.

17 (b) A court of inquiry consists of three (3) or more commissioned offi-
 18 cers. For each court of inquiry, the convening authority shall also appoint
 19 counsel for the court.

20 (c) Any person subject to this code whose conduct is subject to inquiry
 21 shall be designated as a party. Any person subject to this code who has a di-
 22 rect interest in the subject of inquiry has the right to be designated as a
 23 party upon request to the court. Any person designated as a party shall be
 24 given due notice and has the right to be present, to be represented by coun-
 25 sel, to cross-examine witnesses, and to introduce evidence.

26 (d) Members of a court of inquiry may be challenged by a party, but only
 27 for cause stated to the court.

28 (e) The members, counsel, the reporter, and interpreters of courts of
 29 inquiry shall take an oath to faithfully perform their duties.

30 (f) Witnesses may be summoned to appear and testify and be examined be-
 31 fore courts of inquiry, as provided for courts-martial.

32 (g) Courts of inquiry shall make findings of fact but may not express
 33 opinions or make recommendations unless required to do so by the convening
 34 authority.

35 (h) Each court of inquiry shall keep a record of its proceedings, which
 36 shall be authenticated by the signatures of the president and counsel for
 37 the court and forwarded to the convening authority. If the record cannot
 38 be authenticated by the president, it shall be signed by a member in lieu of
 39 the president. If the record cannot be authenticated by the counsel for the
 40 court, it shall be signed by a member in lieu of the counsel.

41 ARTICLE 136. AUTHORITY TO ADMINISTER OATHS AND TO ACT AS NOTARY

42 (a) The following persons may administer oaths for the purposes of mil-
 43 itary administration, including military justice:

- 44 (1) All judge advocates.
 45 (2) All summary courts-martial.

1 (3) All adjutants, assistant adjutants, acting adjutants, and person-
2 nel adjutants.

3 (4) All commanding officers of the naval militia.

4 (5) All other persons designated by regulations of the armed forces of
5 the United States or by statute.

6 (b) The following persons may administer oaths necessary in the perfor-
7 mance of their duties:

8 (1) The president, military judge, and trial counsel for all general
9 and special courts-martial.

10 (2) The president and the counsel for the court of any court of inquiry.

11 (3) All officers designated to take a deposition.

12 (4) All persons detailed to conduct an investigation.

13 (5) All recruiting officers.

14 (6) All other persons designated by regulations of the armed forces of
15 the United States or by statute.

16 (c) The signature without seal of any such person, together with the ti-
17 tle of his office, is prima facie evidence of the person's authority.

18 ARTICLE 137. ARTICLES TO BE EXPLAINED

19 (a) The articles of this code specified in subsection (c) of this arti-
20 cle shall be carefully explained to each enlisted member at the time of, or
21 within thirty (30) days after, the member's initial entrance into a duty sta-
22 tus with the state military forces.

23 (b) Such articles shall be explained again:

24 (1) After the member has completed basic or recruit training; and

25 (2) At the time when the member reenlists.

26 (c) This subsection applies with respect to articles 2, 3, 7 through 15,
27 25, 27, 31, 37, 38, 55, 77 through 134, and 137 through 139 of this code.

28 (d) The text of the code and of the regulations prescribed under such
29 code shall be made available to a member of the state military forces, upon
30 request by the member, for the member's personal examination.

31 ARTICLE 138. COMPLAINTS OF WRONGS

32 Any member of the state military forces who believes himself wronged by a
33 commanding officer, and who, upon due application to that commanding offi-
34 cer, is refused redress may complain to any superior commissioned officer,
35 who shall forward the complaint to the officer exercising general court-mar-
36 tial jurisdiction over the officer against whom it is made. The officer
37 exercising general court-martial jurisdiction shall examine into the com-
38 plaint and take proper measures for redressing the wrong complained of, and
39 shall, as soon as possible, send to the adjutant general a true statement of
40 that complaint, with the proceedings had thereon.

41 ARTICLE 139. REDRESS OF INJURIES TO PROPERTY

42 (a) Whenever complaint is made to any commanding officer that willful
43 damage has been done to the property of any person or that the person's prop-
44 erty has been wrongfully taken by members of the state military forces, that

1 officer may, under such regulations prescribed, convene a board to investi-
2 gate the complaint. The board shall consist of from one (1) to three (3) com-
3 missioned officers and, for the purpose of that investigation, it has power
4 to summon witnesses and examine them upon oath, to receive depositions or
5 other documentary evidence, and to assess the damages sustained against the
6 responsible parties. The assessment of damages made by the board is subject
7 to the approval of the commanding officer, and in the amount approved by that
8 officer shall be charged against the pay of the offenders. The order of the
9 commanding officer directing charges herein authorized is conclusive on any
10 disbursing officer for payment to the injured parties of the damages so as-
11 sessed and approved.

12 (b) If the offenders cannot be ascertained, but the organization or
13 detachment to which they belong is known, charges totaling the amount of
14 damages assessed and approved may be made in such proportion as may be con-
15 sidered just upon the individual members thereof who are shown to have been
16 present at the scene at the time the damages complained of were inflicted, as
17 determined by the approved findings of the board.

18 ARTICLE 140. DELEGATION BY THE GOVERNOR

19 The governor may delegate any authority vested in the governor under this
20 code and provide for the sub-delegation of any such authority, except the
21 power given the governor by article 22 of this code.

22 ARTICLE 141. PAYMENT OF FEES, COSTS AND EXPENSES

23 The fees and authorized travel expenses of all witnesses, experts, victims,
24 court reporters, and interpreters, fees for the service of process, the
25 costs of collection, apprehension, detention and confinement, and all other
26 necessary expenses of prosecution and the administration of military jus-
27 tice, to include courts-martial and nonjudicial punishment, not otherwise
28 payable by any other source, shall be paid out of the military division sup-
29 port fund as established in section 46-806, Idaho Code.

30 ARTICLE 142. PAYMENT OF FINES AND DISPOSITION THEREOF

31 (a) Fines imposed by a military court or through imposition of nonjudi-
32 cial punishment may be paid to the state and delivered to the court or impos-
33 ing officer or to a person executing their process. Fines may be collected in
34 the following manner:

35 (1) By cash or money order;

36 (2) By retention of any pay or allowances due or to become due the person
37 fined from any state or the United States;

38 (3) By garnishment or levy, together with costs, on the wages, goods,
39 and chattels of a person delinquent in paying a fine, as provided by law.

40 (b) Any sum so received or retained shall be deposited in the military
41 division support fund as established in section 46-806, Idaho Code, or to
42 whomever the court so directs.

1 ARTICLE 143. UNIFORMITY OF INTERPRETATION

2 This code shall be so construed as to effectuate its general purpose to make
3 it uniform, so far as practical, with the uniform code of military justice,
4 10 U.S.C. chapter 47.

5 ARTICLE 144. IMMUNITY FOR ACTION OF MILITARY COURTS

6 All persons acting under the provisions of this code, whether as a member of
7 the military or as a civilian, shall be immune from any personal liability
8 for any of the acts or omissions which they did or failed to do as part of
9 their duties under this code.

10 ARTICLE 145. SEVERABILITY

11 The provisions of this code are hereby declared to be severable and if any
12 provision of this code or the application of such provision to any person or
13 circumstance is declared invalid for any reason, such declaration shall not
14 affect the validity of the remaining portions of this code.

15 ARTICLE 146. SHORT TITLE

16 This act may be cited as the "~~Uniform State~~ Idaho Code of Military Justice"
17 (USICMJ).

18 ARTICLE 147. TIME OF TAKING EFFECT

19 This act takes effect July 1, 20159.

20 ARTICLE 148. TIME OF TAKING EFFECT

21 Upon enactment and the effective date, this law supersedes all existing
22 statutes, ordinances, directives, rules, regulations, orders and other
23 laws in the state covered by the subject matter of this law, and all such
24 statutes, ordinances, directives, rules, regulations, orders and other laws
25 are hereby repealed.
