HOUSE BILL NO. 186

BY APPROPRIATIONS COMMITTEE

1 AN ACT  
2 RELATING TO THE APPROPRIATION TO THE DIVISION OF VETERANS SERVICES FOR FIS-  
3 CAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE DIVISION OF VET-  
4 ERANS SERVICES FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE  
5 DIVISION OF VETERANS SERVICES FOR FISCAL YEAR 2019; PROVIDING FOR A CASH  
6 TRANSFER; AND DECLARING AN EMERGENCY.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. In addition to the appropriation made in Section 1, Chap-  
9 ter 105, Laws of 2018, and any other appropriation provided by law, there  
10 is hereby appropriated to the Division of Veterans Services the following  
11 amounts to be expended according to the designated expense classes from the  
12 listed funds for the period July 1, 2018, through June 30, 2019:

22 SECTION 2. Notwithstanding any other provision of law to the contrary,  
23 the appropriation made to the Division of Veterans Services in Section 1,  
24 Chapter 105, Laws of 2018, from the Miscellaneous Revenue Fund is hereby re-  
25 duced by \$1,200,000 for personnel costs for the period July 1, 2018, through  
26 June 30, 2019.

27 SECTION 3. CASH TRANSFER. Notwithstanding the provisions of Section  
28 65-703(2), Idaho Code, or any other provision of law to the contrary, there  
29 is hereby appropriated and the administrator of the Division of Veterans  
30 Services shall request the State Controller to make a transfer or transfers  
31 from the Idaho Veterans Recognition Fund to the Idaho Veterans Recognition  
32 Income Fund in an amount not to exceed a total of \$800,000 for the purpose of  
33 providing the state's required match for the establishment of a fourth vet-  
34 erans home in north Idaho for the period July 1, 2018, through June 30, 2019.  
35 Further, notwithstanding the provisions of Section 65-704(5), Idaho Code,  
36 or any other provision of law to the contrary, any funds remaining in the  
37 Veterans Recognition Income Fund at the end of fiscal year 2019 shall remain

1 in the Veterans Recognition Income Fund and shall not be transferred back to  
2 the Idaho Veterans Recognition Fund.

3 SECTION 4. An emergency existing therefor, which emergency is hereby  
4 declared to exist, this act shall be in full force and effect on and after its  
5 passage and approval.
