A SENATE RESOLUTION

1 STATING FINDINGS OF THE SENATE AND PROVIDING FOR THE AMENDMENT OF RULE 19 OF
2 THE RULES OF THE SENATE TO PROVIDE FOR APPOINTMENT OF MEMBERS OF STAND-
3 ING COMMITTEES, TO PROVIDE FOR APPOINTMENT OF THE CHAIR AND VICE-CHAIR
4 OF COMMITTEES, AND TO REVISE PROVISIONS REGARDING THE PRINTING COMMIT-
5 TEE.

7 Be It Resolved by the Senate of the State of Idaho:

8 WHEREAS, the Senate deems it necessary and desirable that Rule 19 of the
9 Rules of the Senate be amended.

10 NOW, THEREFORE, BE IT RESOLVED by the members of the Senate, assembled
11 in the Second Regular Session of the Sixty-fifth Idaho Legislature, that
12 Rule 19 of the Rules of the Senate shall be amended to read as follows:

13 RULE 19

14 Committee Assignments.-- (A) The members of the following standing com-
15 mittees shall be appointed by the leadership under the direction of the Pres-
16 ident Pro Tempore, by and with the advice and consent of the Senate; the num-
17 ber of members on each committee shall be fixed in the order of appointment,
18 and such order shall be read into the Journal; provided that the President
19 Pro Tempore shall appoint a majority of each committee and the ~~chairman~~ chair
20 and vice-chair of each committee from the membership of the political party
21 having a majority in the Senate:

22 Agricultural Affairs
23 Commerce and Human Resources
24 Education
25 Finance
26 Health and Welfare
27 Judiciary and Rules
28 Local Government and Taxation
29 Resources and Environment
30 State Affairs
31 Transportation

32 Printing Committee.-- (B) The Judiciary and Rules Committee shall con-
33 stitute and perform all duties of a printing and engrossing and enrolling
34 committee in the Senate, ~~including the execution of a contract for print-~~
35 ~~ing of the session laws to be submitted to the Senate by resolution for~~
36 ~~approval;~~ and the Secretary of the Senate shall serve as an ex officio member
37 of said committee. The Joint Printing Committee shall prepare a brief writ-
38 ten report of its recommendations, which shall be delivered to the Senate

1 Judiciary and Rules Committee, and shall perform such other functions of
2 administration of Senate affairs as shall be assigned to it by the President.

3 Absence of Chairman Chair.-- (C) At any committee meeting, in the
4 absence of the chairman chair, the acting chairman chair shall be the
5 vice-chairman chair. If both chairman chair and vice-chairman chair be ab-
6 sent, then the other committee members, in the order listed on the committee
7 roster, shall have the right to serve as acting chairman chair.

8 Chairman Chair Voting.-- (D) On all standing committees and the Commit-
9 tee of the Whole, the chairman chair shall be entitled to vote at all times.
