1 RELATING TO THE APPROPRIATION TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT
2 PROGRAM'S DIVISION OF EDUCATIONAL SERVICES FOR THE DEAF AND THE BLIND;
3 APPROPRIATING MONEYS TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PRO-
4 GRAM'S DIVISION OF EDUCATIONAL SERVICES FOR THE DEAF AND THE BLIND FOR
5 FISCAL YEAR 2023; APPROPRIATING GENERAL FUND MONEYS FOR TRANSFER TO THE
6 PUBLIC SCHOOL INCOME FUND FOR FISCAL YEAR 2023; CLARIFYING THE ORIGINAL
7 FUND SOURCE FOR EXPENDITURES IN THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT
8 PROGRAM'S DIVISION OF EDUCATIONAL SERVICES FOR THE DEAF AND THE BLIND
9 FOR FISCAL YEAR 2023; APPROPRIATING ADDITIONAL MONEYS TO THE PUBLIC
10 SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF EDUCATIONAL SERVICES
11 FOR THE DEAF AND THE BLIND FOR FISCAL YEAR 2022; APPROPRIATING ADDI-
12 TIONAL GENERAL FUND MONEYS FOR TRANSFER TO THE PUBLIC SCHOOL INCOME FUND
13 FOR FISCAL YEAR 2022; CLARIFYING THE ORIGINAL FUND SOURCE FOR EXPENDI-
14 TURES IN THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF
15 EDUCATIONAL SERVICES FOR THE DEAF AND THE BLIND FOR FISCAL YEAR 2022;
16 AND DECLARING AN EMERGENCY.

18 Be It Enacted by the Legislature of the State of Idaho:

19 SECTION 1. There is hereby appropriated to the Public Schools Educa-
20 tional Support Program's Division of Educational Services for the Deaf and
21 the Blind the following amounts to be expended from the listed funds for the
22 period July 1, 2022, through June 30, 2023:

25 ARPA State Fiscal Recovery Fund	8,000
26 School for the Deaf and the Blind Endowment Fund	<u>233,600</u>
27 TOTAL	\$13,300,000

28 SECTION 2. There is hereby appropriated and the Office of the State
29 Controller shall transfer \$13,058,400 from the General Fund to the Public
30 School Income Fund on July 1, 2022, or as soon thereafter as practicable for
31 the period July 1, 2022, through June 30, 2023.

32 SECTION 3. Of the amounts appropriated in Section 1 for the Public
33 Schools Educational Support Program's Division of Educational Services for
34 the Deaf and the Blind \$13,058,400 shall be considered expended from the
35 General Fund for the period July 1, 2022, through June 30, 2023.

36 SECTION 4. In addition to the appropriation made in Section 3, Chap-
37 ter 252, Laws of 2021, and any other appropriation provided by law, there is

1 hereby appropriated to the Public Schools Educational Support Program's Di-
2 vision of Educational Services for the Deaf and the Blind \$231,000 from the
3 Public School Income Fund to be expended for the period July 1, 2021, through
4 June 30, 2022.

5 SECTION 5. There is hereby appropriated and the Office of the State Con-
6 troller shall transfer \$231,000 from the General Fund to the Public School
7 Income Fund as soon as practicable for the period July 1, 2021, through June
8 30, 2022.

9 SECTION 6. Of the additional amounts appropriated in Section 4 for the
10 Public Schools Educational Support Program's Division of Educational Ser-
11 vices for the Deaf and the Blind \$231,000 shall be considered expended from
12 the General Fund for the period July 1, 2021, through June 30, 2022.

13 SECTION 7. An emergency existing therefor, which emergency is hereby
14 declared to exist, this act shall be in full force and effect on and after its
15 passage and approval.
