SENATE BILL NO. 1423

AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF AGRICULTURE; APPROPRI-
2 ATING ADDITIONAL MONEYS TO THE DEPARTMENT OF AGRICULTURE FOR THE PLANT
3 INDUSTRIES PROGRAM FOR FISCAL YEAR 2022; PROVIDING REAPPROPRIATION AU-
4 THORITY; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF AGRICUL-
5 TURE FOR THE ANIMAL INDUSTRIES PROGRAM FOR FISCAL YEAR 2023; AND DECLAR-
6 ING AN EMERGENCY.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to the appropriation made in Section 1, Chap-
10 ter 106, Laws of 2021, and any other appropriation provided by law, there is
11 hereby appropriated to the Department of Agriculture for the Plant Indus-
12 tries Program \$600,000 from the General Fund to be expended for operating ex-
13 penditures for the period July 1, 2021, through June 30, 2022, for the pur-
14 pose of invasive species watercraft check stations.

15 SECTION 2. REAPPROPRIATION AUTHORITY. There is hereby reappropriated
16 to the Department of Agriculture for the Plant Industries Program any unex-
17 pended and unencumbered balances appropriated to the Department of Agricul-
18 ture for the Plant Industries Program from the General Fund for the purpose
19 of invasive species watercraft check stations for fiscal year 2022, in an
20 amount not to exceed \$600,000 from the General Fund, to be used for nonrecur-
21 ring expenditures related to invasive species watercraft check stations for
22 the period July 1, 2022, through June 30, 2023. The Office of the State Con-
23 troller shall confirm the reappropriation amount, by fund, expense class,
24 and program, with the Legislative Services Office prior to processing the
25 reappropriation authorized herein.

26 SECTION 3. In addition to any other appropriation provided by law,
27 there is hereby appropriated to the Department of Agriculture for the Animal
28 Industries Program the following amounts to be expended according to the
29 designated expenses classes from the General Fund for the period July 1,
30 2022, through June 30, 2023:

35 SECTION 4. An emergency existing therefor, which emergency is hereby
36 declared to exist, this act shall be in full force and effect on and after its
37 passage and approval.
