RS 28090. Major Stokes stated security personnel at the OCTC are not certified law enforcement officers and do not have the authority to arrest. The Idaho Military Division recommends striking the word "arrest" from Code. The Major also said security personnel do not attend the Idaho POST Academy. The requirement to attend does not reflect current procedures. The IMD requests striking the

requirement to attend the POST academy from Code.

MOTION: Rep. Harris made a motion to introduce RS 28090. Motion carried by voice vote.

RS 28078: Pete Koehler, Interim Administrator, Veteran Services, presented RS 28078.

Mr. Koehler said this proposed legislation eliminates outdated and unnecessary

sections of Code related to state funding of Veterans Memorials.

MOTION: Rep. DeMordaunt made a motion to introduce RS 28078. Motion carried by

voice vote.

RS 28079: Pete Koehler presented RS 28079. The proposed legislation repeals outdated and

unnecessary sections of Code related to males over eighteen years of age.

RS 28328: Rep. Gestrin presented **RS 28328**. Rep. Gestrin stated the purpose of this

proposed legislation is to enable the Idaho Transportation Department to issue a letter stating that a lien, filed properly with the department, shall be considered perfected, if ITD is not able to issue title in a timely manner. In answer to a committee question, Rep. Gestrin clarified this legislation pertains only to commercial dealerships where titles need to be processed quickly. He added, ITD

converted to a new computer system and it is causing long delays with processing titles.

H 5: Jeff Neumeyer, Vice President and General Counsel, United Heritage, presented

H 5. He stated the legislation clarifies the intent of Code relative to the use of global positioning or navigation systems by the operator of a motor vehicle. Use of these

mobile electronic devices is permissible provided it is hands-free.

MOTION:

Rep. Blanksma made a motion to send **H 5** to the floor with a **DO PASS** recommendation.

Speaking in opposition were Jessica Marcu, Adrian Marcu, Del Chapel and Vitaliy Velich. Business for entities delivering food, Uber Drivers and others who depend on use of GPS systems will be hampered if use of their device is totally hand-free.

Rep. Holtzclaw spoke **in opposition** stating it was his understanding the food delivery business has doubled in recent months. He doesn't want to get in the way of people earning a living.

Jeff Neumeyer responded to concerns by saying he's sensitive to the issues mentioned. Delivery drivers need access to their GPS. That is permissible if the device is stationed somewhere out of their hands. He added, this issue is now addressed on the new driver exam.

has contributed to the development of submarine design.

RS 28439: Rep. Monks presented RS 28439. Leaving this Code in tact causes confusion with other states regarding whether or

not Idaho is still a participating state.

Speaking in opposition were: Matthew Conde, AAA Idaho and Mike Kane.

Margie Baker spoke in support of the bill.

Brian Goeke addressed concerns. He said Idaho Transportation Department has no ability to enforce the statute. Other states in the NRVC have already been

that exempts disclosure on a vehicle due to its age, changed from ten to twenty years. Motorists are responsible to stop a certain number of feet away from a crossing when a train is approaching. Modern on-track maintenance equipment has evolved into "train like" machines that present the same dangers as a train. This legislation adds the language "or other on-track equipment" to code, anywhere it delineates a motorist's responsibilities at a railroad crossing or

when a "train" is present.

David Cameron, Teamsters Rail Conference, spoke **in support** of the bill. He commented that some of the new railroad equipment is as big as a locomotive and

poses the same dangers at railroad crossings or when a train is present.

MOTION: Rep. Gestrin made a motion to send S 1104 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Okuniewicz will sponsor

the bill on the floor.

S 1102: Brody Aston, representing VITU, presented **S 1102**. This legislation provides

States that have adopted an Electronic Vehicle Credential Program have reported reduced costs, paperwork and pressure on DMVs while improving customer service. The EVC program authorizes ITD to allow providers to electronically file vehicle titling and

registration transactions.

Rep. Youngblood addressed Jeremy Chou, co-sponsor of the bill. Mr. Chou, representing the Idaho Association of Counties and American Council of Engineering Companies, clarified wording in the bill. He further explained the bonding and grant process.

H 229aaS:	Chairman Palmer stated when he presented H 229aaS in committee on April 14, 2021, for Rep. Gestrin , who was taking care of a family emergency, he did not have all of the pertinent information necessary for the committee to consider. As a result, H 229aaS was returned to committee in order for Rep. Gestrin to provide a more detailed explanation of the Senate amendments.
	Rep. Gestrin , District 8, thanked the committee for considering the Senate amendments a second time. He indicated the amendments only add \$10.00 to the in-state snowmobile sticker fee and \$10.00 to the rental snowmobile fee. If the committee concurs with the amendments, overall, H 229aaS would generate over \$611,000 in additional revenues, with over \$328,000 of that from non-resident fees. These additional funds will support the construction and grooming of trails and maintenance of parking lots and toilets. Additionally, \$1.00 from each fee collected will be set aside to establish a statewide snowmobile avalanche program, which will include avalanche awareness education, avalanche forecasting, an avalanche warning system, and avalanche response throughout the state.
	In response to committee questions regarding what happens if this bill isn't passed, Rep. Gestrin stated the last time there was a fee increase was 2007, so this bill is just trying to catch up with the cost of doing business to keep the program solvent.
	Several committee members spoke with concern over the level of the fee increase.
MOTION:	Rep. Addis made a motion to concur with the amendments made in the Senate to H 229aaS. Motion carried by voice vote. Reps. Harris, Monks, and Mitchell requested to be recorded as voting NAY. Rep. Gestrin will sponsor the bill on the floor.
