Motion: Beginning with the FY 2023 Base of \$9,309,800, add \$35,400 for benefit costs, \$339,000 for replacement items, a reduction of \$2,500 for statewide cost allocation, and \$424,900 for the change in employee compensation. Also included are the following line items: line item 1, which provides \$13,400.

For FY 2023 I move 72.00 FTP, \$7,475,600 from the General Fund, \$2,320,600 from dedicated funds, and \$323,800 from federal funds for a grand total of \$10,120,000.

This motion includes an exemption to budget laws to allow funds to be transferred between object codes and no FTP cap. Also included is reappropriation authority from FY 2022 into FY 2023 for the unexpended and unencumbered balance of the appropriation from the Technology Infrastructure Stabilization Fund.
