STATEMENT OF PURPOSE

RS23097

This is the FY 2015 appropriation to the Department of Commerce in the amount of \$34,416,900 with full-time equivalent positions capped at 49. This appropriation provides for increased cost of benefits, statewide cost allocation, and a network billing adjustment. The budget provides for the equivalent of a 2% change in employee compensation (1% ongoing and 1% one-time). Finally, this budget includes four line items. Line item 2 provides \$30,000 to expand the foreign trade offices in Asia. Line item 3 provides \$29,600 for additional IGEM grants, this unappropriated cash from the Miscellaneous Revenue Fund and the Small Business Assistance Fund. Line item 4 provides \$50,000 in operating expenditures transferred from trustee and benefit payments for general operations. Line item 5 provides \$3,000,000 in spending authority for the Idaho Opportunity Fund, but this is not new money, it is leftover cash from the current year transfer from the General Fund. Overall, this budget is a 0.5% increase above the FY 2014 appropriation.
