## STATEMENT OF PURPOSE

## RS26272

This is the FY 2019 original appropriation bill to the Board of Tax Appeals. It appropriates \$608,600 and caps the number of authorized full-time equivalent positions at 5.00. This appropriation includes a reduction of benefit costs, a onetime increase for replacement items, a reduction for Statewide Cost Allocation, and funding for a 3% ongoing merit-based salary increase for permanent employees, to be distributed at the discretion of the agency head. Replacement items includes six phones, one network router, and one network switch. Overall, this budget is a 0.3% increase above the FY 2018 original appropriation.
