AN ACT

RELATING TO FIREARMS ON SCHOOL PROPERTY; AMENDING SECTION 18-3302C, IDAHO CODE, TO PROVIDE A CODE REFERENCE; AMENDING SECTION 18-3302D, IDAHO CODE, TO DEFINE TERMS, TO REVISE DEFINITIONS, TO REVISE A PROVISION REGARDING SEARCH OF A STUDENT OR MINOR, TO PROVIDE AN EXCEPTION, TO PROHIBIT CERTAIN ACTIONS, TO PROVIDE FOR DISCLOSURE OF A CONCEALED WEAPON ON SCHOOL PROPERTY IN CERTAIN INSTANCES, TO PROVIDE FOR THE RIGHT OF PRIVATE PROPERTY OWNERS IN CERTAIN INSTANCES, TO PROHIBIT A CAUSE OF ACTION IN CERTAIN INSTANCES, TO PROHIBIT CERTAIN SIGNAGE, TO PROVIDE THAT NO SCHOOL EMPLOYEE SHALL BE REQUIRED TO CARRY A CONCEALED WEAPON, AND TO PROVIDE THAT A SCHOOL EMPLOYEE SHALL NOT BE CIVILLY OR CRIMINALLY LIABLE IN CERTAIN INSTANCES; AMENDING SECTION 74-106, IDAHO CODE, TO PROVIDE THAT CERTAIN RECORDS SHALL BE EXEMPT FROM DISCLOSURE AND TO MAKE A TECHNICAL CORRECTION; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

RELATING TO PHYSICIANS AND PHYSICIAN ASSISTANTS; AMENDING SECTION 54-1867, IDAHO CODE, TO PROVIDE FOR ASSISTANT PHYSICIAN LIMITED LICENSURE; AMENDING CHAPTER 18, TITLE 54, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 54-1868, IDAHO CODE, TO PROVIDE FOR THE GENERAL PRACTICE LICENSURE OF CERTAIN ASSISTANT PHYSICIANS; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

HOUSE BILL NO. 419 BY HEALTH AND WELFARE COMMITTEE

AN ACT

RELATING TO MEDICAID; AMENDING SECTION 56-267, IDAHO CODE, TO PROVIDE CERTAIN CONDITIONS FOR IMPLEMENTATION OF MEDICAID ELIGIBILITY EXPANSION, TO REQUIRE NOTIFICATION TO THE LEGISLATURE, AND TO PROVIDE FOR CONDITIONAL TERMINATION OF MEDICAID ELIGIBILITY EXPANSION; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

HOUSE BILL NO. 420 BY EDUCATION COMMITTEE

AN ACT

RELATING TO SCHOOL DISTRICT TRUSTEES; AMENDING SECTION 33-504, IDAHO CODE, TO REVISE PROVISIONS REGARDING VACANCIES ON SCHOOL DISTRICT BOARDS OF TRUSTEES AND TO MAKE TECHNICAL CORRECTIONS; AMENDING SECTION 33-510, IDAHO CODE, TO REVISE PROVISIONS REGARDING THE TRANSACTION OF BUSINESS BY SCHOOL BOARDS OF TRUSTEES WHEN VACANCIES OCCUR AND TO MAKE TECHNICAL CORRECTIONS; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

<u>H 415</u>, <u>H 416</u>, <u>H 417</u>, <u>H 418</u>, <u>H 419</u>, and <u>H 420</u> were introduced, read the first time by title, and referred to the Judiciary, Rules, and Administration Committee for printing.
