- RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE; AP-2 PROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE 3 FOR THE DIVISION OF WELFARE FOR FISCAL YEAR 2025; PROVIDING DIRECTION TO 4 MAXIMIZE FEDERAL FUNDS FOR CHILD CARE DEVELOPMENT BLOCK GRANTS; APPRO-5 PRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR 6 THE DIVISION OF WELFARE FOR FISCAL YEAR 2024; REDUCING THE APPROPRIA-7 TION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE DIVISION OF WELFARE 8 9 FOR FISCAL YEAR 2024; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE DIVISION OF WELFARE FOR FISCAL YEAR 2024; 10 AND DECLARING AN EMERGENCY AND PROVIDING EFFECTIVE DATES. 11
- 12 Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. Notwithstanding any other provision of law to the contrary, there is hereby appropriated to the Department of Health and Welfare for the Division of Welfare for the Self-Reliance Operations Program the following amounts to be expended according to the designated expense classes from the listed funds for the period July 1, 2024, through June 30, 2025:
