RELATING TO PUBLIC HEALTH DISTRICTS; AMENDING SECTION 39-411, IDAHO CODE, TO
 REVISE PROVISIONS REGARDING THE COMPOSITION OF HEALTH DISTRICT BOARDS;
 AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

5 Be It Enacted by the Legislature of the State of Idaho:

6 SECTION 1. That Section 39-411, Idaho Code, be, and the same is hereby 7 amended to read as follows:

8 39-411. COMPOSITION OF DISTRICT BOARD -- QUALIFICATIONS OF MEMBERS
 9 -- APPOINTMENT AND REMOVAL -- TERMS -- SELECTION OF OFFICERS -- BOARD OF
 10 TRUSTEES OF DISTRICT BOARDS OF HEALTH. (1) For those districts comprised of:

(a) Fewer than eight (8) counties, the district board of health shall
 consist of seven (7) members to be appointed by <u>each of</u> the boards of
 county commissioners within each district acting jointly, and, with
 each board of county commissioners may appoint a <u>appointing at least one</u>
 (1) board member.

(b) Eight (8) counties, the district board of health shall consist of
 not fewer than eight (8) members nor more than nine (9) members, and each
 board of county commissioners may appoint a board member.

(2) Each member of the district board of health shall be a citizen of 19 the United States, a resident of the state of Idaho and the public health 20 district for one (1) year immediately last past, and a qualified elector, 21 22 and, except for a board seat designated for an available physician pursuant to subsection (3) of this section, a currently elected county official from 23 the appointing county pursuant to subsection (1) (a) of this section. One (1) 24 member of the district board, if available to serve, shall be a physician li-25 censed by the Idaho state board of medicine. All members shall be chosen with 26 due regard to their knowledge and interest in public health and in promoting 27 the health of the citizens of the state and the public health district. Rep-28 resentation shall be assured from rural as well as urban population groups. 29

(3) All appointments The appointment of a physician to the district
board shall be confirmed by a majority vote of all the county commissioners
of all the counties located within the public health district. Any member
of the district board may be removed by majority at least two-thirds (2/3)
vote of all the county commissioners of all the counties located within the
district.

(4) The members of the district board of health shall be appointed for a term of five (5) two (2) years, subject to reappointment; and vacancies on the board for an unexpired term shall be filled for the balance of the unexpired term. Notwithstanding any provision of this section as to term of appointment, if a board member is an appointee for a board of county commissioners, and if that board member is an elected county commissioner and leaves office prior to the expiration of the term on the district board of health, the board of county commissioners may declare the position vacant
and may appoint another currently elected county commissioner to fill the
unexpired portion of the term of that board member.

4 (5) The members of the district board, each year, shall select a chair5 man, a vice chairman and a trustee. The trustee shall represent the district
6 board as a member of the board of trustees of the Idaho district boards of
7 health.

(6) The board of trustees of the Idaho district boards of health shall 8 have authority to allocate appropriations from the legislature to the health 9 districts. Such authority is limited to the development and administration 10 of formulas for the allocation of legislative appropriations. Any formula 11 adopted by the board of trustees must be in use, without alteration, for at 12 least two (2) years; provided that during the two (2) year period, the for-13 mula may be changed if an emergency occurs, the emergency is declared and 14 there is a unanimous vote of the board of trustees to make the emergency for-15 16 mula change. All proceedings of the board of trustees shall be subject to the provisions of chapter 2, title 74, Idaho Code. 17

18 SECTION 2. An emergency existing therefor, which emergency is hereby 19 declared to exist, this act shall be in full force and effect on and after 20 July 1, 2025.
