 2 RELATING TO THE APPROPRIATION TO THE STATE BOARD OF EDUCATION AND THE BOARD
 3 OF REGENTS OF THE UNIVERSITY OF IDAHO FOR SPECIAL PROGRAMS; APPROPRIAT-
 4 ING ADDITIONAL MONEYS TO THE STATE BOARD OF EDUCATION AND THE BOARD OF
 5 REGENTS OF THE UNIVERSITY OF IDAHO FOR SPECIAL PROGRAMS FOR FISCAL YEAR
 6 2026; AUTHORIZING ADDITIONAL FULL-TIME EQUIVALENT POSITIONS FOR FISCAL
 7 YEAR 2026; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to any other appropriation provided by law,
 10 there is hereby appropriated to the State Board of Education and the Board
 11 of Regents of the University of Idaho for Special Programs the following
 12 amounts to be expended according to the designated programs and expense
 13 classes from the listed funds for the period July 1, 2025, through June 30,
 14 2026:

6 SECTION 2. FTP AUTHORIZATION. In addition to any other authorization
7 provided by law, the full-time equivalent position authorization provided
8 to the State Board of Education and the Board of Regents of the University
9 of Idaho for Special Programs is hereby increased by twenty-seven hundredths
10 (0.27) for the period July 1, 2025, through June 30, 2026.

11 SECTION 3. An emergency existing therefor, which emergency is hereby
12 declared to exist, this act shall be in full force and effect on and after
13 July 1, 2025.
