- RELATING TO APPLICATIONS FOR DRIVER'S LICENSES; AMENDING SECTION 49-306,
 IDAHO CODE, TO PROVIDE FOR A CERTAIN VOLUNTARY DONATION RELATING TO
 VISION SCREENING AND EYE HEALTH AND TO MAKE A TECHNICAL CORRECTION; AND
 DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.
- 6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section 49-306, Idaho Code, be, and the same is hereby 8 amended to read as follows:

49-306. APPLICATION FOR DRIVER'S LICENSE, INSTRUCTION PERMIT, 9 COMMERCIAL LEARNER'S PERMIT OR RESTRICTED SCHOOL ATTENDANCE DRIVING PER-10 MIT. (1) Every application for any instruction permit, restricted school 11 attendance driving permit, or driver's license shall be made on a form 12 13 furnished by the department and shall be verified by the applicant before a person authorized to administer oaths. Officers and employees of the 14 department, agents authorized by the department, and sheriffs and their 15 deputies are authorized to administer the oaths without charge. 16

17 (2) Every application for a permit, extension, driver's license, or knowledge test shall be accompanied by a nonrefundable fee pursuant to this 18 subsection. Fee portions identified as going to the current expense fund 19 shall be retained by the issuing entity. If the issuing entity is the depart-20 ment or an agent authorized by the department, other than the county, such 21 22 fee portion shall be deposited in the state highway account. All other re-23 maining fee portions shall be remitted to the state treasurer. If the fee is 24 collected by a county, all remaining fee portions shall be paid over to the county treasurer and the county treasurer shall remit such fees to the state 25 treasurer not less than monthly. The state treasurer shall immediately al-26 locate such fees in accordance with the schedule identified following each 27 28 fee:

(3) The fee for any electronic driver's license renewal allowed pur-40 suant to section 49-319(10), Idaho Code, shall be five dollars (\$5.00) less 41 than the applicable application fee prescribed in subsection (2) of this 42 section. This fee reduction shall be accounted for by subtracting five dol-43 lars (\$5.00) from the portion of fees retained by the department. 44 (4) A person who applies for a driver's license or a driver's license 45 renewal may designate a voluntary contribution of two dollars (\$2.00) for 46 47 the pursuant to paragraph (a) or (b) of this subsection or both. Such voluntary contribution may be made for: 48 The purpose of promoting and supporting organ donation. 49 (a) Such a contribution shall be treated as a voluntary contribution to the organ 50

1 donation contribution fund created in section 49-2447, Idaho Code, and 2 not as a driver's license fee. Each voluntary contribution shall be 3 deposited into the organ donation contribution fund created in section 4 49-2447, Idaho Code; and

(b) The purposes of promoting and supporting vision screening, vision 5 treatment, and eye health in Idaho. Such contribution shall be treated 6 as a voluntary contribution to envision sight, an Idaho nonprofit cor-7 poration, and not as a driver's license fee. Such contributions shall 8 be transferred to envision sight, at least monthly, less actual ad-9 ministrative costs associated with collecting and transferring such 10 contributions. Envision sight shall only use funds received pursuant 11 to this paragraph for the purposes expressly provided for in this para-12 graph and shall submit an annual report to the legislature by January 13 15 accounting for funds received in the prior year pursuant to this 14 paragraph and describing how such funds were spent. The report shall be 15 16 submitted to the legislative services office electronically.

(5) Every application shall state the applicant's true and full name, 17 date of birth, sex, declaration of Idaho residency, Idaho residence address 18 and mailing address if different, height, weight, hair color, eye color, and 19 social security number as verified by the social security administration. 20 21 If an applicant has submitted an application pursuant to the provisions of chapter 58, title 19, Idaho Code, then the applicant may state, in his or 22 23 her application pursuant to this section, the applicant's alternative Idaho mailing address in place of his or her Idaho residence address and mail-24 ing address. Notwithstanding the provisions of section 49-303(13), Idaho 25 Code, an applicant for a nondomiciled class A, B or C driver's license or 26 nondomiciled commercial learner's permit having residency in a state that 27 is prohibited from issuing class A, B or C driver's licenses or commercial 28 learner's permits, as provided in 49 CFR 384, is excepted from providing 29 proof of Idaho residency and an Idaho mailing address. 30

(a) The requirement that an applicant provide a social security number
 as verified by the social security administration shall apply only to
 applicants who have been assigned a social security number.

34 (b) An applicant who has not been assigned a social security number35 shall:

36 37 (i) Present written verification from the social security administration that the applicant has not been assigned a social security number; and

(iii) Submit such proof as the department may require that the applicant is lawfully present in the United States.

A driver's license, commercial learner's permit or any instruction
 permit issued on and after January 1, 1993, shall not contain an appli cant's social security number. Applications on file shall be exempt
 from disclosure except as provided in sections 49-202, 49-203, 49-203A
 and 49-204, Idaho Code.

(c) Every application for a class A, B or C license shall state where the applicant has been licensed for the preceding ten (10) years and under which of the following driving categories the applicant will operate:

(i) Non-excepted interstate. The applicant operates or expects to operate in interstate commerce and is required to provide a medical examiner's certificate;

(ii) Excepted interstate. The applicant operates or expects to operate in interstate commerce, but engages exclusively in trans-8 portation or operations excepted by the federal motor carrier 9 safety administration from all or parts of the qualification re-10 quirements of federal motor carrier safety regulation 49, part 11 391, and is therefore not required to provide a medical examiner's 12 certificate; 13

- (iii) Non-excepted intrastate. The applicant operates only in 14 intrastate commerce and is subject to and meets all Idaho driver 15 16 qualification requirements and the applicable parts of federal motor carrier safety regulation 49, part 391, and is required to 17 provide a medical examiner's certificate; or 18
- (iv) Excepted intrastate. The applicant operates in intrastate 19 commerce, but engages exclusively in exempted transportation or 20 operations as listed in section 67-2901B(2), Idaho Code, and the 21 applicable parts of federal motor carrier safety regulation 49, 22 part 391, and is therefore not required to provide a medical exam-23 iner's certificate. 24

All applications shall also state whether the applicant has previously 25 been licensed as a driver and, if so, when and by what state or country 26 and whether a driver's license or privileges have ever been suspended, 27 revoked, denied, disqualified, canceled or refused and, if so, the 28 date of and reason for the suspension, revocation, denial, disquali-29 fication, cancellation or refusal and the applicant's oath that all 30 information is correct as signified by the applicant's signature. 31

(d) The applicant must submit proof of identity and citizenship sta-32 tus acceptable to the examiner or the department and date of birth as 33 set forth in a certified copy of his birth certificate. When a certified 34 copy of his birth certificate or a delayed birth certificate is impossi-35 ble to obtain from a vital statistics agency, another government-issued 36 document may be submitted that provides satisfactory evidence of a per-37 son's full legal name and date of birth acceptable to the examiner or the 38 department. 39

(e) Every applicant for a class A, B or C driver's license or commer-40 cial learner's permit shall provide proof of United States citizenship 41 or lawful permanent residency in the United States upon application for 42 issuance, transfer, upgrade or renewal, unless the applicant's driving 43 record already contains documentation confirming United States citi-44 zenship or lawful permanent residency. Every applicant for a nondomi-45 ciled class A, B or C driver's license or commercial learner's permit 46 47 domiciled in a foreign country must provide an unexpired employment authorization document issued by the department of homeland security or 48 an unexpired foreign passport accompanied by an approved I-94 form doc-49 umenting the applicant's most recent admittance into the United States. 50

(f) Individuals required to register in compliance with section 3 of the federal military selective service act, 50 U.S.C. App. 451 et seq., as amended, shall be provided an opportunity to fulfill such registration requirements in conjunction with an application for a driver's license, commercial learner's permit or instruction permit. Any registration information so supplied shall be transmitted by the department to the selective service system.

6) Whenever an application is received from a person previously licensed in another jurisdiction, the department shall request a copy of the driver's record from the other jurisdiction and shall contact the national driver register. When received, the driver's record from the previous jurisdiction shall become a part of the driver's record in this state with the same force and effect as though entered on the driver's record in this state in the original instance.

(7) Whenever the department receives a request for a driver's recordfrom another licensing jurisdiction, the record shall be forwarded withoutcharge.

(8) The department shall contact and notify the commercial driver li cense information system of the proposed application for a class A, B or C
 driver's license or commercial learner's permit to ensure identification of
 the person and to obtain clearance to issue the license.

(9) The department shall request information from the drug and alcohol clearinghouse to determine whether an applicant for any class A, B, or C
driver's license or commercial learner's permit is eligible for the credential.

(10) A contractor administering a class A, B, or C skills test may collect an additional fee for the use of the contractor's vehicle for the skills
test.

(11) The department may issue seasonal class B or C driver's licenses to
 drivers who are employees of agri-chemical businesses, custom harvesters,
 farm retail outlets and suppliers, and livestock feeders that:

32 (a) Will be valid only for driving commercial vehicles that normally33 require class B or C commercial driver's licenses;

34 (b) Will be valid for seasonal periods that begin on the date of is35 suance and that are not to exceed one hundred eighty (180) days in a
36 twelve (12) month period;

(c) May be obtained only twice in a driver's lifetime;

(d) Are valid only within a one-hundred-fifty (150) mile radius of the
 place of business or farm being serviced; and

40 (e) Will be valid only in conjunction with valid Idaho class D driver's41 licenses.

42 (12) The department may issue seasonal class B or C driver's licenses to43 drivers who:

(a) Have not violated the single license provisions of applicable fed-eral regulations;

46 (b) Have not had any license suspensions, revocations or cancella-47 tions;

(c) Have not had any convictions in any vehicle for any offense listed
 in section 49-335(1) or (2), Idaho Code, or any one (1) serious traffic
 offense;

(d) Have at least one (1) year of driving experience with a class D or
 equivalent license in any type of motor vehicle; and

3 (e) Are at least sixteen (16) years old <u>of age</u>.

SECTION 2. An emergency existing therefor, which emergency is hereby
declared to exist, this act shall be in full force and effect on and after
July 1, 2025.
