This appropriation to the Department of Insurance provides enhancements to the FY 2026 maintenance budget that includes 2.00 FTP and additional personnel costs for a staff actuary and a regulatory compliance specialist; a compensation increase for state fire marshal staff; and replacement items.

FISCAL NOTE

This appropriation provides an additional \$533,400 to the maintenance appropriation provided to the Department of Insurance found in Senate Bill 1109. Table 1 show incremental adjustments to the budget found in this bill, of which the ongoing increase is \$365,200 and the onetime increase is \$168,200. Table 2 shows all the adjustments leading to the FY 2026 Total. The total budget for the Department of Insurance is \$12,093,100.
