FOR THE FEDERAL GRANT FUND; AND DECLARING AN EMERGENCY AND PROVIDING AN
EFFECTIVE DATE.

9 SECTION 1. In addition to any other appropriation provided by law,
10 there is hereby appropriated to the Division of Veterans Services the fol 11 lowing amounts to be expended according to the designated expense classes

SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated 1 2 to the Division of Veterans Services any unexpended and unencumbered balances appropriated or reappropriated to the division from the Federal Grant 3 Fund not to exceed \$111,488,600 for fiscal year 2025, to be used for nonre-4 curring expenditures for the Boise Veterans Home and the Lewiston Veterans 5 Home for the period July 1, 2025, through June 30, 2026. The Office of the 6 State Controller shall confirm the reappropriation amounts, by fund and ex-7 pense class, with the Legislative Services Office prior to processing the 8 reappropriation authorized herein. 9

SECTION 4. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after July 1, 2025.
