SENATE BILL NO. 1137

BY FINANCE COMMITTEE

1 AN ACT  
 2 RELATING TO THE APPROPRIATION TO THE DIVISION OF VETERANS SERVICES; APPRO-  
 3 PRIATING ADDITIONAL MONEYS TO THE DIVISION OF VETERANS SERVICES FOR  
 4 FISCAL YEAR 2026; REDUCING THE APPROPRIATION TO THE DIVISION OF VETER-  
 5 ANS SERVICES FOR FISCAL YEAR 2026; PROVIDING REAPPROPRIATION AUTHORITY  
 6 FOR THE FEDERAL GRANT FUND; AND DECLARING AN EMERGENCY AND PROVIDING AN  
 7 EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to any other appropriation provided by law,  
 10 there is hereby appropriated to the Division of Veterans Services the fol-  
 11 lowing amounts to be expended according to the designated expense classes  
 12 from the listed funds for the period July 1, 2025, through June 30, 2026:

26 SECTION 2. Notwithstanding any other appropriation provided by law to  
 27 the contrary, the appropriation made to the Division of Veterans Services is  
 28 hereby reduced by the following amounts in operating expenditures from the  
 29 listed funds for the period July 1, 2025, through June 30, 2026:

1           SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
2 to the Division of Veterans Services any unexpended and unencumbered bal-  
3 ances appropriated or reappropriated to the division from the Federal Grant  
4 Fund not to exceed \$111,488,600 for fiscal year 2025, to be used for nonre-  
5 ccurring expenditures for the Boise Veterans Home and the Lewiston Veterans  
6 Home for the period July 1, 2025, through June 30, 2026. The Office of the  
7 State Controller shall confirm the reappropriation amounts, by fund and ex-  
8 pense class, with the Legislative Services Office prior to processing the  
9 reappropriation authorized herein.

10           SECTION 4. An emergency existing therefor, which emergency is hereby  
11 declared to exist, this act shall be in full force and effect on and after  
12 July 1, 2025.
