Principal Research Analyst / Team Lead

<u>RESPONSIBILITIES</u>: Provide professional, independent, **non-partisan** research support to the Idaho Legislature regarding impacts, efficiencies, or cost-benefits of various policy decisions.

- The incumbent will lead an independent research team to research various state agency programs for accountability and value to the State of Idaho.
- The incumbent will provide expertise to the Legislature through written reports and publications, memoranda, briefs, electronic presentations, dashboards, and oral testimony before committees. Projects and work products will range from single item requests with quick completions to longer more in-depth projects and reviews.
- The Idaho Legislature meets from January through March each year, but also has numerous interim meetings, activities, and research projects throughout the year.
- Some statewide travel may be required to attend interim meetings or state agency board and commission meetings.

MINIMUM QUALIFICATIONS:

- A graduate degree, Juris Doctorate, or Ph.D. from an accredited college or university AND three years of experience in state or local government budgeting, finance, public policy, economics, or evaluation. Experience in a related field may substitute for education.
- Excellent interpersonal communication skills, team and project management experience, and the ability to train and coach other analysts as needed to strengthen their skills. The ability to manage and resolve conflicts in a positive and constructive manner.
