Boise State University

Boise State University offers a high-quality undergraduate education and a graduate school that cultivates the personal and career growth of its students. Within seven academic colleges, the University offers an array of degree programs including business, engineering, healthcare, education and public service, that foster student success, lifelong learning, community engagement, innovation and creativity.

- Boise State has balanced its budget by eliminating a \$15M structural deficit.
- •For every \$1 spent on instruction, Boise State spends only \$0.18 on administration the lowest of any university in Idaho. howcollegesspendmoney.com
- •Boise State's 4-year graduation rate has increased by 39% over the last 5 years and 71% of its bachelor's degree graduates stay and work in Idaho. *EMSI/Lightcast Economic Impact Study*
- •The average annual rate of return on our students' investment in their degree is 15.9%, a higher rate of return than the 30-year stock market average annual return rate of 10.6%. EMSI/Lightcast Economic Impact Study

FY 2023 Appropriation vs. Actual Expenditures

Personnel Costs (PC) – FY23 to FY24 (\$23,228,000) reappropriation in Dedicated funds; transfer of HERC General funds \$1,779,000; move HESF (\$3,186,400) appropriation from PC to OE and CO.

Operating Expense (OE) – FY23 to FY24 (\$61,635,600) reappropriation in Dedicated funds; move HESF \$2,800,000 appropriation from PC to OE; Return of systemwide General funds \$119,100.

Capital Outlay (CO) – FY23 to FY24 (\$1,938,900) reappropriation in Dedicated funds; move HESF \$386,400 appropriation from PC to CO

Line Item Brief Name	Amount	Status Update
Health Sciences Program support	\$1,530,000	\$1.1M was invested in the College of Health Sciences for new and existing faculty and graduate assistants in nursing, respiratory, public health and kinesiology programs. This investment allows for a 33% increase in the cohort size at the School of Nursing. The remaining funding has been allocated to the in-demand public health program.
Chief Audit Executive Risk Manager	\$(68,400) \$(59,900)	Position transfers have been completed.
Personnel Costs fund shift	(\$5,249,000)	Fund shift from Dedicated to General Fund in Personnel Costs

Personnel Costs Fund Shift, CEC	\$3,619,500	Fund shift from Dedicated to General Fund with adjustment to reduce the appropriation to support a 5% CEC
Higher Education Strategic Fund for academic support	\$4,000,000	Funding new data-driven electronic academic advising infrastructure

Line Item Brief Name	Amount	Status Update
Audit Staff Transfer	\$(423,200)	Transfer of audit positions from BSU to the Office of the State Board of Education in a budget-neutral transfer.
Operational Capacity Enhancement	\$2,136,600	Boise State used this funding to offset negative EWA and partially fund CEC.
DHR Consolidation	\$46,800	DHR Consolidation was a Governor's initiative. Increase in General Fund and Dedicated spending authority was provided to cover the increases in DHR fees to BSU due to DHR consolidation.
