General Fund Budget Monitor – December 2022

The Division of Financial Management published the FY 2023 revised revenue forecast on Monday January 9. The final published revision for the year reflects a 5.3% decrease from FY 2022, or \$5.87 billion, as found on line 4 in the table below. This is a downward revision from the August forecast which was a 1.9% decrease from FY22 or \$6.01 billion. Compared to the DFM forecast, General Fund revenue collections are \$36.1 million below expectations. For the month of December, General Fund revenue collections totaled \$543.4 million, which brings total FY 2023 collections to \$2.69 billion. The cumulative amount is \$127.5 million or 5.0% more than at this point last fiscal year (see page 2 lines 15-16). By tax category, individual income tax collections are down \$80.6 million because refunds are \$111.5 million higher than this time last year. Conversely, corporate income tax collections are up \$110.8 million, sales tax collections are up \$105.2 million, miscellaneous revenues are up \$2.1 million, and product taxes are \$9.5 million behind.

This month's budget monitor is projecting a smaller ending balance than last month's because of two factors: 1) the revenue forecast was revised down; and 2) corporate income tax collections came in below forecast expectations by \$29.0 million. Additionally, statutory transfers were revised by \$94 million (line 8) and the beginning cash balance was adjusted to reflect a correction with the after year end reversion from Health and Welfare. With these adjustments, coupled with revenue collections running \$36.1 million behind projections (line 5), and assuming the rest of the revenue forecast comes in as predicted, total revenues available for FY 2023 are \$6.04 billion (line 9). Using the budget that was set last March as found on lines 10 and 11, the projected ending balance is \$1.33 billion (line 13). 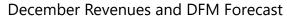

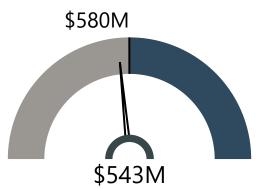
