General Fund Budget Monitor – January 2023

For the month of January, General Fund revenue collections were \$624.8 million, bringing total FY 2023 collections to \$3.32 billion. Total collections are \$99.9 million or 1.6% more than at this point last fiscal year. January collections were \$9.2 million more than the Division of Financial Management (DFM) revenue forecast anticipated for the month. However, General Fund collections are \$26.9 million below the DFM revenue forecast (line 5). For information about the revenue forecast, please visit the January report here: https://dfm.idaho.gov/

By category, individual income tax collections are below last year by \$82.9 million because refunds are \$117.8 million higher than this time last year. Conversely, corporate income tax collections are up \$78.9 million, sales tax collections are up \$111.5 million, miscellaneous revenues are up \$3.1 million, and product taxes are \$10.8 million behind as found on page 2 line 24.

Compared to last month, this month's budget monitor is projecting a slightly larger ending balance by \$9.2 million. Assuming the rest of the revenue forecast comes in as predicted, net revenues available for FY 2023 are \$6.05 billion (line 9). Using the original appropriation (line 10) and the authorized reappropriation and executive carry forward (line 11), the projected ending balance is \$1.34 billion (line 13). 




