Legislative History Online Guide

Many legislative history materials, such as session laws, bill texts, statements of purpose, committee minutes, and journals, are available on the Legislature's website for legislation from 1998 to Present. Legislative histories can be helpful when trying to understand when a statute was enacted or when a specific change in statute occurred, what the discussion was around the change, as well as providing additional context for the legislation.

STEP 1: LOCATE THE STATUTE

Go to <u>www.legislature.idaho.gov</u>, click on "Laws and Rules" and then "Idaho Statutes." Navigate through the Titles, Chapters, and Subsections until you find the statute that you need a legislative history for.





STEP 2: READ THE HISTORY LINE

The history line for each statute shows when the statute was added under the current numbering system (it may not show the statute's entire history if it was recodified), as well as each year it has been amended and the chapter number, section number, and page number where the change in statute can be found in that year's Session Laws. Take note of each year, chapter, and section of the statute iterations you are interested in.

STEP 3: FIND THE CHAPTER IN SESSION LAWS

Return to the Legislature homepage, click on "Laws and Rules" and then "Session Laws." Scroll down to find the year from the statute's history line and click on the volume linked. If there are multiple volumes listed, select the volume that includes the history line's chapter number in the range.

You can then search the document for the chapter number (e.g., "c. 52" or "CHAPTER 52") using Ctrl + F, Adobe's search function, or by scrolling to the page number indicated in the history line. After locating the chapter, the associated bill number will be listed below the chapter heading.

STEP 4: FIND BILL INFORMATION

Return to the Legislature homepage and click on "Legislative Sessions." Use the dropdown to change the year to the session year from the statute's history line.

The bill pages may have a slightly different format depending on the year. Click on any hyperlinks to open PDFs available for the bill and click "Print Friendly" to save or print the bill status.

The official bill actions are located in the final journal, which are maintained by the offices of the Secretary of the Senate and the Chief Clerk of the House. The daily journals are published at the end of each legislative day.

STEP 5: FIND COMMITTEE MINUTES

Return to the main Legislative Session page from Step 4 and click on "Committee Minutes." If you already know the dates that the bill was discussed in committees, select the appropriate House and/or Senate Committees from the list. To find when a bill was discussed, click on the "Committee Minutes Index" tab of the Committee Minutes page.

Scroll down to find the bill number and click on each hyperlinked date provided for the bill. The link will open the committee minutes document for the date clicked. Note: the RS (in this case RS18337) is helpful in locating the earliest discussion of a bill, before it has been assigned its bill number. In this example Senate Bill 1043 has a related trailer bill, House Bill 265. Sometimes it is helpful to review any committee discussions on related bills as well. You can follow the same process to locate the related bill's bill information and committee minutes.

STEP 6: FIND HOUSE AND SENATE JOURNALS

Return to the main Legislative Session page from Step 4 and click on "House and Senate Journals." Open the PDF of one of the journals and scroll to the journal's index near the end. Find the bill number you are looking for and take note of the page numbers listed. The pages can be navigated to by scrolling, using Adobe's page number feature, or by using Ctrl + F and the bill number (e.g., "1043" and "S 1043") to find each time the bill is mentioned. Note: depending on the journal, the PDF page number may not match up with the journal's actual page number. Always verify the page number in the top right corner of the PDF viewer to verify that you are looking at the correct page.
