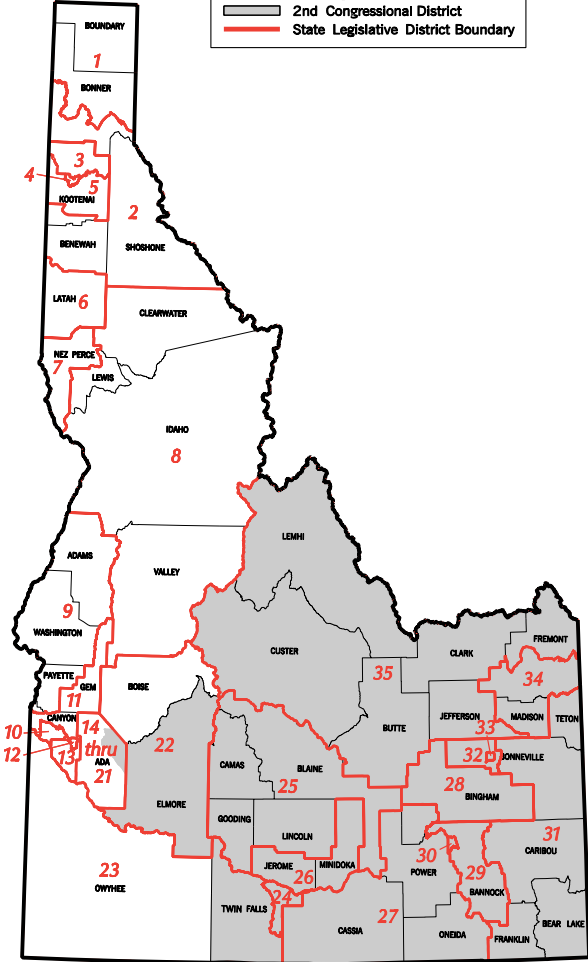

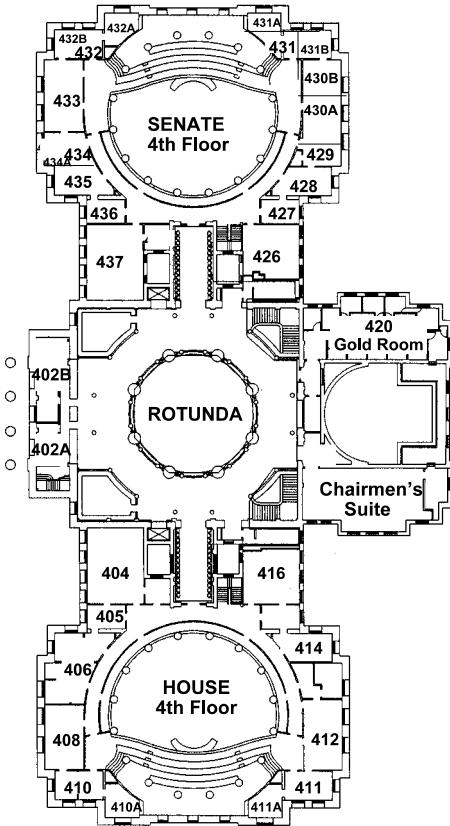

The Legislative Council oversees the management responsibilities of the Legislature. The Council consists of the President Pro Tempore of the Senate, the Speaker of the House of Representatives, the majority and minority leaders of both houses, and four senators and four representatives.
