(Docket No. 41-0403-0901) (Proposed Chapter Repeal)

By these proposed rule dockets (Docket Nos. 41-0402-0901 and 41-0403-0901), Public Health District No. 4 seeks to repeal IDAPA chapters 41.04.02 (Rules for Community Subsurface Sewage Disposal Systems) and 41.04.03 (Rules for On-Site Sewage Treatment Systems) (hereinafter collectively "proposed chapter repeals). Public Health District No. 4 (hereinafter "District") bases its authority to repeal this rule chapter on section 39-416(1), Idaho Code, which allows a public health district board to adopt, amend or rescind rules and standards as it deems necessary to carry out the purposes and provisions of the Public Health Districts Act, codified at chapter 4, title 39, Idaho Code (hereinafter "Act"). Section 39-414(2), Idaho Code, grants public health districts the power to do all things required for the preservation and protection of the public health and such other things delegated by the Director of the Department of Health and Welfare or the Director of the Department of Environmental Quality.

According to the District, no fee or charge is imposed by the proposed rule. The District states that there is no anticipated impact to the general fund greater than \$10,000 during the fiscal year as a result of the proposed rule. The District states that public hearings will be held if requested in writing by 25 persons, a political subdivision or an agency not later than September 16, 2009. The District states that all written comments must be delivered to the District on or before September 24, 2009. No negotiated rulemaking was conducted because the nature of the rulemaking is to repeal these chapters.

ANALYSIS

The District states that the proposed chapter repeals apply only to the District and that IDAPA 58.01.03, Individual/Subsurface Sewage Disposal Rules, promulgated by the Department of Environmental Quality (DEQ) and applicable to their entire state, promote more consistent and effective statewide regulation of subsurface sewage disposal. According to the District, the seven public health districts have been delegated certain responsibilities for regulation of subsurface sewage disposal pursuant to IDAPA 58.01.03 by the Director of DEQ.

SUMMARY

The District has the authority under section 39-416(1), Idaho Code, to repeal chapters 41.04.02 and 41.04.03. Pursuant to section 39-414(2), Idaho Code, the public health districts are empowered to do such other things as delegated by the Director of DEQ.
