HOUSE BILL NO. 176

AN ACT

1 RELATING TO COUNTY CORONERS; AMENDING SECTION 34-622, IDAHO CODE,
 2 TO REQUIRE NEWLY ELECTED OR APPOINTED COUNTY CORONERS WITHIN
 3 ONE YEAR OF TAKING OFFICE TO ATTEND A CORONER’S SCHOOL EITHER
 4 SPONSORED OR ENDORSED BY THE IDAHO STATE ASSOCIATION OF COUNTY
 5 CORONERS; AND AMENDING CHAPTER 28, TITLE 31, IDAHO CODE, BY
 6 THE ADDITION OF A NEW SECTION 31-2810, IDAHO CODE, TO PROVIDE
 7 CONTINUING EDUCATION REQUIREMENTS FOR COUNTY CORONERS.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. That Section 34-622, Idaho Code, be, and the same is hereby amended to
 11 read as follows:

12 34-622. ELECTION OF COUNTY CORONERS – QUALIFICATIONS. (1) At the
 13 general election, 1986, and every four (4) years thereafter, a coroner shall be elected in every
 14 county.

15 (2) No person shall be elected to the office of coroner unless he has attained the age of
 16 twenty-one (21) years at the time of his election, is a citizen of the United States and shall have
 17 resided within the county one (1) year next preceding his election.

18 (3) Each candidate shall file his declaration of candidacy with the county clerk.

19 (4) Each candidate who files a declaration of candidacy shall at the same time pay a
 20 filing fee of forty dollars (\$40.00) which shall be deposited in the county treasury.

21 (5) All newly elected or appointed county coroners shall attend a coroner’s school within
 22 one (1) year of taking office. Such school shall be sponsored or endorsed by the Idaho state
 23 association of county coroners.

24 SECTION 2. That Chapter 28, Title 31, Idaho Code, be, and the same is hereby amended
 25 by the addition thereto of a NEW SECTION, to be known and designated as Section 31-2810,
 26 Idaho Code, and to read as follows:

27 31-2810. CONTINUING EDUCATION REQUIREMENTS. After January 1, 2010,
 28 each county coroner shall complete twenty-four (24) hours of continuing education on a
 29 biannual calendar basis. The Idaho state association of county coroners shall either sponsor or
 30 provide courses pursuant to this section and monitor this requirement.
