RELATING TO MOTOR VEHICLES; AMENDING SECTION 49-432, IDAHO CODE, TO REVISE SPECIFIED PERMIT FEES, TO DELETE REFERENCE TO CERTAIN PERMIT FEES, TO PROVIDE CERTAIN PERMIT FEES, TO PROVIDE CODE REFERENCES AND TO PROVIDE A CORRECT CODE REFERENCE; AMENDING SECTION 49-434, IDAHO CODE, TO DELETE REFERENCE TO CERTAIN REGISTRATION FEES, TO PROVIDE CERTAIN REGISTRATION FEES, TO PROVIDE FOR DEPOSIT OF MONEYS, TO PROVIDE CORRECT CODE REFERENCES, TO REVISE CERTAIN REGISTRATION AND ADMINISTRATIVE FEES, TO PROVIDE EFFECTIVE DATES, TO PROVIDE OPTIONS TO CERTAIN ANNUAL REGISTRATIONS, TO SPECIFY PROCESS PROVISIONS, TO PROVIDE FOR ADMINISTRATIVE FEES, TO DELETE REFERENCE TO PROVISIONS RELATING TO REGISTRATION FEES FOR SPECIFIED COMMERCIAL AND FARM VEHICLES, TO PROVIDE FOR REGISTRATION FEES FOR SPECIFIED COMMERCIAL AND FARM VEHICLES, TO REVISE FEE PROVISIONS RELATING TO SPECIFIED COMMERCIAL AND FARM VEHICLES AND TO DELETE REFERENCE TO CERTAIN USE FEES; AMENDING SECTION 49-435, IDAHO CODE, TO REVISE AN IDENTIFICATION CHARGE; AMENDING CHAPTER 7, TITLE 40, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 40-701A, IDAHO CODE, TO PROVIDE FOR THE HIGHWAY MAINTENANCE, PRESERVATION AND RESTORATION FUND, TO PROVIDE FOR MONEYS DEPOSITED INTO THE FUND, TO PROVIDE FOR INTEREST, TO PROVIDE FOR APPORTIONMENT OF FUND MONEYS, TO PROVIDE FOR CONTINUOUS APPROPRIATION AND TO PROVIDE FOR EXPENDITURES; AND PROVIDING EFFECTIVE DATES.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 49-432, Idaho Code, be, and the same is hereby amended to read as follows:

49-432. TEMPORARY REGISTRATION FOR RESIDENTS AND NONRESIDENTS – FEES. (1) When a vehicle or combination of vehicles subject to registration is to be moved upon the public highways in the state of Idaho, the department may issue a permit in lieu of registration for any vehicle or combination of vehicles upon the payment of a fee as set forth in the following schedule:

- (a) One hundred twenty (120) hour permit
  - Single vehicle ..... \$~~603~~.00
  - Combination of vehicles ..... \$~~1206~~.00
- (b) Fuel permit ..... \$~~603~~.00
- (c) Thirty (30) day unladen weight permit ..... \$~~603~~.00



1 available only to a vehicle which is currently and validly registered in Idaho pursuant to section  
2 49-432(1), 49-434(1), 49-434(8)(c) or 49-435, Idaho Code.

3 (5) The department may select vendors to serve as agents on state highways for the  
4 purpose of selling permits where fixed ports of entry do not adequately serve a respective  
5 highway entering the state. The vendor shall be remunerated at the rate of three dollars (\$3.00)  
6 per permit sold, and he shall collect the fees specified in this section, and pay the fees to the  
7 department. The vendor shall guarantee payment by giving a bond to the state in a sum as shall  
8 be fixed by the board, the premium on the bond to be paid by the department.

9 SECTION 2. That Section 49-434, Idaho Code, be, and the same is hereby amended to  
10 read as follows:

11 49-434. OPERATING FEES.

12 (1) (a) There shall be paid on all commercial vehicles, noncommercial vehicles, and  
13 on all farm vehicles having a maximum gross weight not in excess of sixty thousand  
14 (60,000) pounds, an annual registration fee in accordance with the following schedule.

35 (b) Beginning on February 1, 2010, nineteen percent (19%) of the moneys from the fees  
36 assessed pursuant to this subsection (1), shall be deposited into the highway maintenance,  
37 preservation and restoration fund as established in section 40-701A, Idaho Code.

38 (2) There shall be paid on all commercial vehicles, irrespective of body type, and on all  
39 farm vehicles having a maximum gross weight in excess of sixty thousand (60,000) pounds, an  
40 annual registration fee in the amount prescribed by subsection (8) of this section, as applicable.

41 (3) In addition, the annual registration fee for trailers shall be:

- 1 (a) Trailer or semitrailer in a combination of vehicles ..... \$~~1522.05~~0
- 2 (b) Rental utility trailer with a gross weight of two thousand (2,000) pounds or less .....
- 3 ..... \$~~812.00~~00
- 4 (c) Rental utility trailer with a gross weight over two thousand (2,000) pounds .....
- 5 ..... \$~~1522.05~~0

6 (4) As an option to the trailer and semitrailer and rental utility trailer annual registrations  
 7 issued pursuant to subsection (3) of this section, the department may provide a nonexpiring  
 8 registration for trailers and semitrailers, and an optional, extended registration for rental utility  
 9 trailers.

10 (a) For trailers and semitrailers, the nonexpiring registration fee shall be one hundred ~~five~~  
 11 fifty-seven dollars and fifty cents (\$~~1057.50~~.50). The license plate originally issued shall  
 12 remain on the trailer or semitrailer until the registration is canceled. If the registrant  
 13 does not transfer the plate and registration to another trailer or semitrailer titled to the  
 14 registrant, the plate and registration shall be canceled and no part of the fee is subject  
 15 to refund. Provided however, the registrant may transfer the nonexpiring plate and  
 16 registration to another trailer or semitrailer titled to the registrant. The registration  
 17 document shall be the official record of the status of the nonexpiring registration. No  
 18 pressure-sensitive validation sticker shall be required or issued for such nonexpiring  
 19 license plate.

20 (b) For rental utility trailers, the registrant may prepay the annual registration for  
 21 an additional one (1), two (2), three (3) or four (4) years, but in no event shall the  
 22 optional registration period extend beyond five (5) years. The fee shall be as specified  
 23 in subsection (3)(b) or (c) of this section. A pressure-sensitive sticker shall be used to  
 24 validate the license plate. The license plate shall become void if the owner's interest in  
 25 the rental utility trailer changes during the five (5) year period. If the owner fails to enter  
 26 the rental utility trailer on the annual renewal application during the five (5) year period,  
 27 the registration record shall be purged. Any unrenewed plate shall be returned to the  
 28 department if it is not entered on the renewal application.

29 (5) A fleet registration option is available to owners who have twenty-five (25) or more  
 30 commercial or farm vehicles or any combination thereof. Such owners may register all of  
 31 their company vehicles with the department in lieu of registering with a county assessor. To  
 32 qualify the fleet must be owned and operated under the unified control of one (1) person  
 33 and the vehicles must be physically garaged and maintained in two (2) or more counties.  
 34 Fleet registration shall not include fleets of rental vehicles. The department shall provide  
 35 a registration application to the owner and the owner shall provide all information that the  
 36 department determines is necessary. The department shall devise a special license plate  
 37 numbering system for fleet-registered vehicles as an alternative to county license plates. The  
 38 fleet registration application and all subsequent registration renewals shall include the physical  
 39 address where a vehicle is principally used, garaged and maintained. The fleet owner shall  
 40 report the physical address to the department upon initial registration, on each renewal, and at  
 41 any time a vehicle registered under this option is permanently transferred to another location.

42 (6) If the ownership of a vehicle changes during the registration period, the original  
 43 owner may transfer the plate to another vehicle. The remaining fee shall be credited against the  
 44 cost of the new registration. Refunds may be given for any unexpired portion of the vehicle  
 45 registration fee if the plate is not transferred by the owner to another vehicle. Any request for  
 46 refund shall include surrender of the license plate, validation sticker and registration document.

1 Owners of vehicles registered under the international registration plan may request a refund  
 2 of the unexpired portion of the Idaho vehicle registration fee by presenting evidence from the  
 3 base jurisdiction that the license plate, validation sticker and registration document have been  
 4 surrendered. A license plate shall not be transferred to another owner when the ownership of a  
 5 vehicle changes. The owner shall obtain a replacement plate, validation sticker if required, and  
 6 a registration document when a plate is lost, destroyed or becomes illegible.

7 (7) An administrative fee of ~~four~~ six dollars (\$~~4~~6.00) shall be paid and deposited to the  
 8 state highway account on all registrations completed by the department under subsection (1) or  
 9 (8)(a) of this section. Vehicles registered under subsection (8)(b) of this section shall pay the  
 10 fee provided in section 49-435(2), Idaho Code.

11 (8) There shall be paid on all commercial and farm vehicles having a maximum gross  
 12 weight in excess of sixty thousand (60,000) pounds, a registration fee based upon the maximum  
 13 gross weight of a vehicle as declared by the owner and the total number of miles driven  
 14 on roads and highways in the state, county, city and highway district systems in Idaho, and  
 15 if registered under the international registration plan (IRP), in all other jurisdictions. The  
 16 appropriate registration fee shall be determined as follows:

17 (a) If the owner registers vehicles under the international registration plan (IRP), the  
 18 appropriate mileage column shall be determined by the total miles an owner operated a  
 19 fleet of vehicles on roads and highways in the state, county, city and highway district  
 20 systems in Idaho and in all other jurisdictions in the preceding year, as defined in section  
 21 49-117, Idaho Code, and by the maximum gross weight of each vehicle within a fleet.

22 (b) If the owner registers vehicles under the international registration plan and determines  
 23 that the average international registration plan fleet miles, calculated by dividing the total  
 24 IRP fleet miles in all jurisdictions by the number of registered vehicles, is less than fifty  
 25 thousand one (50,001) miles, the owner may apply to the department for refund of a  
 26 portion of the registration fees paid, consistent with the fee schedules set forth in this  
 27 section. The department shall provide an application for the refund. An owner making  
 28 application for refund under this section shall be subject to auditing as provided in section  
 29 49-439, Idaho Code.

30 (c) If the owner is not registering vehicles under the international registration plan, the  
 31 appropriate mileage column shall be determined by the total miles the owner operated  
 32 each of the vehicles to be registered on roads and highways in the state, county, city  
 33 and highway district systems in Idaho in the preceding year and by the maximum gross  
 34 weight of each vehicle.

1 by the Idaho transportation department in accordance with the provisions of subsection

3 (3) Moneys in the highway maintenance, preservation and restoration fund as provided  
4 in subsection (2)(b) of this section are hereby continuously appropriated to the Idaho  
5 transportation department. Expenditures of moneys from the fund by the department shall be  
6 made only for the maintenance, preservation and restoration of the state highway system. In  
7 no event shall expenditures be made from this dedicated fund for capacity expansion projects.  
8 Provided however, that no moneys shall be expended from such fund unless and until the  
9 department has made plans for and begun implementation of a statewide pavement management  
10 system or similar management tool that is efficient, effective and widely accepted in the trade  
11 or practice for coordinating a statewide system for the management of pavement maintenance.

12 SECTION 5. Section 3 of this act shall be in full force and effect on and after July 1,  
13 2009; the remaining sections of this act shall be in full force and effect on and after July 1,  
14 2010.
