HOUSE CONCURRENT RESOLUTION NO. 3

BY JUDICIARY, RULES AND ADMINISTRATION COMMITTEE

1 A CONCURRENT RESOLUTION
 2 PROVIDING FOR PRINTING THE HOUSE AND SENATE PERMANENT JOURNALS
 3 AND FIXING THE PRICE FOR PRINTING THE SAME.

4 Be It Resolved by the Legislature of the State of Idaho:

5 WHEREAS, Section 67-509, Idaho Code, has made provisions for the printing of the
 6 House and Senate Permanent Journals;

7 NOW, THEREFORE, BE IT RESOLVED by the members of the First Regular Session of
 8 the Sixtieth Idaho Legislature, the House of Representatives and the Senate concurring therein,
 9 in accordance with a written contract duly made and entered into by the Speaker of the House
 10 of Representatives, the President Pro Tempore of the Senate, the House Judiciary, Rules, and
 11 Administration Committee, and the Senate Judiciary and Rules Committee of the Legislature of
 12 the State of Idaho, hereinafter referred to as the Joint Printing Committee, that the contract for
 13 the printing of the House and Senate Permanent Journals in accordance with the provisions of
 14 law and in accordance with the written contract between the Speaker of the House of Represen-
 15 tatives, the President Pro Tempore of the Senate, and the Joint Printing Committee, as party of
 16 the first part, and CUSTOM PRINTING, INC., Nampa, Idaho, as party of the second part, be,
 17 and the same is hereby ratified and confirmed, and is incorporated herein and made a part of the
 18 resolution, in words and figures following, to wit:

19 PRINTING AGREEMENT

20 THIS AGREEMENT, made and entered into the 15th day of January, 2009, by and be-
 21 tween the Speaker of the House of Representatives, the President Pro Tempore of the Senate,
 22 and the Joint Printing Committee of the First Regular Session of the Sixtieth Idaho Legisla-
 23 ture, hereinafter referred to as party of the first part, and CUSTOM PRINTING, INC., Nampa,
 24 Idaho, hereinafter referred to as party of the second part:

25 WITNESSETH:

26 That pursuant to a resolution of said party of the first part and written quotation submitted
 27 to the said party of the first part by the party of the second part, a contract for legislative
 28 printing is hereby awarded to the said CUSTOM PRINTING, INC. as follows:

29 HOUSE AND SENATE PERMANENT JOURNALS
 30 FIRST AND SECOND REGULAR SESSIONS
 31 AND ANY EXTRAORDINARY SESSIONS
 32 SIXTIETH LEGISLATURE

33 As outlined in the November 11, 2008 quote of the party of the second part, the House
 34 and Senate Permanent Journals will be printed and charged at a price per page of thirty-two
 35 dollars (\$32.00) not to exceed one hundred and fifty (150) copies of the House Permanent Jour-
 36 nal and one hundred and fifty (150) copies of the Senate Permanent Journal. The number of
 37 copies to be supplied under this contract shall be specified at the time of order. Included in
 38 the price, the party of the second part will print and bind six (6) hard-bound gold lettered vol-

1 umes for the House and seven (7) hard-bound gold lettered volumes for the Senate. Additional
2 hard-bound gold lettered volumes can be ordered at an additional sixty dollars (\$60.00) per vol-
3 ume.

4 IT IS AGREED between the parties hereto that all of said printing shall be done in the
5 form and manner as included in the bid specifications, in compliance with the statutes of the
6 state of Idaho where not otherwise provided, such statutes shall be controlling. Upon failure
7 to deliver such House and Senate Permanent Journals in the manner and within the time herein
8 specified, this contract may be deemed terminated forthwith at the option of the party of the
9 first part and recourse had against the bond of the party of the second part.

10 IT IS FURTHER AGREED that said House and Senate Permanent Journals shall be
11 printed, delivered and be ready for distribution in conformity with the provisions of Section
12 67-509, Idaho Code, which section is hereby referred to and by such reference made a part of
13 this contract as though set forth herein at length.

14 IN WITNESS WHEREOF, the party of the second part has caused these presents to be
15 executed by its proper official, and the party of the first part, by Concurrent Resolution, has
16 caused these presents to be executed by its proper officials.
