2 PROVIDING FOR PRINTING OF HOUSE AND SENATE BILLS, RESOLUTIONS, MEMO-  
3                                   RIALS AND AMENDMENTS, AND FIXING THE PRICE FOR PRINTING THE  
4                                   SAME.

5 Be It Resolved by the Legislature of the State of Idaho:

6           WHEREAS, the House Judiciary, Rules, and Administration Committee and the Senate  
7 Judiciary and Rules Committee have, according to law, made provisions for the printing of the  
8 House and Senate bills, resolutions, memorials and amendments;

9           NOW, THEREFORE, BE IT RESOLVED by the members of the First Regular Session of  
10 the Sixtieth Idaho Legislature, the House of Representatives and the Senate concurring therein,  
11 in accordance with a written contract duly made and entered into by the Speaker of the House  
12 of Representatives, the President Pro Tempore of the Senate, the House Judiciary, Rules, and  
13 Administration Committee, and the Senate Judiciary and Rules Committee of the Legislature  
14 of the State of Idaho, hereinafter referred to as the Joint Printing Committee, that the con-  
15 tract for the printing of the House and Senate bills, resolutions, memorials and amendments,  
16 in accordance with the provisions of law and in accordance with the written contract between  
17 the Speaker of the House of Representatives, the President Pro Tempore of the Senate, and  
18 the Joint Printing Committee, as party of the first part, and the BUREAU OF COPY AND  
19 RECORDS SERVICES, Boise, Idaho, as party of the second part, be, and the same is hereby  
20 ratified and confirmed, and is incorporated herein and made a part of the resolution, in words  
21 and figures following, to wit:

22                                   PRINTING AGREEMENT

23           THIS AGREEMENT, made and entered into the 15th day of January, 2009, by and be-  
24 tween the Speaker of the House of Representatives, the President Pro Tempore of the Senate,  
25 and the Joint Printing Committee of the First Regular Session of the Sixtieth Idaho Legislature,  
26 hereinafter referred to as party of the first part, and, the BUREAU OF COPY AND RECORDS  
27 SERVICES, Boise, Idaho, hereinafter referred to as party of the second part:

28                                   WITNESSETH:

29           That pursuant to a resolution of said party of the first part and written quotation submitted  
30 to the said party of the first part by the party of the second part, a contract for legislative  
31 printing is hereby awarded to the said BUREAU OF COPY AND RECORDS SERVICES as  
32 follows:

33           HOUSE AND SENATE BILLS, RESOLUTIONS, MEMORIALS AND AMENDMENTS  
34                                   FIRST AND SECOND REGULAR SESSIONS  
35                                   AND ANY EXTRAORDINARY SESSIONS  
36                                   SIXTIETH LEGISLATURE

37           As outlined in the November 18, 2008 quote of the party of the second part, the House  
38 and Senate bills, resolutions, memorials and amendments will be printed and charged at a price

1 per page not to exceed eight dollars and fifty cents (\$8.50) based on incremental numbers of  
2 copies ordered. The number of copies to be supplied under this contract shall be specified at  
3 the time of order, and may be adjusted as required by the party of the first part.

4 IT IS AGREED between the parties hereto that all of said printing shall be done in the  
5 form and manner as included in the bid specifications, in compliance with the statutes of the  
6 state of Idaho where not otherwise provided, such statutes shall be controlling. Upon failure to  
7 deliver such bills, resolutions, memorials and amendments in the manner and within the time  
8 herein specified, this contract may be deemed terminated forthwith at the option of the party of  
9 the first part and recourse had against the bond of the party of the second part.

10 IN WITNESS WHEREOF, the party of the second part has caused these presents to be  
11 executed by its proper official, and the party of the first part, by Concurrent Resolution, has  
12 caused these presents to be executed by its proper officials.
