AN ACT

1 RELATING TO ASSAULT AND BATTERY; AMENDING SECTION 18-915, IDAHO CODE,
2 TO REVISE PROVISIONS RELATING TO ASSAULT OR BATTERY UPON CERTAIN
3 PERSONNEL.

5 Be It Enacted by the Legislature of the State of Idaho:

6 SECTION 1. That Section 18-915, Idaho Code, be, and the same is hereby
7 amended to read as follows:

8 18-915. ASSAULT OR BATTERY UPON CERTAIN PERSONNEL -- PUNISHMENT. (1)
9 Any person who commits a crime provided for in this chapter against or upon
10 a justice, judge, magistrate, prosecuting attorney, public defender, peace
11 officer, bailiff, marshal, sheriff, police officer, ~~correctional officer,~~
12 ~~employee of the department of correction, employee of a private prison~~
13 ~~contractor while employed at a private correctional facility in the state~~
14 ~~of Idaho, employees of the department of water resources authorized to~~
15 ~~enforce the provisions of chapter 38, title 42, Idaho Code, jailer, parole~~
16 ~~officer, misdemeanor probation officer, officer of the Idaho state police,~~
17 ~~fireman, social caseworkers or social work specialists of the department~~
18 ~~of health and welfare, employee of a state secure confinement facility~~
19 ~~for juveniles, employee of a juvenile detention facility, a teacher at~~
20 ~~a detention facility or a juvenile probation officer, emergency medical~~
21 ~~technician certified by the department of health and welfare, emergency~~
22 ~~medical technician ambulance certified by the department of health and~~
23 ~~welfare, advanced emergency medical technician and EMT paramedic certified~~
24 ~~by the state board of medicine, a member, employee or agent of the state~~
25 ~~tax commission, United States marshal, ~~or~~ federally commissioned law~~
26 ~~enforcement officer or their deputies or agents or an employee of the state~~
27 ~~of Idaho or any of its political subdivisions and the perpetrator knows~~
28 ~~or has reason to know of the victim's status, the punishment shall be as~~
29 follows:

30 (a) For committing battery with intent to commit a serious felony the
31 punishment shall be imprisonment in the state prison not to exceed
32 twenty-five (25) years.

33 (b) For committing any other crime in this chapter the punishment shall
34 be doubled that provided in the respective section, except as provided
35 in subsections (2) and (3) of this section.

36 (2) For committing a violation of the provisions of section 18-901
37 or 18-903, Idaho Code, against the person of a former or present justice,
38 judge or magistrate, jailer or correctional officer or other staff of the
39 department of correction, or a county jail, or of a private correctional
40 facility, or of an employee of a state secure confinement facility for
41 juveniles, an employee of a juvenile detention facility, a teacher at a

1 detention facility, misdemeanor probation officer or a juvenile probation
2 officer:

3 (a) Because of the exercise of official duties or because of the
4 victim's former or present official status; or

5 (b) While the victim is engaged in the performance of his duties and
6 the person committing the offense knows or reasonably should know that
7 such victim is a justice, judge or magistrate, jailer or correctional
8 officer or other staff of the department of correction, or of a private
9 correctional facility, an employee of a state secure confinement
10 facility for juveniles, an employee of a juvenile detention facility,
11 a teacher at a detention facility, misdemeanor probation officer or a
12 juvenile probation officer;

13 the offense shall be a felony punishable by imprisonment in a correctional
14 facility for a period of not more than five (5) years, and said sentence shall
15 be served consecutively to any sentence being currently served.

16 (3) For committing a violation of the provisions of section 18-903,
17 Idaho Code, except unlawful touching as described in section 18-903(b),
18 Idaho Code, against the person of a former or present peace officer, sheriff
19 or police officer:

20 (a) Because of the exercise of official duty or because of the victim's
21 former or present official status; or

22 (b) While the victim is engaged in the performance of his duties and the
23 person committing the offense knows or reasonably should know that such
24 victim is a peace officer, sheriff or police officer;

25 the offense shall be a felony punishable by imprisonment in a correctional
26 facility for a period of not more than five (5) years, and said sentence shall
27 be served consecutively to any sentence being currently served.
