

## STATEMENT OF PURPOSE

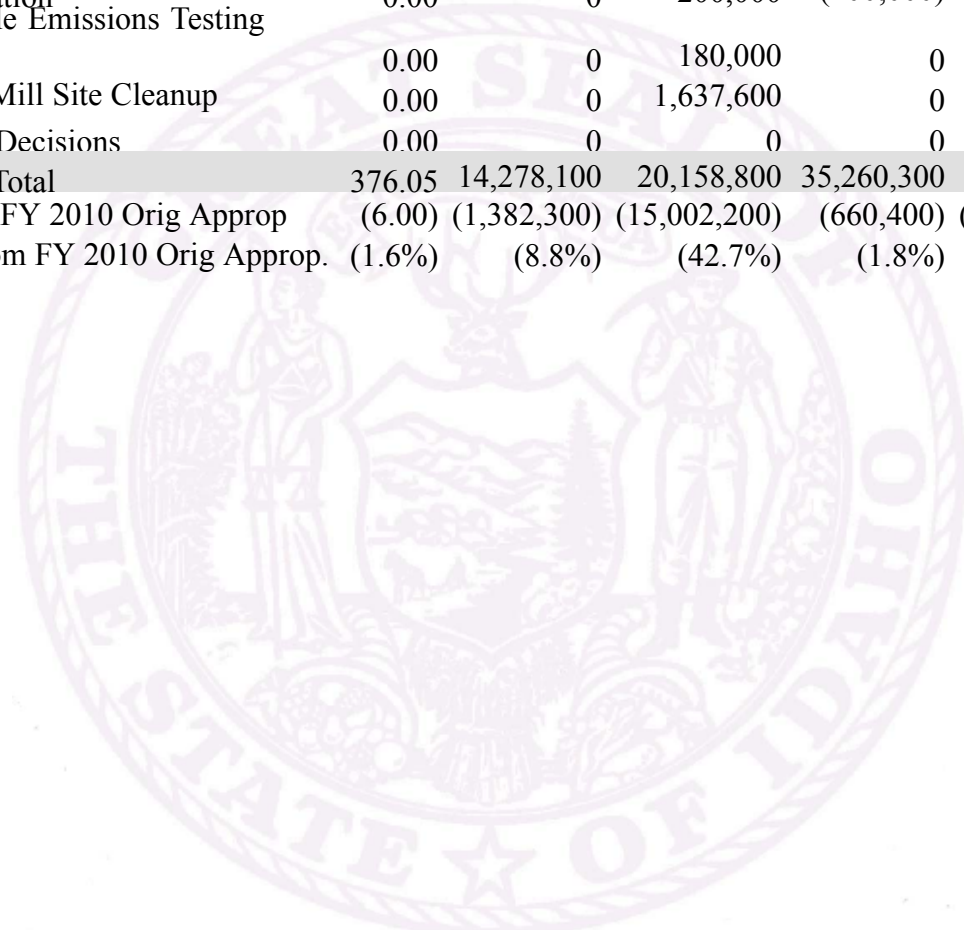
### RS19799

Reduces the fiscal year 2010 General Fund appropriation to the Department of Environmental Quality by \$1,396,600; appropriates \$69,697,200 to the Department of Environmental Quality for fiscal year 2011; limits the number of full-time equivalent positions to 376.05; transfers \$1.5 million from the Water Pollution Control Fund to the Environmental Remediation Fund; requires an annual report of the Superfund cleanup; and supersedes the statutory uses of the Water Pollution Control Fund.
