BY APPROPRIATIONS COMMITTEE

1 AN ACT
2 REDUCING THE APPROPRIATION TO THE SECRETARY OF STATE FOR FISCAL YEAR 2010;
3 APPROPRIATING MONEYS TO THE SECRETARY OF STATE FOR FISCAL YEAR 2011;
4 LIMITING THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; AND DECLARING AN
5 EMERGENCY.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. Notwithstanding any other provision of law to the contrary,
8 the appropriation made in Section 1, Chapter 313, Laws of 2009, to the Sec-
9 retary of State is hereby reduced by the following amount according to the
10 designated expense classes from the listed fund for the period July 1, 2009,
11 through June 30, 2010:

8 SECTION 4. An emergency existing therefor, which emergency is hereby
9 declared to exist, Section 1 of this act shall be in full force and effect on
10 and after passage and approval.
