HOUSE BILL NO. 711

BY APPROPRIATIONS COMMITTEE

AN ACT

1 APPROPRIATING MONEYS FROM THE PERMANENT BUILDING FUND TO THE DIVISION OF
2 PUBLIC WORKS FOR THE VARIOUS PURPOSES SPECIFIED; EXPRESSING LEGISLA-
3 TIVE INTENT CONCERNING THE USE OF MONEYS APPROPRIATED IN THIS ACT;
4 EXEMPTING THE APPROPRIATIONS FROM THE PROVISIONS OF CHAPTER 36, TITLE
5 67, IDAHO CODE, AND FROM THE PROVISIONS OF SECTION 67-3516, IDAHO CODE;
6 AND AUTHORIZING THE USE OF TAX ANTICIPATION NOTES.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated from the Permanent Building
10 Fund to the Division of Public Works the following amounts, or so much
11 thereof as in each case may be necessary, for the purpose of paying the
12 cost of any land, building, equipment, or the rebuilding, renovation or
13 repair of buildings, installations, facilities or structures at the places,
14 institutions and agencies, or their successors, including those listed
15 in this section. The Permanent Building Fund Advisory Council is hereby
16 authorized and directed to anticipate revenues accruing to the Permanent
17 Building Fund for the purpose of undertaking the construction, renovation,
18 repair and acquisitions herein authorized, without delay, and to determine
19 the priority of construction pursuant to which the work hereunder will be
20 undertaken.

4 SECTION 2. It is legislative intent that the moneys appropriated in
5 this act may be made available for matching any allocation of moneys now
6 in existence or hereafter made available by agencies of the United States
7 and/or private donations; and it is further the express intention of the
8 Legislature to authorize the Division of Public Works to expend, for the pur-
9 pose of paying the cost of any land, building, equipment or the rebuilding,
10 renovation or repair of buildings, moneys appropriated for public works to
11 various agencies as part of the respective agency operating budgets; pro-
12 vided the express approval by the Permanent Building Fund Advisory Council
13 is granted to make application for such moneys in each instance.

14 SECTION 3. All appropriations made herein shall be exempt from the pro-
15 visions of Chapter 36, Title 67, and Section 67-3516, Idaho Code, but shall
16 be available for expenditure only after request for spending authority in
17 accordance with the other provisions of Chapter 35, Title 67, Idaho Code, and
18 all appropriations made hereunder shall be subject to the provisions of Sec-
19 tion 67-5711, Idaho Code, except as otherwise provided herein.

20 SECTION 4. The State Treasurer is hereby authorized and directed to
21 anticipate the revenues in the Permanent Building Fund by the issuance of
22 tax anticipation notes in accordance with authority conferred in Sections
23 63-3201 through 63-3204, Idaho Code, and in accordance with the procedures
24 and subject to the limitations provided in those sections, in the same manner
25 as though the revenues in the General Fund were being anticipated.
