## HOUSE BILL NO. 711

### BY APPROPRIATIONS COMMITTEE

#### AN ACT

- APPROPRIATING MONEYS FROM THE PERMANENT BUILDING FUND TO THE DIVISION OF
  PUBLIC WORKS FOR THE VARIOUS PURPOSES SPECIFIED; EXPRESSING LEGISLA TIVE INTENT CONCERNING THE USE OF MONEYS APPROPRIATED IN THIS ACT;
  EXEMPTING THE APPROPRIATIONS FROM THE PROVISIONS OF CHAPTER 36, TITLE
  67, IDAHO CODE, AND FROM THE PROVISIONS OF SECTION 67-3516, IDAHO CODE;
  7 AND AUTHORIZING THE USE OF TAX ANTICIPATION NOTES.
- 8 Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated from the Permanent Building 9 Fund to the Division of Public Works the following amounts, or so much 10 thereof as in each case may be necessary, for the purpose of paying the 11 12 cost of any land, building, equipment, or the rebuilding, renovation or repair of buildings, installations, facilities or structures at the places, 13 institutions and agencies, or their successors, including those listed 14 in this section. The Permanent Building Fund Advisory Council is hereby 15 authorized and directed to anticipate revenues accruing to the Permanent 16 Building Fund for the purpose of undertaking the construction, renovation, 17 repair and acquisitions herein authorized, without delay, and to determine 18 the priority of construction pursuant to which the work hereunder will be 19 20 undertaken.

4 SECTION 2. It is legislative intent that the moneys appropriated in this act may be made available for matching any allocation of moneys now 5 in existence or hereafter made available by agencies of the United States 6 and/or private donations; and it is further the express intention of the 7 Legislature to authorize the Division of Public Works to expend, for the pur-8 pose of paying the cost of any land, building, equipment or the rebuilding, 9 renovation or repair of buildings, moneys appropriated for public works to 10 various agencies as part of the respective agency operating budgets; pro-11 vided the express approval by the Permanent Building Fund Advisory Council 12 is granted to make application for such moneys in each instance. 13

SECTION 3. All appropriations made herein shall be exempt from the provisions of Chapter 36, Title 67, and Section 67-3516, Idaho Code, but shall be available for expenditure only after request for spending authority in accordance with the other provisions of Chapter 35, Title 67, Idaho Code, and all appropriations made hereunder shall be subject to the provisions of Section 67-5711, Idaho Code, except as otherwise provided herein.

SECTION 4. The State Treasurer is hereby authorized and directed to anticipate the revenues in the Permanent Building Fund by the issuance of tax anticipation notes in accordance with authority conferred in Sections 63-3201 through 63-3204, Idaho Code, and in accordance with the procedures and subject to the limitations provided in those sections, in the same manner as though the revenues in the General Fund were being anticipated.
