

## STATEMENT OF PURPOSE

### RS19918

This is the fiscal year 2011 appropriation to the Department of Administration; includes a supplemental of \$200,000 to the Department of Administration for fiscal year 2010; reduces the General Fund appropriation to the Department of Administration by \$526,400 for fiscal year 2010; and appropriates \$60,081,000 to the Department of Administration for fiscal year 2011. This bill limits the number of full-time equivalent positions to 151.75; provides legislative intent on health insurance benefits; and provides legislative intent on the Idaho Education Network project.
