5	Be It Enacted by the Legislature of the State of Idaho:
6 7	SECTION 1. That Section $67-435$, Idaho Code, be, and the same is hereby amended to read as follows:
8	67-435. POWERS AND DUTIES. (1) The joint finance-appropriations com-
9	mittee shall have the following powers and duties:
10	(a) To review the executive budget and the budget requests of each state
11	department, agency and institution, including requests for construc-
12	tion of capital improvements, as well as other requests for appropria-
13	tions submitted to the legislature.
14	(b) To conduct such hearings as it may deem necessary and proper.
15	(c) To submit a report to each session of the legislature covering its
16 17	activities during the preceding period and setting forth its findings and recommendations and to make such recommendations to the appropriate
17 18	legislative committees as it may deem proper concerning the budget and
19	other proposed legislation.
20	(d) To perform such other duties as the legislature or legislative
21	council may by appropriate resolution direct.
22	(2) The joint finance-appropriations committee shall use the following
23	procedures for releasing reports produced by the legislative audits divi-
24	sion:
25	(a) All reports produced by the legislative audits division shall be
26	delivered to the cochairs of the joint finance-appropriations commit-
27	tee for their review and approval prior to release;
28	(b) The cochairs of the joint finance-appropriations committee may, at
29	their discretion, conduct hearings relating to any report and seek in-
30	put and testimony prior to, or after reports are released; and
31	(c) After such review as deemed necessary and prudent by the cochairs of
32 33	the joint finance-appropriations committee, the cochairs shall release the reports produced by the legislative audits division within sixty
33 34	(60) days of submission to the cochairs; except in the event that a

(3) The joint finance-appropriations committee shall provide the public and legislators opportunity to comment on any proposed budget prior to the committee setting an agency budget. The committee shall also have prepared detailed minutes of all its proceedings that shall be available to the public on a meeting by meeting basis. The committee shall also consult
