RELATING TO IMMUNIZATION; AMENDING SECTION 39-4803, IDAHO CODE, TO REMOVE 2 LANGUAGE REGARDING A VOLUNTARY IMMUNIZATION REGISTRY, TO REMOVE A 3 4 CERTAIN AUTHORIZATION REQUIREMENT FOR INCLUSION IN THE REGISTRY, TO PROVIDE FOR EXCLUSION FROM THE REGISTRY UPON A CERTAIN STATEMENT THAT 5 MAY NOT BE PART OF A GENERAL AUTHORIZATION OR RELEASE, TO CLARIFY THE 6 PURPOSES FOR WHICH THE REGISTRY SHALL BE MAINTAINED AND FOR WHICH 7 THE REGISTRY INFORMATION SHALL BE DISCLOSED, TO CLARIFY THAT CERTAIN 8 INFORMATION SHALL BE INCLUDED IN THE REGISTRY AND TO CLARIFY THAT 9 DISCLOSURE OF REGISTRY INFORMATION SHALL BE LIMITED TO CERTAIN PERSONS. 10

11 Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 39-4803, Idaho Code, be, and the same is hereby amended to read as follows:

14 39-4803. IMMUNIZATION REGISTRY. (1) The department of health and 15 welfare shall provide for the establishment of a voluntary registry of the 16 immunization status of Idaho children against childhood diseases. The 17 registry may shall be maintained and its data disclosed as set out herein to 18 further the following purposes:

(a) To make immunizations readily available to every Idaho citizen thatdesires to have their child immunized;

(b) To increase the voluntary immunization rate in Idaho to the maximum
 extent possible without mandating such immunizations;

(c) To recognize and respect the rights of parents and guardians to make
 health care decisions for their children; and

(d) To provide for timely reminders to parents of children in theregistry.

- (a) The child's name, address and birth date;
- (b) The name and address of each parent of the child;

37 (c) The month, day, year and type of each immunization that has been38 administered to the child;

- 39 (d) The name, address and phone number of each provider that has40 administered an immunization to the child;
- (e) If requested by a parent or guardian, any statement made pursuant to
 subsection (4) of this section; <u>and</u>

Other information as authorized or requested by a parent or 1 (f) quardian. 2 The department of health and welfare may shall only disclose 3 (3)information relating to an individual child in the registry to the following 4 upon a specific request: 5 (a) Employees of the health district in which the child resides or seeks 6 medical services; 7 (b) Health records staff of the school or school district in which the 8 9 child is enrolled; 10 (c) The operator of a licensed child daycare facility in which the child is enrolled; 11 (d) Persons who are legally responsible for the long-term care of the 12 child, including operators of licensed ICF/MR's and residential or 13 14 assisted living facilities, adoptive and foster parents and a guardian appointed pursuant to chapter 5, title 15, Idaho Code; 15 (e) Any health care provider rendering treatment to the child, and the 16 17 provider's agents; (f) Any person possessing a lawful release, properly executed by the 18 19 child's parent or guardian; (g) A parent of the child; or 20 (h) Any hospital where the child is receiving care. 21 (4) A parent or guardian of the child shall have free and open access to 22 all information in the registry that relates to their child or themselves. 23 Upon the written request of a parent or guardian, the department of health 24 and welfare shall: 25 26 (a) Cause all information relating to the child to be removed from the registry and any databases or files of other entities or persons to 27 28 which information in the database has been disclosed; Include in the registry the statement of a physician or parent 29 (b) pursuant to section 39-4802(2) or 39-1118(2), Idaho Code. 30 (5) All information contained in the registry or disclosed from it is 31 32 confidential and may not be sold and may only be disclosed as specifically 33 authorized in this section. A person or entity to whom information is disclosed from the registry may not thereafter disclose it to others. Any 34 35 person who discloses or authorizes disclosure of any information contained in the registry, except as authorized in this section is guilty of a 36 37 misdemeanor and is liable for civil damages in the amount of one hundred

38 dollars (\$100) for each violation.
