SENATE BILL NO. 1419

AN ACT

REDUCING THE APPROPRIATION TO THE STATE BOARD OF EDUCATION FOR GENERAL EDUCATION PROGRAMS AT BOISE STATE UNIVERSITY, IDAHO STATE UNIVERSITY, LEWIS-CLARK STATE COLLEGE, THE UNIVERSITY OF IDAHO AND FOR THE OFFICE OF THE STATE BOARD OF EDUCATION FOR FISCAL YEAR 2010; APPROPRIATING MONEYS FOR GENERAL EDUCATION PROGRAMS AT BOISE STATE UNIVERSITY, IDAHO STATE UNIVERSITY, LEWIS-CLARK STATE COLLEGE, THE UNIVERSITY OF IDAHO AND FOR THE OFFICE OF THE STATE BOARD OF EDUCATION FOR FISCAL YEAR 2011; REAPPROPRIATING CERTAIN UNEXPENDED AND UNENCUMBERED BALANCES; ESTABLISHING AMOUNTS TO BE EXPENDED FOR SYSTEMWIDE PROGRAMS; PROVIDING LEGISLATIVE INTENT FOR AMERICAN RECOVERY AND REINVESTMENT ACT MONEYS; AND DECLARING AN EMERGENCY.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. Notwithstanding any other provision of law to the contrary, the appropriation made to the State Board of Education and the Board of Regents of the University of Idaho for Boise State University, Idaho State University, the University of Idaho, Lewis-Clark State College, and the Office of the State Board of Education in Section 1, Chapter 207, Laws of 2009, is hereby reduced by the following amount for the period July 1, 2009, through June 30, 2010:

SECTION 2. There is hereby appropriated to the State Board of Education and the Board of Regents of the University of Idaho for Boise State University, Idaho State University, Lewis-Clark State College, the University of Idaho, and the Office of the State Board of Education the following amount to be expended for the designated programs from the listed funds for the period July 1, 2010, through June 30, 2011:

3 SECTION 3. There is hereby reappropriated to the State Board of Educa-  
 4 tion and the Board of Regents of the University of Idaho for Boise State Uni-  
 5 versity, Idaho State University, the University of Idaho, Lewis-Clark State  
 6 College, and the Office of the State Board of Education, any non-General Fund  
 7 unexpended and unencumbered balances of any appropriation contained in Sec-  
 8 tion 1, Chapter 207, Laws of 2009, to be used for nonrecurring expenditures  
 9 for the period July 1, 2010, through June 30, 2011.

10 SECTION 4. It is the intent of the Legislature that of the amount appro-  
 11 priated from the General Fund in Section 2 of this act:

12 (1) An amount not to exceed \$140,000 may be used by the Office of the  
 13 State Board of Education for systemwide needs;

14 (2) An amount not to exceed \$1,435,500 may be used for the mission and  
 15 goals of the Higher Education Research Council; and

16 (3) An amount not to exceed \$1,151,100 may be used by the State Board of  
 17 Education for instructional projects specifically designed to foster inno-  
 18 vative learning approaches using technology and to promote the Idaho Elec-  
 19 tronic Campus.

20 SECTION 5. As appropriated in Section 2 of this act, it is the intent of  
 21 the Legislature that the remaining \$4,305,900 of the college and university  
 22 allocation of one-time American Reinvestment and Recovery Act state fiscal  
 23 stabilization funds are to be allocated to the institutions of higher edu-  
 24 cation and systemwide programs in amounts determined by the State Board of  
 25 Education. Pursuant to Section 14004 of the American Recovery and Reinvest-  
 26 ment Act, uses of these funds may be for education and general expenditures,  
 27 but shall not be used for maintenance of systems, equipment or facilities.  
 28 After initial allocations to the institutions and systemwide programs, any  
 29 moneys allocated by the State Board of Education to the Center for Advanced  
 30 Energy Studies shall be divided equally among the University of Idaho, Idaho  
 31 State University and Boise State University, only.

32 SECTION 6. An emergency existing therefor, which emergency is hereby  
 33 declared to exist, Section 1 of this act shall be in full force and effect on  
 34 and after passage and approval.
