  5 ARTS FOR FISCAL YEAR 2011; LIMITING THE NUMBER OF FULL-TIME EQUIVALENT
  6 POSITIONS; AND DECLARING AN EMERGENCY.
- 7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. Notwithstanding any other provision of law to the contrary, 9 the appropriation made in Section 1, Chapter 304, Laws of 2009, to the Com-10 mission on the Arts is hereby reduced by the following amounts according to 11 the designated expense classes from the listed fund for the period July 1, 12 2009, through June 30, 2010:
