The Legislative Services Office, Research and Legislation, has received the enclosed rules of the State Athletic Commission:

IDAPA 03.01.01 - Rules of the State Athletic Commission (Fee Rule) (Docket No. 03-0101-1101).

Pursuant to Section 67-454, Idaho Code, a meeting on the enclosed rules may be called by the cochairmen or by two (2) or more members of the subcommittee giving oral or written notice to Research and Legislation no later than fourteen (14) days after receipt of the rules analysis from Legislative Services. The final date to call a meeting on the enclosed rules is no later than 10/28/2011. If a meeting is called, the subcommittee must hold the meeting within forty-two (42) days of receipt of the rules analysis from Legislative Services. The final date to hold a meeting on the enclosed rules is 11/28/2011.

The germane joint subcommittee may request a statement of economic impact with respect to a proposed rule by notifying Research and Legislation. There is no time limit on requesting this statement, and it may be requested whether or not a meeting on the proposed rule is called or after a meeting has been held.

IDAPA 03.01.01 - Rules of the State Athletic Commission (Fee Rule) (Docket No. 03-0101-1101)

The State Athletic Commission submits notice of proposed rulemaking at IDAPA 03.01.01 - Rules of the State Athletic Commission. The proposed rule increases application and annual license and permit renewal fees.

The Commission states that it continues to have a negative fund balance. The Commission expects that the fee increases will provide an estimated \$43,880.00 in additional revenue based on the number of licenses held at the end of FY2011. Negotiated rulemaking was not conducted.

The proposed fee rule is within the authority granted to the State Athletic Commission in Section 54-416, Idaho Code.

NOTICE OF RULEMAKING - PROPOSED RULE

AUTHORITY: In compliance with Section 67-5221(1), Idaho Code, notice is hereby given that this agency has initiated proposed rulemaking procedures. The action is authorized pursuant to Section 54-416, Idaho Code.

PUBLIC HEARING SCHEDULE: Public hearing(s) concerning this rulemaking will be scheduled if requested in writing by twenty-five (25) persons, a political subdivision, or an agency, not later than October 19, 2011.

The hearing site(s) will be accessible to persons with disabilities. Requests for accommodation must be made not later than five (5) days prior to the hearing, to the agency address below.

DESCRIPTIVE SUMMARY: The following is a nontechnical explanation of the substance and purpose of the proposed rulemaking:

The State Athletic Commission's fund balance was (\$140,883) at the end of FY2011. This change will help provide additional revenue.

FEE SUMMARY: The following is a specific description of the fee or charge imposed or increased:

The application fee for a promoter is being increased from five hundred (\$500) to one thousand (\$1000) dollars. The application fee for a sanction permit is being increased from twenty-five (\$25) to two hundred (\$200) dollars. The application fees for combatants and non-combatants is being increased from thirty dollars (\$30) to one hundred fifty dollars (\$150). The application fee for a matchmaker is being increased from one hundred dollars (\$100) to two hundred fifty dollars (\$250). The application fee for a ring official is being increased from thirty dollars (\$30) to one hundred fifty dollars (\$150). Finally, the renewal fees are being increased as follows: a promoter renewal is being increased from one hundred (\$100) to seven hundred fifty (\$750) dollars; a combatant and noncombatant renewal is being increased from thirty dollars (\$30) to one hundred fifty dollars (\$150); a matchmaker renewal is being increased from one hundred (\$100) to two hundred fifty dollars (\$250); and the ring official renewal is being increased from thirty dollars (\$30) to one hundred fifty dollars (\$150). The anticipated impact is a total positive impact of \$43,880 to the dedicated fund based on the number of licensees and the number of sanction permits issued in the last fiscal year.

FISCAL IMPACT: The following is a specific description, if applicable, of any negative fiscal impact on the state general fund greater than ten thousand dollars (\$10,000) during the fiscal year resulting from this rulemaking:

The State Athletic Commission continues to have a negative balance. This change will help provide additional revenue estimated at \$43,880 based on the number of licensees at the end of FY2011. The Board's fund balance at the end of fiscal year 2011 was (\$140,883). The Commission's expenses have exceeded its revenues by \$49,116 in FY 2011, \$35,482 in FY 2010, and \$62,678 in FY 2009.

NEGOTIATED RULEMAKING: Pursuant to Section 67-5220(2), Idaho Code, negotiated rulemaking was not conducted.
