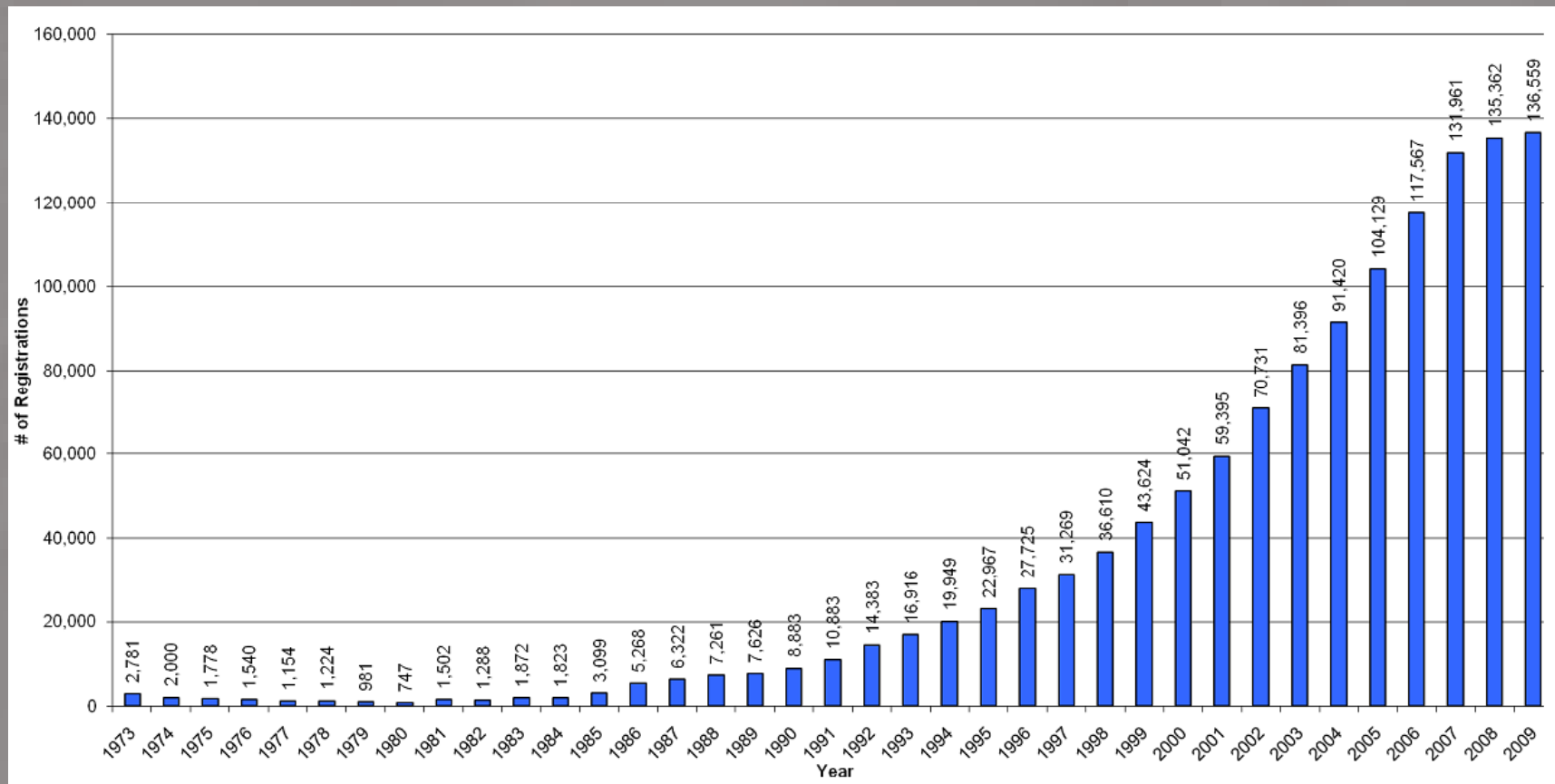

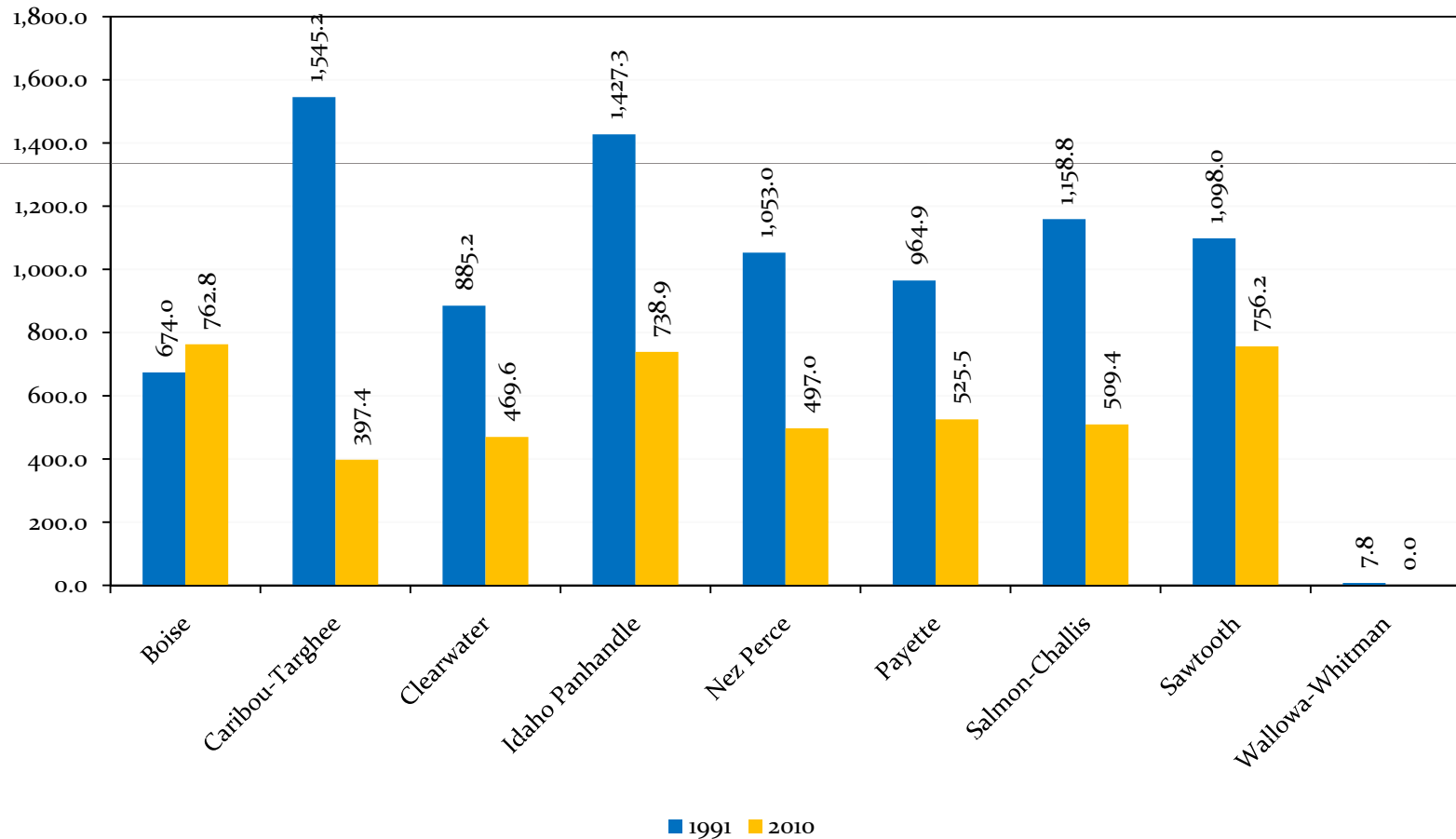
Increase Demand In Registered OHVs

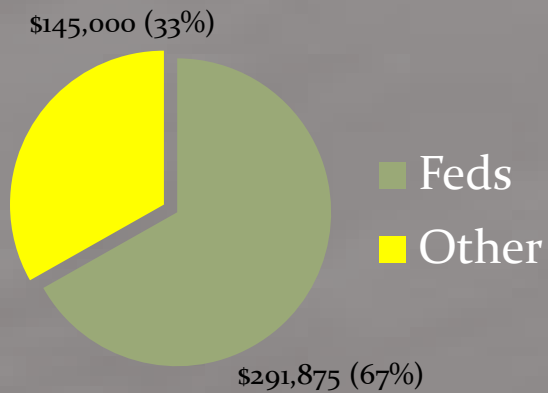
IDPRs Role In Enforcement

- Help with Enforcement through grant and direct funding

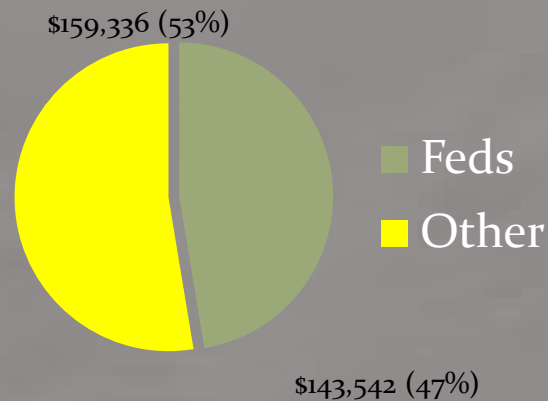


Trails Projects Approved FY 2011

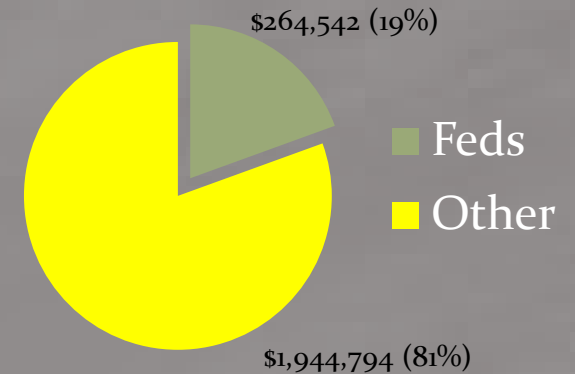

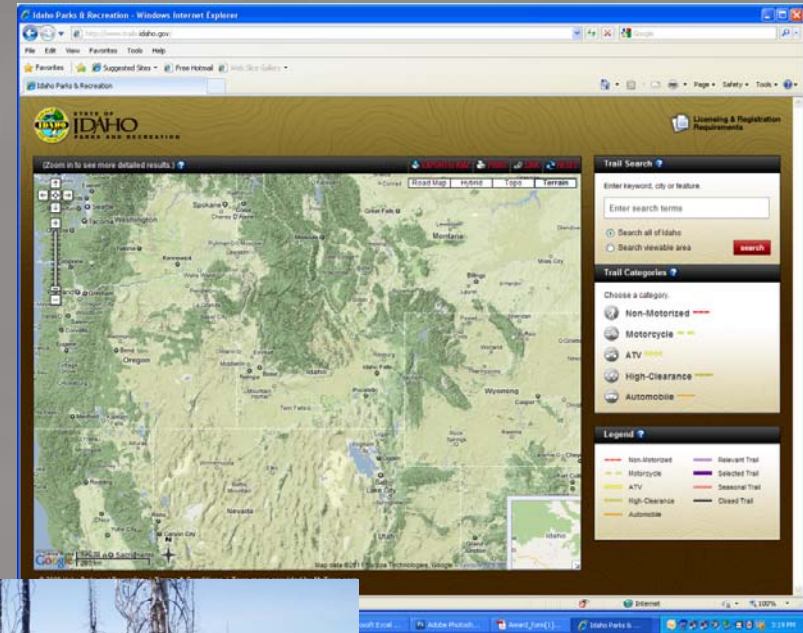
