AN ACT

1 APPROPRIATING MONEYS TO THE LEGISLATIVE COUNCIL FOR FISCAL YEAR 2012; EX-
2 EMPTING APPROPRIATION OBJECT AND PROGRAM TRANSFER LIMITATIONS; REAP-
3 PROPRIATING CERTAIN UNEXPENDED AND UNENCUMBERED BALANCES; AND PROVID-
4 ING THAT THE PRESIDENT PRO TEMPORE OF THE SENATE AND THE SPEAKER OF THE
5 HOUSE OF REPRESENTATIVES SHALL DIRECT THE STATE CONTROLLER TO LIMIT THE
6 FUNDS TRANSFER TO THE LEGISLATIVE FUND FOR FISCAL YEAR 2012.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the Legislative Council, the
10 following amounts to be expended according to the designated programs and
11 expense classes, from the listed funds for the period July 1, 2011, through
12 June 30, 2012:

5 SECTION 2. EXEMPTIONS FROM OBJECT AND PROGRAM TRANSFER LIMITATIONS.
6 For fiscal year 2012, the Legislative Council is hereby exempted from the
7 provisions of Section 67-3511(1), (2) and (3), Idaho Code, allowing unlim-
8 ited transfers between object codes and between programs, for all moneys
9 appropriated to it for the period July 1, 2011, through June 30, 2012. Leg-
10 islative appropriations shall not be transferred from one fund to another
11 fund unless expressly approved by the Legislature.

12 SECTION 3. NON-GENERAL FUND REAPPROPRIATION AUTHORITY. There is hereby
13 reappropriated to the Legislative Council any unexpended and unencumbered
14 balances of moneys categorized as dedicated funds and federal funds as ap-
15 propriated or reappropriated for fiscal year 2011, to be used for nonrecur-
16 ring expenditures, for the period July 1, 2011, through June 30, 2012.

17 SECTION 4. LEGISLATIVE TRANSFER FOR FISCAL YEAR 2012. On July 1, 2011,
18 the President Pro Tempore of the Senate and the Speaker of the House of Repre-
19 sentatives shall direct the State Controller to limit the amount transferred
20 from the General Fund to the Legislative Fund pursuant to Section 67-451(2),
21 Idaho Code, to \$5,846,000 for the period July 1, 2011, through June 30, 2012.
