HOUSE BILL NO. 319

AN ACT

1 RELATING TO THE PUBLIC EMPLOYEE RETIREMENT SYSTEM; AMENDING SECTION  
2 59-1342, IDAHO CODE, TO REVISE PROVISIONS RELATING TO COMPUTATION  
3 OF CERTAIN SERVICE RETIREMENT ALLOWANCES AS THEY RELATE TO THE IDAHO  
4 LEGISLATURE; AND AMENDING SECTION 59-1346, IDAHO CODE, TO REVISE PROVI-  
5 SIONS RELATING TO COMPUTATION OF CERTAIN EARLY RETIREMENT ALLOWANCES AS  
6 THEY RELATE TO THE IDAHO LEGISLATURE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. That Section 59-1342, Idaho Code, be, and the same is hereby  
10 amended to read as follows:

11 59-1342. COMPUTATION OF SERVICE RETIREMENT ALLOWANCES -- MINIMUM BEN-  
12 EFITS. (1) The annual amount of accrued retirement allowance for each month  
13 of credited service for which a member was not classified as a police member  
14 or firefighter shall equal one and two-thirds percent (1 2/3%) of the mem-  
15 ber's average monthly salary. Effective October 1, 1992, the annual amount  
16 of accrued retirement allowance for all service for which a member was not  
17 classified as a police member or firefighter shall equal one and seventy-  
18 five hundredths percent (1.75%) of the member's average monthly salary; ef-  
19 fective October 1, 1993, the annual amount of accrued retirement allowance  
20 shall equal one and eight hundred thirty-three thousandths percent (1.833%)  
21 of the member's average monthly salary; effective October 1, 1994, the an-  
22 nual amount of accrued retirement allowance shall equal one and nine hun-  
23 dred seventeen thousandths percent (1.917%); and effective June 30, 2000,  
24 the annual amount of accrued retirement allowance shall equal two percent  
25 (2%) of the member's average monthly salary. Entitlement to an annual amount  
26 of accrued retirement allowance shall not vest until the effective date of  
27 that annual amount of accrued retirement allowance. The retirement bene-  
28 fits shall be calculated on the amounts, terms and conditions in effect on  
29 the date of the final contribution by the member. The annual amount of ini-  
30 tial service retirement allowance of such a member shall equal (a) or (b),  
31 whichever is greater:

32 (a) The member's accrued retirement allowance; or

33 (b) Five dollars (\$5.00) multiplied by the number of months of cred-  
34 ited service and by the bridging factor, as provided in section 59-1355,  
35 Idaho Code, between July 1, 1974 and the first of the month following the  
36 member's final contribution.

37 (2) The annual amount of accrued retirement allowance for each month  
38 of credited service for which a member was classified as a police member or  
39 firefighter shall equal two percent (2%) of the member's average monthly  
40 salary. Effective October 1, 1992, the annual amount of accrued retire-  
41 ment allowance for all service for which a member was classified as a police  
42 member or firefighter shall equal two and seventy-five thousandths percent

1 (2.075%) of the member's average monthly salary; effective October 1, 1993,  
2 the annual amount of accrued retirement allowance shall equal two and fif-  
3 teen hundredths percent (2.15%) of the member's average monthly salary;  
4 effective October 1, 1994, the annual amount of accrued retirement allowance  
5 shall equal two and two hundred twenty-five thousandths percent (2.225%);  
6 and effective June 30, 2000, the annual amount of accrued retirement al-  
7 lowance shall equal two and three-tenths percent (2.3%) of the member's  
8 average monthly salary. Entitlement to an annual amount of accrued retire-  
9 ment allowance shall not vest until the effective date of that annual amount  
10 of accrued retirement allowance. The retirement benefits shall be calcu-  
11 lated on the amounts, terms and conditions in effect on the date of the final  
12 contribution by the member. The annual amount of initial service retirement  
13 allowance of such a member shall equal (a) or (b), whichever is greater:

14 (a) The member's accrued retirement allowance; or

15 (b) Six dollars (\$6.00) multiplied by the number of months of credited  
16 service and by the bridging factor, as provided in section 59-1355,  
17 Idaho Code, between July 1, 1974 and the first of the month following the  
18 member's final contribution.

19 (3) Provisions of this section shall be applicable to members and con-  
20 tingent annuitants of the retirement system and to members, annuitants and  
21 beneficiaries of the teachers and city systems. In any recomputation of an  
22 initial retirement allowance for a person not making a final contribution  
23 subsequent to 1974, the bridging factor referred to in subsections (1) and  
24 (2) shall be 1.000. Any recomputed retirement allowance shall be payable  
25 only prospectively from July 1, 1974.

26 (4) Benefits payable to a person who became a member prior to July 1,  
27 1974, or to the member's beneficiaries shall never be less than they would  
28 have received under this chapter as in effect on June 30, 1974; provided,  
29 however, that the member shall have accrued the amount of accumulated con-  
30 tributions required thereby prior to payment of an initial retirement al-  
31 lowance.

32 (5) If the majority of a member's credited service is as an elected of-  
33 ficial or as an appointed official, except as a member of the Idaho legisla-  
34 ture who left the Idaho legislature before July 1, 2011, and subsequently was  
35 an employee, as defined in section 59-1302(14)(A), Idaho Code, other than  
36 by virtue of being a member of the Idaho legislature, and that official was  
37 normally in the administrative offices of the employer less than twenty (20)  
38 hours per week during the term of office, or was normally not required to be  
39 present at any particular work station for the employer twenty (20) hours per  
40 week or more during the term of office, that member's initial service retire-  
41 ment allowance shall be the sum of:

42 (a) That amount computed under subsection (1) and/or (2) of this sec-  
43 tion for only those months of service as an elected or an appointed offi-  
44 cial that are in excess of the months of other credited service, without  
45 consideration of any other credited service; and

46 (b) That accrued service retirement allowance that is computed from an  
47 average monthly salary for salary received during the member's total  
48 months of credited service excluding those excess months referenced in  
49 subsection (5) (a) of this section.

1 The initial service retirement allowance of members of the Idaho legisla-  
2 ture who left the Idaho legislature before July 1, 2011, and subsequently  
3 were employees, as defined in section 59-1302 (14) (A), Idaho Code, other than  
4 by virtue of being a member of the Idaho legislature, will be computed under  
5 subsection (1) and/or (2) of this section, on the basis of their total months  
6 of credited service. The initial service retirement allowance of all other  
7 members of the Idaho legislature will be computed in the same manner as the  
8 computation for nonlegislative elected or appointed officials including the  
9 provisions of this subsection if applicable.

10 (6) In no case, however, will a member's initial service retirement  
11 benefit be equal to more than the member's accrued benefit as of May 1, 1990,  
12 or one hundred percent (100%) of the member's average compensation for the  
13 three (3) consecutive years of employment which produce the greatest aggre-  
14 gate compensation, whichever is greater. If the benefit is calculated to  
15 exceed one hundred percent (100%) of the member's average compensation, the  
16 member shall be eligible for and may choose either:

17 (a) An annual service retirement allowance equal to the member's aver-  
18 age annual compensation for the three (3) consecutive years of employ-  
19 ment which produced the greatest aggregate compensation; or

20 (b) A separation benefit.

21 (7) The annual amount of initial service retirement allowance of a mem-  
22 ber who is over age seventy (70) on the effective date of the member's re-  
23 tirement shall be a percentage of the member's initial service retirement  
24 allowance. Such percentage shall be one hundred percent (100%) increased as  
25 determined by the board to compensate for each month that the member's re-  
26 tirement is deferred beyond age seventy (70).

27 (8) A member's accrued retirement allowance, as otherwise provided in  
28 subsections (1), (2), (3), (4) and (5) of this section, shall not be less than  
29 the minimum accrued retirement allowance provided in this subsection. The  
30 determination of the initial service retirement allowance provided in sub-  
31 sections (1) and (2) of this section, and the application of the provisions  
32 in subsections (6) and (7) of this section, will be made after the determi-  
33 nation of the minimum accrued retirement allowance provided in this subsec-  
34 tion.

35 This subsection shall apply to members who have at least two (2) sep-  
36 arate periods of employment covered under this chapter where each separate  
37 period of employment would otherwise be eligible for a separation benefit  
38 described in section 59-1359, Idaho Code. For purposes of this subsection,  
39 if a separation of employment occurs that does not exceed sixty (60) consec-  
40 utive calendar months then the member's period of employment shall be con-  
41 sidered a continuous period of employment. For purposes of this subsection,  
42 date of last contribution is the date of final contribution for each period  
43 or periods of employment.

44 For each separate period of employment considered under this subsec-  
45 tion, the member must not have received a separation benefit for that period,  
46 or if he has received such a separation benefit under section 59-1359, Idaho  
47 Code, he must have completed reinstatement of all previous credited service  
48 associated with all separation benefits for all periods of employment as  
49 permitted under section 59-1360, Idaho Code.

1 The minimum accrued retirement allowance shall be equal to the largest  
 2 accrued retirement allowance calculated at each date of last contribution  
 3 based upon the benefit and eligibility provisions in effect as of the date of  
 4 the last contribution made during such separate period of employment. For  
 5 purposes of determining the accrued retirement allowance for each date of  
 6 last contribution:

7 (a) The member must have at least sixty (60) months of credited service  
 8 at the date of last contribution;

9 (b) The member's months of credited service and average monthly salary  
 10 are determined based solely on all periods of employment up to that date  
 11 of last contribution, ignoring later periods of employment; and

12 (c) The accrued retirement allowance computed for each period is mul-  
 13 tiplied by the bridging factor as provided in section 59-1355(3), Idaho  
 14 Code, between the date of the last contribution made during that sepa-  
 15 rate period of employment and the date of the member's final contribu-  
 16 tion made during the last period of employment prior to retirement.

17 SECTION 2. That Section 59-1346, Idaho Code, be, and the same is hereby  
 18 amended to read as follows:

19 59-1346. COMPUTATION OF EARLY RETIREMENT ALLOWANCES. (1) The annual  
 20 amount of initial early retirement allowance of a member shall be a percent-  
 21 age of the member's accrued retirement allowance. Such percentage shall be  
 22 one hundred percent (100%) if the sum of the number of years and months of  
 23 credited service and the age in years and months is equal to or greater than  
 24 the sum indicated below. Otherwise, such percentage shall be one hundred  
 25 percent (100%) reduced by one-fourth of one percent (.25%) for each month  
 26 up to sixty (60) months that the member's retirement precedes the date the  
 27 member would be eligible to receive full accrued benefit without additional  
 28 credited service, and further reduced by two-thirds of one percent (.6667%)  
 29 for each additional month. Effective October 1, 1992, the further reduc-  
 30 tion for each additional month shall equal six thousand and forty-two ten-  
 31 thousandths of one percent (.6042%) of the member's average monthly salary;  
 32 effective October 1, 1993, the further reduction for each additional month  
 33 shall equal five thousand four hundred and seventeen ten-thousandths of one  
 34 percent (.5417%) of the member's average monthly salary; and effective Oc-  
 35 tober 1, 1994, the further reduction for each additional month shall equal  
 36 four thousand seven hundred and ninety-two ten-thousandths of one percent  
 37 (.4792%) of the member's average monthly salary. Entitlement to an annual  
 38 amount of accrued retirement allowance shall not vest until the effective  
 39 date of that annual amount of accrued retirement allowance. The retirement  
 40 benefits shall be calculated on the amounts, terms and conditions in effect  
 41 at the date of the final contribution by the member.

13 (2) If the majority of a member's credited service is as an elected of-  
14 ficial or as an appointed official, except as a member of the Idaho legisla-  
15 ture who left the Idaho legislature before July 1, 2011, and subsequently was  
16 an employee, as defined in section 59-1302(14) (A), Idaho Code, other than  
17 by virtue of being a member of the Idaho legislature, and that official was  
18 normally in the administrative offices of the employer less than twenty (20)  
19 hours per week during the term of office, or was normally not required to be  
20 present at any particular work station for the employer twenty (20) hours per  
21 week or more during the term of office, that member's accrued retirement al-  
22 lowance shall be the sum of:

23 (a) That amount computed from an average monthly salary for salary re-  
24 ceived only for those months of service as an elected or as an appointed  
25 official that are in excess of the months of other credited service  
26 without consideration of any other credited service; and

27 (b) That accrued retirement allowance that is computed from an aver-  
28 age monthly salary for salary received during the member's total months  
29 of credited service excluding those excess months referenced in subsec-  
30 tion (2) (a) of this section.

31 The initial service retirement allowance of members of the Idaho legislature  
32 who left the Idaho legislature before July 1, 2011, and subsequently were  
33 employees, as defined in section 59-1302(14) (A), Idaho Code, other than by  
34 virtue of being a member of the Idaho legislature, will be computed under the  
35 provisions of this section, on the basis of their total months of credited  
36 service. The initial service retirement allowance of all other members of  
37 the Idaho legislature will be computed in the same manner as the computation  
38 for nonlegislative elected or appointed officials including the provisions  
39 of this subsection if applicable.
