AN ACT

1 APPROPRIATING ADDITIONAL MONEYS FROM THE IDAHO MILLENNIUM FUND AND DI-
2 RECTING A TRANSFER TO THE CATASTROPHIC HEALTH CARE FUND FOR FISCAL
3 YEAR 2011; PROVIDING LEGISLATIVE INTENT TO REVERT MONEYS TO THE IDAHO
4 MILLENNIUM FUND FOR FISCAL YEAR 2011; APPROPRIATING MONEYS TO THE CATA-
5 STROPHIC HEALTH CARE FUND FROM THE GENERAL FUND AND DIRECTING A TRANSFER
6 FOR FISCAL YEAR 2012; PROVIDING LEGISLATIVE INTENT TO REVERT MONEYS TO
7 THE GENERAL FUND FOR FISCAL YEAR 2012; APPROPRIATING MONEYS TO THE CAT-
8 ASTROPHIC HEALTH CARE FUND FROM THE IDAHO MILLENNIUM FUND AND DIRECTING
9 A TRANSFER; PROVIDING LEGISLATIVE INTENT TO REVERT MONEYS TO THE IDAHO
10 MILLENNIUM FUND FOR FISCAL YEAR 2012; AND DECLARING AN EMERGENCY.

12 Be It Enacted by the Legislature of the State of Idaho:

13 SECTION 1. In addition to the appropriation made in Section 2, Chapter
14 324, Laws of 2010, and any other appropriation provided for in law, there is
15 hereby appropriated to the Catastrophic Health Care Program \$4,325,000 from
16 the Idaho Millennium Fund to be transferred to the Catastrophic Health Care
17 Fund, for the period July 1, 2010, through June 30, 2011.

18 SECTION 2. LEGISLATIVE INTENT. Notwithstanding any other provision of
19 law to the contrary, on June 30, 2011, any remaining unexpended and unencum-
20 bered moneys appropriated in Section 1 of this act shall revert to the Idaho
21 Millennium Fund. The State Controller shall transfer said reverted moneys
22 from the Catastrophic Health Care Fund to the Idaho Millennium Fund.

23 SECTION 3. There is hereby appropriated to the Catastrophic Health
24 Care Program \$19,267,700 from the General Fund to be transferred to the Cat-
25 astrophic Health Care Fund, for the period July 1, 2011, through June 30,
26 2012.

27 SECTION 4. LEGISLATIVE INTENT. Notwithstanding any other provision of
28 law to the contrary, on June 30, 2012, any remaining unexpended and unencum-
29 bered moneys appropriated in Section 3 of this act shall revert to the Gen-
30 eral Fund. The State Controller shall transfer said reverted moneys from the
31 Catastrophic Health Care Fund to the General Fund.

32 SECTION 5. There is hereby appropriated to the Catastrophic Health Care
33 Program \$3,000,000 from the Idaho Millennium Fund to be transferred to the
34 Catastrophic Health Care Fund, for the period July 1, 2011, through June 30,
35 2012.

36 SECTION 6. LEGISLATIVE INTENT. Notwithstanding any other provision of
37 law to the contrary, on June 30, 2012, any remaining unexpended and unencum-
38 bered moneys appropriated in Section 5 of this act shall revert to the Idaho

1 Millennium Fund. The State Controller shall transfer said reverted moneys
2 from the Catastrophic Health Care Fund to the Idaho Millennium Fund.

3 SECTION 7. An emergency existing therefor, which emergency is hereby
4 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-
5 fect on and after passage and approval.
